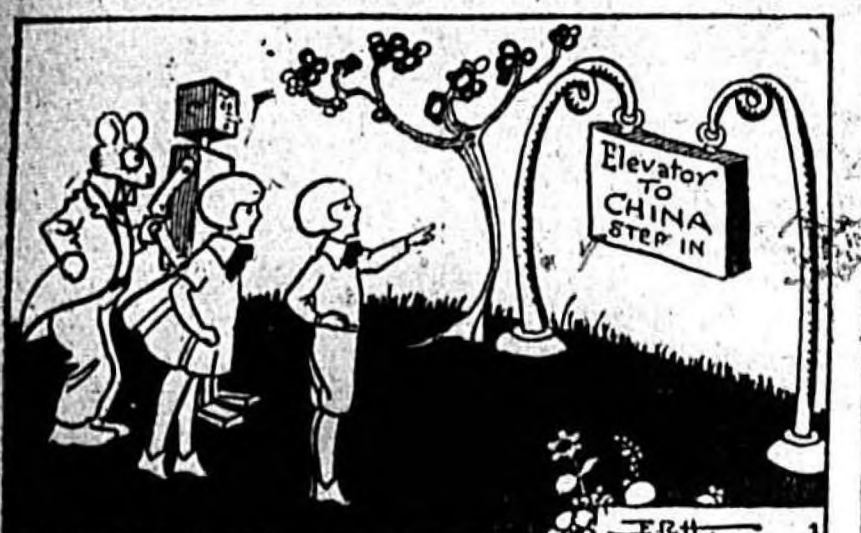

The dog was run down by a passenger train at a Jackson county grade crossing. Hunt was awarded \$50 damages in justice court and the award upheld in circuit court.

TAMPA, Fla., Mar. 3.—(AP)—John T. Westmoreland, 36, of the city, was killed when his automobile struck a telephone pole strung across Memorial Highway about midnight Tuesday night.

He was found shortly after the accident by another motorist and taken to a local hospital where it was found his skull had been fractured and death followed shortly.

The Newspaper's Duty

A newspaper's duty, like every individual's duty, sometimes calls for actions as distasteful to the parties affected. If it is to function properly, it is to be worthy of its position as an institution entrusted to a certain extent with the education of the masses, the newspaper must be a true mirror of life, reflecting impartially the every day actions of the rich and the poor, the great and the humble. The newspaper must be more than impartial, it must be fair and above all it must be fearless.

Suppression is a word that should never appear in a paper's code of ethics. Occasionally a story "breaks" containing matter too rotten, too offensive for the public ear; then the model paper weeds out this rotten matter, but still publishes the facts of the case in readable form.

The influence and the power of the newspaper as an instrument for public betterment cannot be overestimated. Many are deterred from infractions of the law more by the fear of damaging publicity than by the penalty of the law. With the exception of a small minority who seem to crave newspaper notoriety, human beings have a fear of adverse publicity that is responsible for the newspaper's position in the front rank of those forces that tend to promote law and order.

The paper that suppresses news matter damaging to individuals because the individuals affected are influential in the community, is betraying the most fundamental principle of journalism, and is undermining the newspaper's established position as an unbiased medium for the dissemination of all news.

There are admittedly so called "yellow sheets" capitalizing on the masses' inherent love of sensationalism and smut, but the number of such publications is gratifyingly small. Such papers are not representative of the true spirit of journalism.

The paper that functions properly plays each story for what it is worth, not under or over-stating, dealing in medium tones, using neither the loud nor the soft pedal. If a story develops embodying the violation of some moral precept whose application is general, it is the duty of the newspaper to publish the facts, irrespective of who is concerned.

Sanford's Baseball Team

Baseball fans in this city are glad to know that Sanford will be represented in the Florida State League again this year, and that the organization of a baseball team to represent this city is now in progress. Re-organization of the club that a creditable team from this city may be entered in the league, has been received with approval by scores of local baseball enthusiasts.

Sanford's team played in hard luck all of last year. One cause or another kept it at the bottom of the list throughout the whole season. But even at that it must not be forgotten that there were many staunch supporters who stood loyally behind the players throughout all of the discouraging days.

With an eight-club league this summer, the race for the championship will be much more interesting. By having a well organized and competently managed team, Sanford can put up a fight that will make it a contender for the highest honor in Florida baseball. And with a winning team playing high class ball there is little doubt but that sufficient support will be forthcoming from the fans here to meet the financial requirements of the club.

At great expense the people of Sanford have provided a baseball park as good as any to be found in Florida. The Chamber of Commerce and the city acted wisely in not paying out money to induce a major league team to train at this park this year. One season of such an arrangement with the Milwaukee Brewers, was enough to convince us of the folly of such a scheme. The money saved this year should be turned over to President Vance Douglass of the local club to assist in financing the city's team which will provide amusement for our people during the entire summer.

The Herald hopes those responsible for the foundation of a team to suitably represent our city will receive the hearty support of Florida people so that baseball will have a big place in the affairs of this community the coming summer.

Similarly, Wall Street housewives of high finance are shaking out the little grub spiders, speculators, but they go by the thousands. Later those Wall Street housewives will have gathered in the stocks and the game will start up again.

Don't be frightened out of your stocks, if you bought the right kind and are able to hold them and own them. A nation voluntarily buying about ninety million dollars of its own debt as a minor holiday hasn't finished with its boom. Secretary Mellon will buy and retire one hundred million dollars of the Third Liberty Loan during 4-1-4 per cent, as part of his spring financing.

Also six hundred and sixteen millions of treasury notes will be issued, so that the nation's debt seven hundred and sixteen million dollars. Our European friends reading that will be more than ever bitter about "Little Sam swollen with gold," and more than ever determined, through the world court, to relieve him of that gold.

Stewed figs are good for a breakfast fruit. For this purpose you should buy either pulled or dried figs, wash them carefully and let them soak in water to cover overnight. Then let cook in double boiler until tender. Take out figs, add sugar to the juice and let boil up. Pour this over the figs with a little lemon juice, and serve when cool.

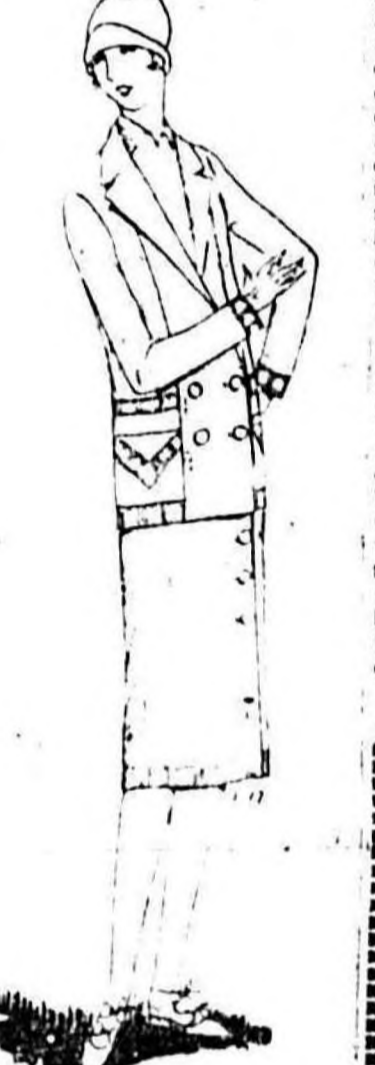

GRAPE GROWERS UNHURT THROUGH SALOON DEMISE

Statistics Of The Agricultural Department Show That An Increase Of Both Acreage And Prices Keep Going Up

SAN FRANCISCO, March 2.—(P)—Six years of grape growing in California under national prohibition have proven unfounded fears of vineyard owners that abolition of the saloon would injure the market for their product.

Shipments of grapes from this state have increased from 21,605 cars in 1919 to 72,118 last year.

Statistics of the Agricultural Economics bureau of the department of agriculture do not distinguish between so-called "wine" and "table" grapes. Therefore they do not show whether it is hunger or thirst that has caused the more than 300 per cent increase in the demand of other states for the products of California vineyards.

Before ratification of the Eighteenth amendment grapes sold around \$20 a ton. Since the law was enacted prices have, several times, soared over \$100 a ton. Acreage has increased but in ratio to the growth of carload shipments. Much of the increase in the shipment figures are due to the fact that a considerable part of the crop goes used in winemaking within the state now goes to other markets.

The California grapegrower class stock of his last year's business and looks to the coming season with inquisitive eye "Winehaven," before prohibition referred to as the world's largest storage center for wine, is being dismantled. It was built immediately after the San Francisco fire of 1906 on a seven-acre tract on Point San Pablo at a cost of \$2,500,000 including cottages for 200 employees. The winery had vats and cellars with a total capacity of 9,000,000 gallons. When filled its stock had a value of \$10,000,000.

In the heyday Winehaven owned a fleet of 150 railroad tank cars and it was in these that the last of the wine was transported under armed guard to San Francisco to be stored in bonded warehouses when the California Wine Growers' association decided to abandon the once famous institution and to attempt to sell the property for some other use.

Homing Pigeons Of Army In Canal Zone Fly With Whistles

CHRISTOBAL, C. Z., Mar. 2.—Homing pigeons in training by the United States Army in the Canal Zone took off today carrying whistles fastened to their tails as a protective measure against hawks which infest the isthmus.

As they flew the rush of air caused the whistles to sound and the astonished hawks gave the whined whistles a wide berth.

Though they weigh only sixteen ounces and eat less than an ounce of food a day, the Army homing pigeons fly for twelve or thirteen hours under the tropical sun of Panama without stopping.

Carried to remote parts of the Panamanian jungles by American soldiers, these plucky little feathered warriors dart away instantly toward their homing lofts the moment they are released.

Their unerring sense of direction and loyalty are counted valuable assets by the soldiers, who use them as a check on radio communication and to accompany airplanes exploring unknown parts of the isthmus.

ST. LOUIS, March 2.—(P)—With the arrival of the second squad of players at the Brown's training camp at Tarpon Springs, Fla. yesterday, the outfit is now complete with the exception of Cedric Durst, outfielder.

Dempsey Will Train For Willis' Match In Hendersonville Camp

HENDERSONVILLE, N. C., March 2.—(P)—Jack Dempsey will seek physical perfection in his coming fight with Harry Willis in the "Land of the Sky." His training camp, it was announced here yesterday, will be set up in Laurel Park estates, a suburb of Hendersonville, early in April.

The announcement, which was made by Eddie Conner, representing the heavyweight champion, also contained the information that adequate accommodations will be provided for trainers and the variety of newspaper writers, who will watch him through the training period.

Conner, after an inspection of the training camp site, said it was ideal for the purpose.

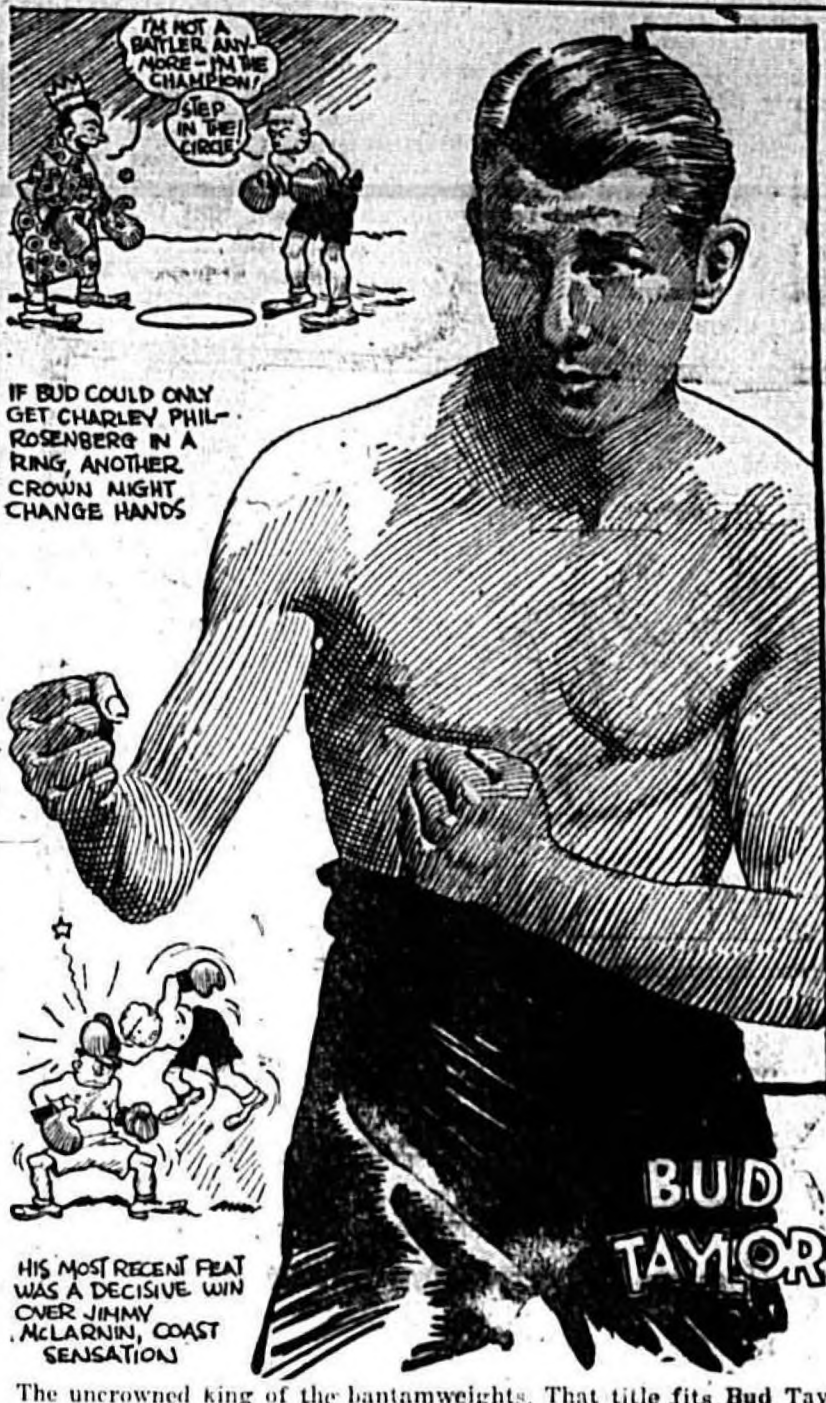

Revenue Act Is Explained And Commented On By A Well Known Accountant

EDITOR'S NOTE: The following article was written for The Herald by S. G. Gray, resident manager for the accounting firm of Halk, Penland and McCall. It gives light to many clauses contained in the new revenue law which may be of interest to readers of The Herald.

Now that the Revenue Act of 1926 has become law by the signature of the President, every man is wondering how his interests will be affected. This is the seventh income tax law passed in the last 12 years. Numerous changes have been made, some of which affect returns made under previous laws. Without attempting to pass upon the advisability or wisdom of these changes, it is interesting to know something about the principal ones, which are apt to affect the pocket book of the ordinary business man.

The changes described below regarding rates, income and deductions of individuals and corporations apply to returns for the year 1926. After taking credit for the usual personal exemptions, the normal rate is 1 1/2 per cent for the first \$4,000, 3 per cent for the second \$4,000, and 5 per cent for the remainder, instead of 2 per cent, 4 per cent and 6 per cent as provided in the former law. The rates of surtax begin at \$20,000 as in the former law, but the maximum rate is now reduced to 20 per cent, which applies to incomes in excess of \$100,000.

Corporation rates are increased to 3 per cent for the year 1925, and to 1 1/2 per cent for subsequent years. Instead of being payable in installments of 25 per cent each, the first two installments will be 24 per cent and the last two will be 25 per cent. These changes in the corporation rates have been made to cover the loss of revenue resulting from the repeal of the capital stock tax. Personal exemptions for single persons have been increased to \$1,600 and for married persons or heads of families to \$3,500. Credits for dependents are 3 1/2 per cent under the prior law. The amount of net income which necessitates the filing of a return has been increased to \$1,500 for single persons and \$3,500 for married persons and heads of families. Returns are still required of all individuals with gross incomes of \$5,000 or over.

12 1/2 per cent on capital gains, and new provisions regarding the sale of property acquired by gift. The maximum amount which may serve as a basis for the increase from \$10,000 to \$20,000, and the surtax as well as the normal tax is now taken into consideration in figuring earned income.

Installment Sales. For the first time the law contains specific provisions regarding the taxation of income from installment sales. These provisions cover merchants who regularly sell personal property on an installment basis, and also cover an individual who disposes of personal property for a price exceeding \$1,000. It also applies to the sale of real estate, provided the initial payments do not exceed one-fourth of the purchase price. The term "initial payments" means the payment received in cash or property (other than evidence of indebtedness of the purchaser) during the taxable period in which the sale is made. The provisions of this paragraph retroactively applied to the Revenue Act of 1916 and succeeding years, and any tax that has been paid under such acts, if in excess of the tax that has been paid under such acts, if in excess of the tax as modified by the provisions of this new section, are to be credited or refunded to the taxpayer, subject to the statutory period of limitations. A new deduction is provided in the law, in the case of a casual sale of real property, which deals with future expense liabilities incurred under the contract of sale.

In order to make certain the exemption of farmers' hail, cyclone, casualty and fire insurance companies, a new section has been added, and the former section exempting farmers and fruit growers co-operative associations has been modified to conform to the recommendations of the Senate Finance Committee. Numerous other changes in rates and deductions of income and deductions from income have been provided, which are of interest only to a few persons specifically named.

Administrative Provisions. With regard to the administrative provisions, it may be said that information returns and reporting from companies and individuals in the case of payment of estate tax to single persons and \$100 to married persons. The publicity section of the prior law has been expanded. Provisions are made for review of decisions of the Board of Tax Appeals of the 1924 act. years, and under prior acts five years. Numerous other administrative provisions have been made to make the matter of assessments more specific. With regard to refund claims, many of the provisions of the old law have been retained, but the limitation on refund claims for taxes imposed by the 1923 act is fixed at three years from the time the tax was paid. Other provisions deal with procedure of the Board of Tax Appeals.

Inheritance Taxation

While the Estate Tax was not entirely eliminated, as desired by our Florida representatives, certain reductions were made. The tax has been reduced from a maximum of 40 per cent to a maximum of 20 per cent on the amount of net estate in excess of ten million dollars. That will interest a few of our new Florida millionaires, but any farmer around Sanford who expects to die during the operation of the new Act may derive some comfort from the fact that the specific exemption has been increased from \$20,000 to \$100,000. The administrative provisions of the estate tax have been revised and enlarged. The rates of tax collectable under the 1924 Act are retroactively reduced to conform to those prescribed in the 1921 act, and where the tax has been paid at the 1924 rates, refund may be claimed.

The tax on admissions has been changed to exempt admissions up to 75 cents, instead of 50 cents. After thirty days from the passage of the act this provision become effective and should be of benefit to our moving picture fans. The stamp taxes are retained at the same rates, except the stamps on deeds of conveyance, proxies, powers of attorney and a few other instruments. Since these repeals

become effective some time in April, a substantial increase of real estate prices may be expected by reason of the saving to the seller in providing for revenue stamps. The capital stock tax has been repealed, the additional one-half per cent assessed on corporation income tax taking its place. The gift tax is repealed and the rates for 1924 and 1925 retroactively reduced. Manufacturers' excise taxes have been repealed, except three per cent on automobiles and 10 per cent on pistols and revolvers. The repeal covers a long list of articles, among which are included mah jong sets, this relief being a little late. The men get

a little comfort from the repeal of the excise tax on pipes, cigarettes holders, and humidors, and the women from the repeal of the tax on jewelry. Brewers and distillers are still compelled to pay a \$1,000 annual tax, but otherwise the special taxes on merchants have been repealed. Several new sections are apparently added with the view of settling definitely several questions which have arisen as a result of recent decisions of the courts and the Board of Tax Appeals affecting prior year returns. One section deals with the question involved in the appeal of Guarantee Construction Company

and the Supreme Court decision in U. S. vs. Anderson, which has to do with the reduction of invested capital for taxes of prior years, and another affects individuals who paid a tax under the 1918 or 1921 Acts as stockholders of personal service corporations which were subsequently determined not to be entitled to personal service classification. In view of the fact that each year new questions of income taxation arise, as a result of new conditions and decisions of the Courts and the Board of Tax Appeals, it seems that the law and its administration will become more intricate instead of simpler.

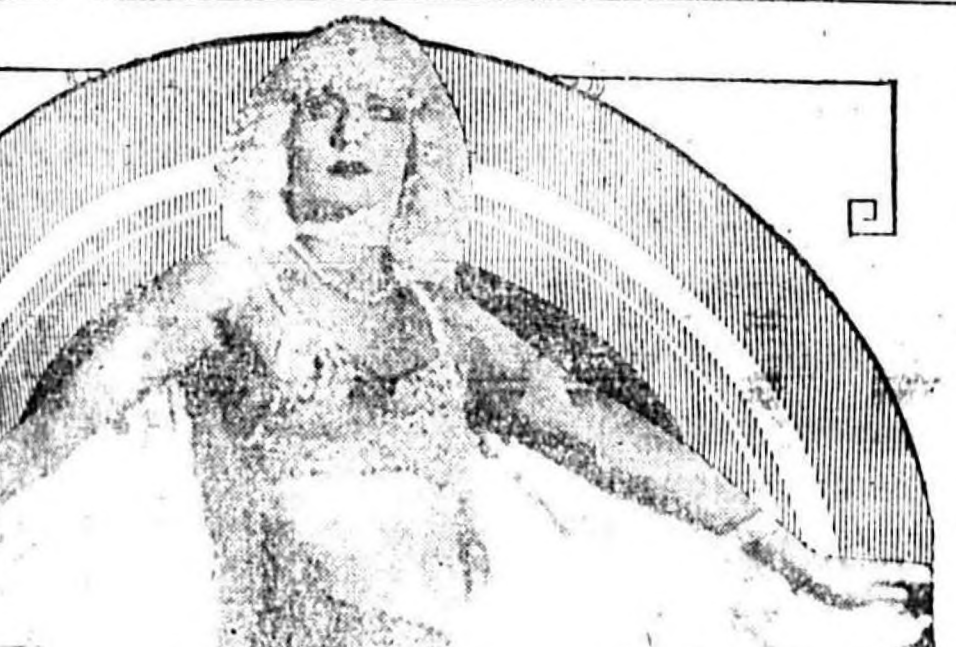

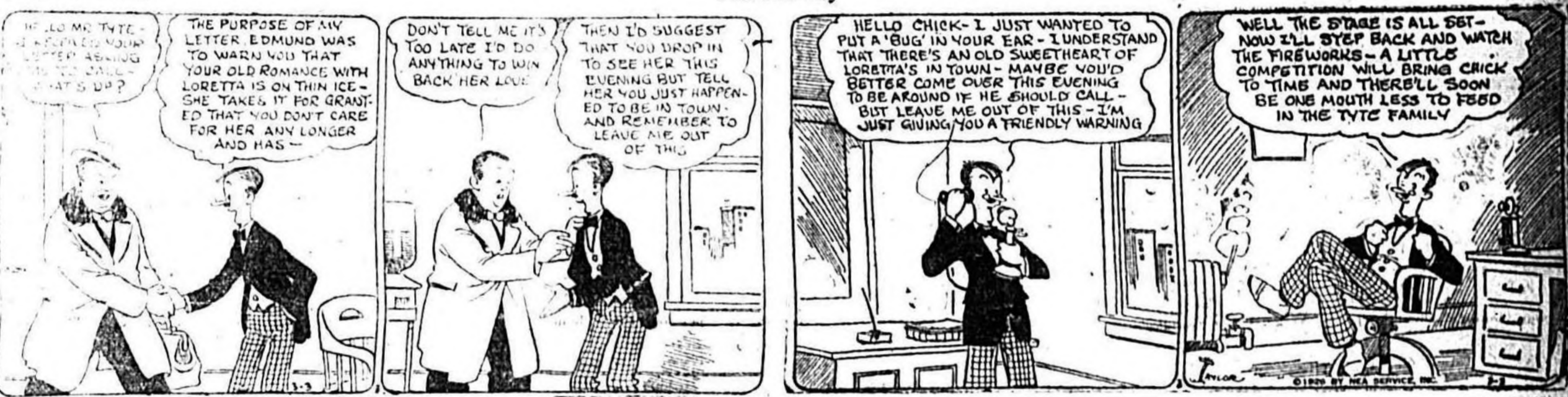
