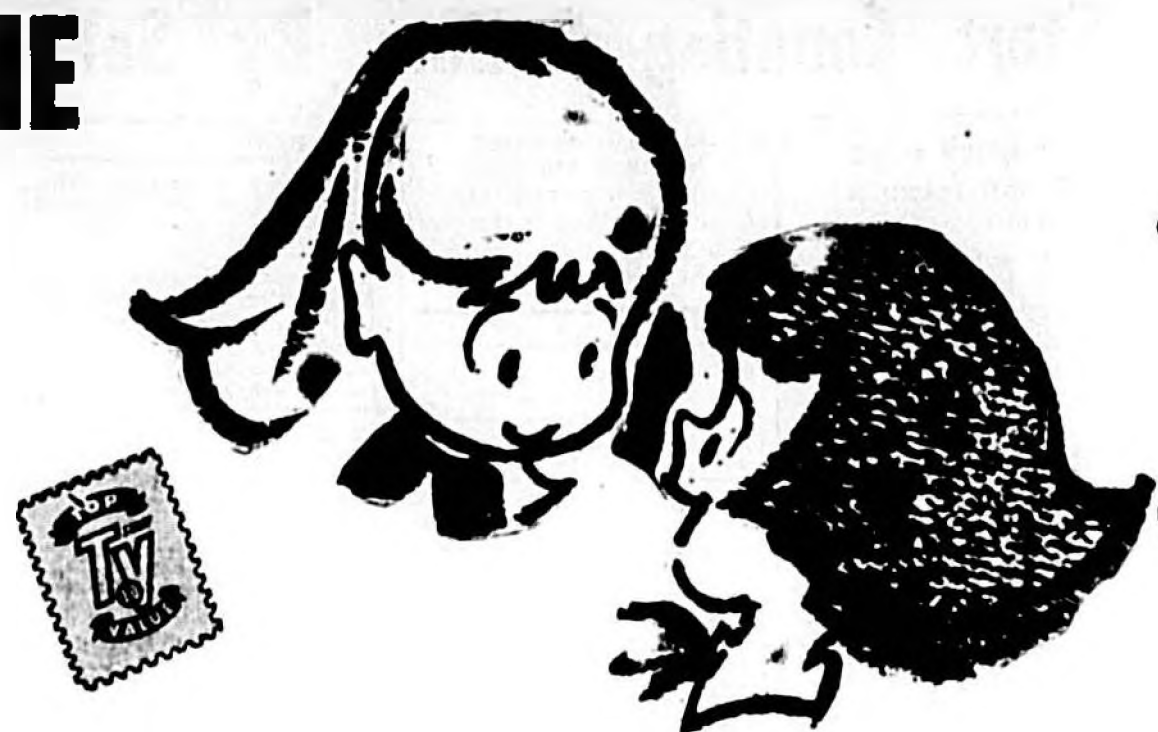

Cons Shackled, 'Some Cuffed'

RAIFORD (UPI) — A former lieutenant of the guard swore to a legislative committee today that he didn't "cuff up" prisoners on order of the captain of the guard but that he devised the treatment himself.

The witness, who testified early this morning before the state legislative interim committee on prisons and convicts, said he took action against state prison convicts here under orders from Capt. James Dunn.

But he added that Dunn did not stipulate just what control measures should be used when state convicts were in the maximum security building.

Dunn had been accused during the 19-hour hearing of ordering prisoners "cuffed up" — prison jargon meaning to shackle a prisoner's feet and hands to the cell doors with the weight of his body resting on his back bone on a concrete floor.

The guard, who testified he had a seventh-grade education, also told of using tear gas on prisoners including a Negro convict who died in his cell. The witness, who was replaced at his position in September, told of personally "cuffing up" or of such treatment administered by other guards to several prisoners for durations from 15 to 72 hours.

One such prisoner had testified last Wednesday of the treatment meted out by guards and showed the committee scars which he claimed were the result of the control practices. A medical examiner testified he treated a prisoner for the injury, an ulceration of the lower portion of the back.

Raiford Prison Supt. DeWitt Sinclair and Asst. Supt. L. D. Swann charged that three riots during May, June and July resulted from depriving maximum security prisoners of reading and writing privileges. Several witnesses testified the new building was extensively damaged during the disturbances.

They also charged that the principal cause for unrest in the prison setup here was the circumvention of authority by subordinate through State Penal Director R. O. Culver.

Reds Still Demand West Quit Berlin, But Fears Abating

BERLIN (UPI) — The official East German Communist newspaper Neues Deutschland renewed demands today the Western Allies get out of Berlin. It said the Western Allied occupation of the city could start a third world war.

But despite a new rash of threats, West Berliners' fears of a new blockade abated somewhat in the face of the backdown Wednesday by East German Premier Otto Grotewohl and West Berlin Deputy Mayor Franz Arndt said "there will be no new blockade."

Mayor Willy Brandt added that the Communist attempt to find a weak spot in the West's armament had backfired in the face of the Western promise to fight if necessary to save the city.

The latest threat came from Hermann Matern, deputy president of the East German parliament, whose statement was printed in Neues Deutschland.

"It is necessary to point out clearly that as long as troops of the Western powers are in Berlin there exists the danger of a provocation that could start a world war," he said.

Matern, who also is member of the Communist Party Politburo, said the Western powers must withdraw to restore Berlin life to normal.

East Berlin Mayor Friedrich Ebert said the occupation regime must be eradicated in all of Berlin. He recalled that the Soviets said in 1948 that the occupation blockade that all Berlin is part of the Soviet zone.

No one thought the danger was past forever, but the feeling was that the exposed Western outpost had gained a breathing spell for the time being.

Bomber Threatens Baptist Convention

MIAMI (UPI) — An anonymous telephone caller today warned that a bomb was set to explode in Central Baptist Church where 1,000 delegates were assembled for the Florida Baptist Convention.

The delegates, alerted to the threat, voted to stay in session. FBI and police officers searched the building while the delegates remained in their seats, but no bomb was found.

Dr. Roy Anzell, pastor of the church, said the delegates were "afraid" but he said, "I don't feel that anyone would blow up a group of Christian people in convention as we are."

The bomb threat was the 12th in Greater Miami since last Sunday. One of the earlier bomb threats was also telephoned to the Central Baptist Church.

'Rights' Probe Ordered In Arrest Of Ministers

WASHINGTON (UPI) — Attorney General William P. Rogers said today he has ordered a federal grand jury investigation to determine whether the arrest last month of three Negro ministers at Birmingham, Ala., violated their civil rights.

Rogers told a news conference he ordered the inquiry after Eugene Connor, commissioner of public safety at Birmingham, refused to discuss any phase of the case with the FBI.

He said Connor also had advised all members of the Birmingham police force not to discuss circumstances of the arrests with FBI agents.

The FBI moved into the case last month after receiving reports that three Montgomery ministers had been arrested at the home of Birmingham's Rev. F. L. Shuttlesworth on vagrancy charges and were held for several hours.

The vagrancy charges were later dropped. Rogers said the FBI has come to the point "to all practical purposes, where it has completed its investigation."

He said that in view of what he called the open defiance by Birmingham authorities, an inquiry would get under way as soon as possible.

Rogers also said the administration is considering legislative proposals to the New Congress covering "the whole gamut" of civil rights, bombings of churches and schools, and hate literature.

He said the proposals are under "serious" consideration, but no decisions have been reached yet. He made it clear that the problem of school integration also are among proposals being mulled over. Rogers said the administration proposals on civil rights are expected to be ready before Congress convenes.

Russia Puts West In Middle Of New Cold War Squeeze

GENEVA (UPI) — Western diplomats found themselves in the middle of a massive new Soviet cold war campaign today and said they believed the Russian intention was to try to force a new summit meeting.

They were studying the stepped-up Russian offensive for possible clues to explain the tough Russian stand at Geneva that has deadlocked two East-West conferences here.

Conferences on the prevention of surprise attack and on limiting nuclear weapons tests were scheduled for today. Both are equally deadlocked.

Informed sources said the Western delegations are studying a report on the latest moves in the Moscow offensive including Russian threats against the Western position in Berlin.

A sharp-edged propaganda drive attacking the West in vicious terms in Soviet radio broadcasts — the call for a new summit meeting in a single Soviet cold war communiqué issued Tuesday night — and the tough, unyielding Soviet attitude in both the Geneva conferences.

Diplomats here said they were convinced all these are part and parcel of a single Soviet cold war push against the West which still is in the process of being unleashed — with the worst yet to come.

They noted the Soviets have not dropped so much as a hint of a possible summit conference in their talks, nor far, possibly hoping to build up some sort of war scare that only summit talks could solve.

Final Rites Set For Auto Victim

Fort Wayne, Ind. (UPI) — Seven children were reported killed today when fire swept the home of Mr. and Mrs. George Gammons in Fort Wayne.

Police and firemen said the victims were all children of the Gammons. His wife, Audrey, and a daughter, Connie Sue, 3, and 4 years old, survived the flames, authorities said.

Mr. and Mrs. Gammons were taken to Fort Wayne Lutheran Hospital for treatment of smoke inhalation.

Police believed an oil stove exploded and hurled flames through the house, trapping the victims. The dead children were identified as George B., Chester J., Irene T., Alvin S., John J., Carolyn B. and Georgia Ann, 7 weeks.

To Be Completed, Ready To Operate Early Next Year

Seminole County's multi-million dollar vegetable industry today received a "shot in the arm" when the Jet-Vac Cooler Co. Inc., Philadelphia, announced plans to construct a vacuum-cooling plant in Sanford.

The announcement was made by William Leffler of Leffler & Bush Engineering Consultants. Leffler said the plant would be completed and ready for operation by Jan. 15.

At a recent meeting with Jet-Vac officials, Seminole vegetable producers discussed location of such a plant here. Officials said at the meeting that a pre-cooling plant would be a "very important addition, economically" to the local vegetable industry.

The process will assure a longer life for vegetables "on the shelf," increased production of lettuce and a better price for most locally produced vegetables, officials said.

Seminole County's vegetable industry now is an \$85 million a year business. Addition of the pre-cooler is expected to increase this figure considerably, according to Cecil Tucker, county agricultural agent. Erection of the plant also is expected to return lettuce production to its former important place in the vegetable industry, Tucker added.

The plant will be erected on land leased from Randall Chase. It is located just south of Seminole Boulevard, extending to Fulton Street and adjoining the newly-located Allied Chemical plant.

Julius Schaller and Happy P. Volou, president and secretary-treasurer, respectively, of Jet-Vac, said land and water were the only two problems in the way of locating the plant. Chase solved the land problem, the St. Johns River will supply the water.

Schaller and Volou said they are convinced that this plant will enrich, greatly, the economy of this area. They added that they are willing to invest \$100,000 in the plant "without the first guarantee from local growers."

Leffler said the plant "will be a big asset, not only in Seminole County, but to all of Central Florida."

Tucker called the plant, "a giant step toward helping us stabilize our vegetable production in Seminole County." He added that it would enable local producers to ship a better product and to diversify crop production.

Part of the equipment for the plant will be nearing completion in Asheville, N. C., and will be shipped in the very near future, Jet-Vac officials said.

Tax Hike Studied By Administration

WASHINGTON (UPI)—Treasury Secretary Robert B. Anderson said today the administration hasn't decided yet whether to reduce the budget deficit by recommending any tax increases to reduce the budget deficit.

There is mounting belief on Capitol Hill that the President already has ruled out a boost in income taxes, but is seriously considering recommending an increase in federal levies in gasoline to replenish dwindling highway funds.

Asked about these reports, Anderson insisted the administration has made no tax decisions. He said it won't attempt to

formulate tax policy until it figures out how much revenue present tax rates can be expected to yield in the next fiscal year which begins July 1, 1959.

Figuring Tax Income
"We're right now in the midst of attempting to figure that out," Anderson said in an interview with United Press International.

The administration's forecast of federal income-and-outgo for the next fiscal year will be made public in the President's January budget message to Congress. Officials generally agree the new budget will be stained with red ink, but insist the deficit won't be anywhere near as big as this year's shortage which is currently estimated at a peacetime record high of 12 billion dollars.

For the new fiscal year the administration is expected to budget spending of close to 80 billion dollars compared with the current 73 billion dollar estimate for this fiscal year.

But the administration is counting on the economic revival to boost revenues far above the 67 billion dollars estimated for the current fiscal year.

Florida Baptists Asked To Work For End Of Prejudices

MIAMI (UPI)—Florida Baptists were asked Wednesday to work actively to end race prejudices.

Dr. R. B. Culbreath, pastor of the Miami Springs Baptist Church, told the Florida Baptist Convention that "too long have our pulpits and churches been silent on the race issue."

Culbreath accused many church members of being "too full of prejudices they do not want to hear what the Bible has to say."

He charged that some of his friends have been asked to resign from their pulpits and "practically run out of town in disgrace" during the time of integration.

Dr. Ramsey Pollard, Knoxville, Tenn., pastor, told the some 1,000 delegates that the liquor industry is the greatest danger to the United States today.

But he said the anti-liquor forces are gradually winning the battle for prohibition. He said local option elections are going against the liquor industry and he predicted the industry "will be in real trouble within five years."

The convention voted to establish an old folks home in Florida, but no site was determined. Sites have been offered at Vero Beach and Tampa and will be considered by a committee.

The delegates adopted an operating budget of \$2,000,000. Half the money will go to state causes and the other for Southern Baptist Convention-wide enterprises.

They also voted to build a new \$400,000 headquarters building in Jacksonville.

Racketeer Crackdown Picks Up Speed

WASHINGTON — (UPI)—The Federal government's crackdown on the nation's "top 100" racketeers is picking up steam.

Last April 10, the Justice Department announced its special drive against the kingpin hoodlums. Carefully, it refused to name the sinister "top" or state specifically how it was moving against them. "How is the program progressing?" United Press International asked the man in charge, Assistant Attorney General Malcolm Anderson, head of the department's criminal division.

"We're working hard," Anderson replied. "We have a lot of work yet to do."

Beyond that Anderson would say little, since the long-range drive is being conducted in a hush-hush manner.

The department not only has not identified the top 100 hoodlums, but the public may never know the names of all who made the list. Nor will the government say whether charges have been brought against any of them since the drive was announced.

The department has a two-fold purpose in keeping the names secret—to avoid tipping its hand in investigations and to prevent any allegations at trials that publicly prejudiced the defendants.

Anderson said only that the names on the list "may" be disclosed sometime—after the racketeers have been tried.

Actually, the names on the list may change from time to time. Whenever one racketeer is dropped—because of conviction, deportation, death or other reasons—another will be added.

All federal law enforcement agencies are cooperating in the campaign, directed against organized crime and its so-called "overlords."

Anderson called illegal gambling, narcotics and extortion the chief areas in which organized crime operates. Deaf Mute Brothers Facing Execution

COLUMBUS, Ohio (UPI)—Two brothers will die in the electric chair Friday, unless they get a reprieve, in what is believed would be the first execution of deaf mutes in Ohio history.

Bert, 17, and Joseph Buss, 21, convicted of first degree murder in the stabbing of an elderly gas station owner, waited in death row while their family and counsel sought a clemency decision from Gov. C. William O'Neill.

The two have accepted side-by-side cells in Ohio Penitentiary for one year. They were convicted by a Belmont County jury Nov. 18, 1957 and began their sentence one day later.

If clemency is denied, the brothers' death will mark Ohio's second double execution of the year, and second in the last 12 years.

Warden Ralph W. Alvis said that to the best of his knowledge they are the first deaf persons ever placed in Ohio's death row.

Defense attorneys have urged that the brothers, convicted of the slaying of Mrs. Margaret Denham, 76, on April 10, 1957, should receive only life sentences on the basis of their disability.

No County Solidly Demo, Total Shows

TALLAHASSEE (UPI)—There is not a single 100 per cent Democratic county left in Florida, according to an official canvass by a Board of Cabinet officers.

Despite the Democratic sweep in the Nov. 4 general election, Republican Leand Hizer received votes in every county in his bid for a U.S. Senate seat. In the past, it was customary for some small rural counties to vote solidly Democratic.

The official canvass turned up no surprises from the unofficial election tally, but it did show graphically the extent of the Democratic sweep.

Sen. Spessard L. Holland, in carrying every county in the state, piled up 388,113 votes, or a 230,137 vote majority over Hizer, who received 153,966.

The canvass showed only 542,150 Floridians turned out for the election.

A total of 81 persons, who apparently did not like either of the senatorial candidates on the ballot, wrote in the names of other choices, including ex-Sen. Claude Pepper, whose Holland ousted in the Democratic primary.

Veteran state Utilities Commissioner Jerry Carter was swept back into office with 400,000 votes to 309,927 for Republican Louis Ingram of Winter Park. His fellow commissioner, Wilbur C. King, won re-election with 308,612 votes to 176,087 for Andrew Sandegren of Sarasota.

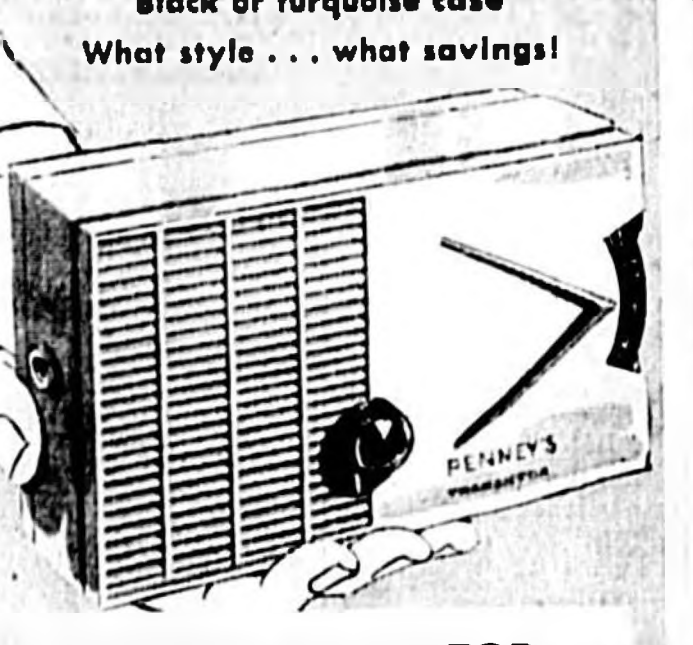

Washington Calling

By Margie Childs

WASHINGTON — While the official State Department view of the current tension in the Middle East is less pessimistic than that of observers who predict a new outbreak of violence, important changes in American personnel are in prospect to strengthen the American position in the area.

The expectation is that Henry A. Byrde will shortly be named Ambassador to Iraq where the ambition of President Gamal Abdel Nasser of the United Arab Republic to dominate the whole Arab world is being put to the sharpest test. As Ambassador to Egypt in 1955 and 1956 Byrde became a highly controversial figure and he was sent to the Union of South Africa where he is now Ambassador to take him out of the trouble zone.

Byrde was accused of being overly partial to Nasser. But his defenders insisted that he was merely realistic, in accord with American policy toward Nasser at the time of his appointment to Cairo. American policy toward Egypt underwent an abrupt shift during Byrde's tenure as Ambassador and he was left to try to make what adjustments he could to the sudden cooling off toward the Egyptian leader when American policy makers had initially helped to bring to power.

In any event, Byrde is one of the few American diplomats with real understanding of the area and with the respect and confidence of Arab leaders. His appointment to Iraq could serve a highly useful purpose at a time when the balance of forces is so delicate.

In the pessimistic view, Nasser's own ambitions, with a prod from Soviet Russia, make a new grab for power inevitable. With the war threat quieting down in the Far East as the China offshore islands

recede from the front page, the Communists will hope to stir trouble and throw the West off balance in the Middle East.

It is in the Near East, with its vast oil riches so essential to Western Europe, that American policy and American personnel have in recent years seemed weakest. The drift has been from one crisis to another, with little in the way of positive policy to check the deterioration of the Western position.

In this connection another change is in prospect and, while the decision is by no means final, it would mean a new realism and perhaps greater vitality. The present Assistant Secretary of State for Near Eastern Affairs, William M. Rountree, may be replaced by Raymond A. Hare, who is currently Ambassador to the United Arab Republic.

Rountree is one of the cautious civil servants whom Secretary of State John Foster Dulles moved into positions that are theoretical by policy making. In the conviction that you will get little less trouble if you do nothing Rountree has been reluctant to approve any move that seemed to involve any unpleasantness.

The Near East is one area in which Dulles feels a lack of expert knowledge and he has, therefore, been more willing to rely on Rountree than on some of his other advisers. In one crisis after another it has been necessary to improvise with measures that often conveyed a sense of desperate expediency. Thus when the rebellion broke out in Iraq without any advance knowledge in the West it became necessary to fly troops into Jordan and Lebanon to try to save those countries.

While Hare is also a foreign service officer he is in the commanding more decisiveness and forthrightness than Rountree. As Am-

Fred Othman Says

WASHINGTON—Profoundly subversive and un-American though it is, a terrible thought sometimes crosses the minds of politicians. This is that woman's suffrage has perhaps not been in every possible circumstance the soundest possible reform of this century.

No politician would dare utter this heresy without first pulling down the blinds and testing the room for wiretaps. Yet, this correspondent is able to report, from deep "inside," that such a dangerous notion currently is being secretly nourished by many friends of Sen. William F. Knowland.

Not all these friends wanted Knowland to win his desperate battle in California—not all of them were fellow Republicans. Some were only fellow husbands; and no doubt able to pass the severest Democratic loyalty test. Nevertheless, these, too now have a special sympathy for this large, grave, highly decent and highly correct man whose wife, Helen, calls him "Billy," in a diminutive

as wildly inappropriate as it is engagingly ironic. For Knowland, who had troubles enough anyhow, for the second time has cause to paraphrase the epigram that a man can take care of his enemies if only the Lord will take care of his friends. If the enthusiastic assistance of friends sometimes goes dangerously far, the help of a fond wife will go mortally far. A lady politician defending her own place and party will hit hard enough. In politics, as in other things, women believe in total war.

But a lady whose husband is a politician has a spirit of combat so disconcertingly clear-eyed as to make the most bellicose male partisan look like a conscientious objector. It is in this spirit that Mrs. Knowland wrote a brisk public commentary upon Mr. Knowland's running mate, Gov. Goodwin Knight. Knight sought to replace Knowland as Senator; Knowland sought to replace Knight as governor. Both lost.

Mrs. Knowland's remarks upon Governor Knight's "m a c a r o n i spine" followed her earlier endorsement of an extremely tough right-wing pamphlet by Joseph Kamp. Mr. Kamp's good wishes for Mr. Knowland were about as useful to him as a hearty endorsement from Gov. Orval Faubus of Arkansas would have been to Gov. Averell Harriman of New York. Similarly, her denunciation of Knight, who was in unhappy tandem with Knowland on what was, after all, a single ticket, brought joy only to the Democrats. Her estimate of Governor Knight was no different from that of many regular Republicans. But the point is that a woman in politics tends to adopt a candor that is a bit excessive.

The late Sen. Robert A. Taft of Ohio was no party-waiver in a campaign; but his devoted wife, Martha, sometimes made him appear almost a pacifist. It is said but true that in politics, and especially in an election year, it is possible to be altogether faithful to intellectual honesty.

Moreover, not many men in the United States of America can control their wives in a political campaign; any more than a wife can be controlled at a cocktail party for a detested boss whose favor her husband is nevertheless not anxious to lose once and for all.

Mrs. Eleanor Roosevelt raised her clear, untroubled voice more to the pain of her distant husband, but nobody ever heard of any husbandly effort to silence her. Indeed, a powerful Texan once wrote Old Cactus Jack Garner, then Vice-President, to complain to Mrs. Roosevelt's pronouncements. He demanded that Garner tell FDR to "do something about it." Garner sent back to Texas a single sentence: "What did you last control your own wife?"

And, finally, if politicians' wives are sometimes made to "see reason" there is yet another proof. This is the formidable and unagable madame chairman of almost any political community. These excellent ladies are sometimes called "charlatades," though the sheltered type of male who have never been white-stopping will hardly credit this. To the charlatades, Mrs. Harry S. Truman, no Richard Nixon, would for a moment deny the palm of the ultimate in fighting determination.

Fifth Amendment Brings Jail In Britain Courts

LONDON (UPI)—Britain introduced America's Fifth Amendment — but there is no such thing as a racketeer in this country. He would be slapped into jail for contempt of court on very short order.

Constitutional experts here point out that the Fifth Amendment, along with the other nine original amendments to the U. S. Constitution, known as the Bill of Rights, was inspired by British Common Law.

Britain herself suffered for many centuries from the injustices of the Court of Star Chamber — a court responsible only to the king himself, in which the prisoner had few rights.

The notorious Star Chamber was abolished in 1641 and since then British law has provided sweeping safeguards against unjust treatment in the courts — such as guarantees against "double jeopardy."

Many of those principles and safeguards were embodied in the U. S. Bill of Rights which became effective in 1791.

In Britain there is no statute to compare with the Fifth Amend-

ment. But the rules governing testimony in court were laid down in the Criminal Evidence Act of 1898.

Under this act, a witness, or his counsel can challenge a question put to him. It is then up to the judge to decide whether the question is permissible. If the judge rules the witness must answer, he has no choice but to do so. The only alternative is jail for contempt of court.

However, there are still restrictions on what may be asked.

In British law, a witness may not be forced to answer a question tending to incriminate him. Under cross-examination, however, he may be asked questions "tending to impeach his character and credit" if they are relevant to the case under trial.

Another rule bars the prosecution from bringing in evidence of a defendant's bad character or previous convictions. A man on trial for murder, for instance, may not be asked whether he has been previously convicted of other crimes of violence.

Questions about the income tax status of a defendant or witness almost certainly would be barred by the judge. Since membership in the Communist Party is no crime in Britain, there never has been an instance of a "Fifth Amendment Communist" in this country, so far as is known.

As in the United States, any court of law has the power to

subpoena a witness — "summon" is the term usually used in Britain. Anyone "summoned" as a witness in a hearing is obliged to attend. The judge himself has full powers to decide whether contempt has been committed and to hold a witness in contempt in jail for as long as he sees fit.

Other bodies with the same powers include select committees of the House of Commons and judicial tribunals named by the

government with parliamentary approval. Refusal to testify probably would result in a summons before the House of Commons Committee on Parliamentary Privilege which could turn the offender over to a court of law for contempt of Parliament.

However, British parliamentary experts can not recollect any case in recent years in which a witness has refused to testify before a parliamentary committee.

4 Secret Meetings On Bomb Threats Slated In Florida

MIAMI (UPI) — The FBI will hold secret conferences in four Florida cities to coordinate efforts against racial bombings and bomb threats.

The federal agency called the meetings Wednesday shortly after Greater Miami received its 10th and 11th bomb threats in the past four days.

The first conference with local law enforcement officers will be held in Miami Friday. Others are planned for West Palm Beach, Orlando, and St. Petersburg. No dates were set on the other hearings.

Wednesday's bomb threats were directed at Temple Beth Jacob Synagogue on Miami Beach and Corpus Christi Roman Catholic Church in Miami.

Both buildings were evacuated while police and fire inspectors made thorough searches. No bombs were found.

Leo O. Tsagan, chief of the FBI's district office in Miami, promised: "We will extend all our services in an effort to cope with the problem."

Nixon Is Talking, Awake Or Sleeping

MIAMI (UPI)—Vice President Richard M. Nixon, a hard-hitting political campaigner when awake, makes non-political speeches in his sleep, a dentist reported today.

Nixon was given a drug called "neval" described as a form of so-called "truth serum" Wednesday as an anesthetic for the extraction of an infected wisdom tooth.

The two dentists in attendance reported that Nixon made a speech after the extraction, while the anesthetic was wearing off. They said he told the audience—the two dentists and three nurses—about the American way of life, discussed a variety of general topics and praised his wife for bravery in Venezuela, where Nixon was attacked by a stone-throwing mob earlier this year. The dentists said he made no partisan political remarks.

After the speech, they said, he asked when they planned to remove the tooth. The dentists said they had to show him the extracted tooth to prove the job had already been done.

Integration At-A-Glance

The first full-scale federal-state conference on the school integration question will be held in Nashville, Tenn., early next year.

The federal Civil Rights Commission announced Wednesday it plans to invite school officials from all over the country to take part. Chairman John A. Hannah said the commission would ask school spokesmen for "all the available information" on local problems in admitting Negroes to white schools.

The commission also announced it was ready to proceed with a probe of alleged voting rights abridgments involving Negroes in Alabama. Executive Director Gordon Tiffany indicated the subpoena would be used if necessary to get at voting records, which have been withheld from federal investigators.

There were these other developments:

The Little Rock School Board Wednesday night dismissed school Supl. Virgil T. Blossom, and five of the six board members resigned effective at midnight Friday. The resigning members said they wanted to give voters a clean-cut choice on the question of integration in a vote Dec. 6 to fill the vacancies.

Negroes filed a damage suit against the city of Birmingham, Ala., challenging application of the city's new law which allows transit officials to enforce segregated bus seating.

Rep. William M. Tuck (D-Va.) urged that his state fight to maintain segregation even should the state's "massive resistance" laws be struck down. The statutes are being tested in both state and federal courts.

Rep. Brooks Hays (D-Ark.) reiterated his "moderate" stand on the racial question in a speech in Atlanta and called on the South to "earnestly seek to solve its problems." He said Arkansas

voters who rejected his bid for reelection in favor of a segregationist write-in candidate "will one day realize they made a mistake."

Robert F. Williams, official of the National Association for the Advancement of Colored People in Monroe, N.C., reported he has written President Eisenhower asking when the 14th Amendment to the Constitution will be applied to this social jungle called Dixie. He cited several recent instances in which he says Negroes have been discriminated against in his area.

Red Says Volcano On Moon Erupted

MOSCOW (UPI)—Soviet astronomer Nikolai Kozirev recently photographed a volcano erupting on the moon, the official Soviet Tass news agency said Wednesday.

Kozirev took the photograph at about 4 a. m. Moscow time Nov. 3 with the 50-inch reflector of the Crimea Astrophysical Laboratory, Tass said.

Kozirev described the eruption as a reddish glow that grew in intensity after ten hours.

"There was every reason to believe that it was a normal development of a volcanic process on the surface of the moon," he said.

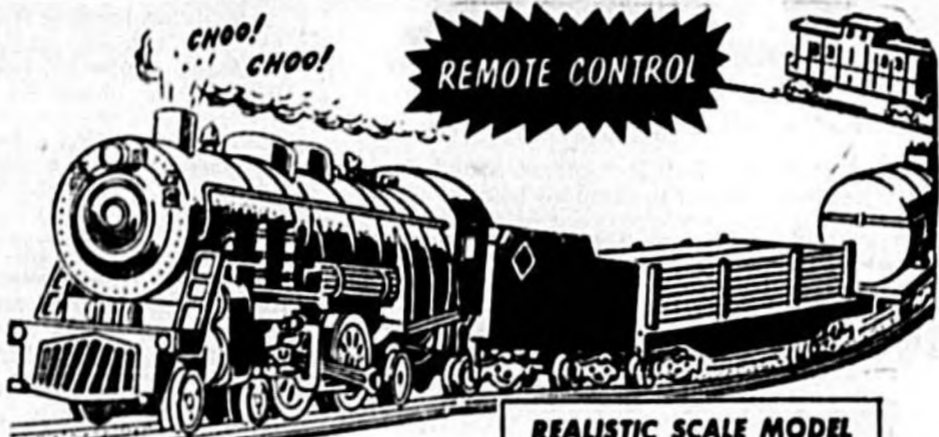

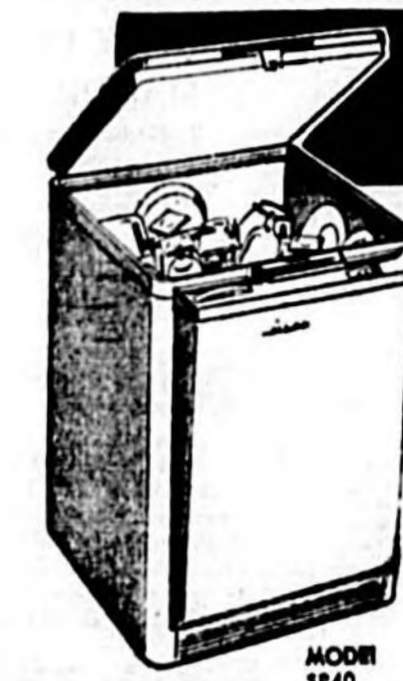

Road Users Oppose Hike In Tax

State, U. S. Discussing Increases For Gasoline

The outgoing chairman of the Florida Road Users Conference today repeated demands that unpledged money from motor vehicle taxes be used for the state's road program, rather than increasing taxes on gasoline.

Sydney O. Chase, Sanford, said some \$31 million from tag sales and vehicle taxes "are dumped into the general fund."

He added that some \$18 million of the state's \$44 million total goes into school construction.

Chase's statements came on the heels of recommendations that federal and state gasoline taxes be increased. State Road Board Chairman Joe Groffert proposed an additional one cent tax on gasoline yesterday. President Eisenhower was advised that a hike of one or one and one-half cents per gallon will be necessary next year to avoid additional "deficit difficulties."

Several weeks ago, Chase issued a statement in opposition to any increase. Today, he said the Road Users Conference is opposed to increases "on any level of government."

The Road Users Conference yesterday held its annual meeting in Tampa. A resolution opposing these proposed hikes was adopted. "We are not in favor of disturbing the \$13 million which goes for school construction," Chase said. "We do believe that the \$11 million which goes into the general fund should be for roads. Not one penny of this tag revenue goes for road construction. That is why Florida is so far behind."

He pointed out that the original tag tax laws provided that this money would go into the road fund, but the 1951 "emergency" caused diversion to pay school teachers. He added that the "emergency" long since has ended.

Chase said he was aware of the fact that "it isn't easy to replace revenue" by adding that officials link "the easiest thing to do is slip up on the people with gasoline and tag tax increases, to which we are opposed."

He said the Road Users Conference would continue to oppose these increases until the practice of "diverting these taxes" is ended. He favored a vote of the people, by state-wide amendment, on tax hike proposals.

"I realize that the Road Board needs money," Chase said, "but the money should be available if it had that unpledged \$31 million."

Special arrangements and accommodations have been secured for the conventionists in Sanford. Restaurants and hotels will be filled with delegates during the three-day session. Some meals will be served from the Civic Center cafeteria.

Invitations to attend Saturday and Sunday convention meetings have been extended to Sanford residents by members of the Assembly.

The program will begin tonight at 6:45 with songs and experiences, and talks on Ministry School. A service meeting will follow, including speeches on training and support of the Circuit Assembly.

On Saturday, delegates will witness baptism and total immersion, the latter to take place in the Mayfair Inn swimming pool at 2 p. m.

There will be a district and circuit assembly meeting with concurrent sessions at 2:30 p. m. "Expanding Our Ministry" will be the subject for training talks Saturday evening. A public meeting will be held Sunday afternoon at 3, under the direction of chairman D. K. Stago. J. W. Wilson will give a discourse on "The Watch Tower Society in God's Purpose."

The convention will conclude Sunday evening with sermons by L. D. Smith and Wilson.

Navy Gives Chiang Air Defense Show

ALBUQUERQUE, N. M., Nov. 13 (UPI)—The U. S. 7th Fleet showed President Chiang Kai-shek today how fast it could hurl jet fighters and atomic bombers into the sky to repulse a Communist attack.

Steam-powered catapults aboard this mighty carrier whipped 100-m. p. h. Crusader jets, carrying "Sparrow" or "Sidewinder" missiles, into the air at the rate of two a minute.

Twinned Skywarrior jet bombers, each capable of carrying an atomic payload, lumbered off the Midway's 1,000-foot flight deck under their own power.

Far over head an "umbrella" of fighter planes patrolled the skies as a precaution against Communist attack.

Chiang, wearing the khaki dress uniform of his five-star military rank, boarded a 10-passenger U. S. Marine helicopter on a golf course near his home to fly to the Midway, at sea off northern Formosa. The Midway's route lay more than 100 miles east of the Red held China coast, far out of range of the Communist shore guns which have been battering the Chinese Nationalist outpost islands.

Bombing Suspect Placed In Jail; Probe Continues

MORGANTOWN, W. Va. (UPI)—A technical charge of vagrancy has been placed against a 30-year-old unemployed coal miner held as a suspect in the dynamiting of an integrated school at nearby Osage.

Mayor Shady Solomon of Osage today sentenced the man, identified as Charles C. Chapman of near Osage, to 30 days in jail on the vagrancy charge while police continued to investigate his possible connection with the Monday bombing.

Chapman was charged with "being a nuisance in a public place." Authorities said the charge was based on Chapman's actions at an Osage beer tavern Sunday night.

Sheriff Charles J. Whiston said investigators were still trying to "prove or disprove whether he (Chapman) was responsible for the dynamiting." Whiston said investigators believe "this was probably a local job, but we don't discount the possible out-of-state element."

Whiston said Chapman was known to have had several arguments with Negroes while drinking.

VIENNA (UPI)—Police in Amstetten have arrested a man who said he masqueraded as a woman for 33 years.

"I thought I would have more luck as a woman than as a man," police quoted Franz Josef Boeck as saying.

He said he first put on feminine attire in 1925 to escape service in the Polish armed forces. Police said Boeck had no permit to live in Austria.

When arrested he was clad in a purple dress, a girly, nylon stockings and high-heeled shoes.

One report said he had aroused suspicions of monks in a monastery when posing as a woman—he had them for girls.

Reds Doubt U. S. Pledge To Fight

BERLIN (UPI)—The Communist East German press renewed its attacks today on the Allied position in Berlin and expressed doubt the United States would really fight to hold the city.

"People are not ready to allow themselves to be dragged into a destructive war for West Berlin," the East Berlin newspaper "Berliner Zeitung" said. Its headline read:

"Die for West Berlin? The people say no."

The story apparently was prompted by the U. S. State Department pledge to hold West Berlin by military force if necessary against the Communists.

The Berliner Zeitung repeated previous Communist assertions the Allied occupation is based on the Potsdam Agreement, declared the West has broken the agreement and said the West has lost its rights to stay here.

This was in denial of a State Department statement the occupation is not based on Potsdam but on the military defeat of Nazi Germany.

The new press attacks came after an unsuccessful Communist election rally Thursday night in blockade-threatened West Berlin.

Three thousand angry young Berliners tried to break up the rally but riot police kept them from mauling the Reds. Their protests were so strong, however, the rally was turned into a fiasco.

The first lady had a big day—early birthday party Thursday when several hundred Republican women came to tea. They presented her with a gold-plated silver sandwich plate matching the Francis I pattern of the Eisenhower personal gold dinner service.

Today's celebration was to be a strictly family affair with the Eisenhower grandchildren on hand. The presents were at private as the party.

Reporters and photographers were banned from the mass tea party as well as the family gathering. But one tea-sipper said Mrs. Eisenhower looked "perfectly lovely" in a green silk frock and matching jade jewelry.

Pink carnations, her favorite flower, bloomed on the tea table. Two old school chums from Cedar Rapids, Iowa, had been invited to drop in along with the GOP women.

In two public appearances this week Mrs. Eisenhower seemed, as one friend put it, "in fine fettle."

'Superior' Brother Kills Because 'He Had To Die'

ALTADENA, Calif. (UPI)—"He just had to die. He was an inferior personality."

Bruce Harlow Ginn, 18-year-old "intellectual," thus Thursday patiently explained to Los Angeles sheriff's deputies why he secretly bought a mail-order revolver and used it to kill his athletic and fun-loving brother, Edward, 14. He was charged with murder.

"I decided a year ago I'd have to kill Ted (Edward's nickname) because he was no good."

"I couldn't stand the thought of Ted being married and bringing kids into the world. Everything he did was bad."

"I'm not sorry a bit. If I had to relive it over again I would relive today with every detail the same."

Ginn made his statement as though trying to make deputies understand why it was necessary for him to shoot his brother seven times Wednesday in the family home. He also killed a pet Boston terrier dog, Razz, with one shot through the head.

Ginn, a tall, hazel-eyed youth, quit high school in his senior year last year when his grades began dropping. His parents sent him to a psychiatrist against his will.

"I had to go to the doctor because in school I kept my hands over my eyes and peered between my fingers. My eyes look color and there are circles under my eyes which hinder my facial appearance," he said.

Harry A. Ginn, 49, the father, a water company employee, said Bruce wasn't physically fit to engage in sports. "He spent time reading books," the father said. "He was an intellectual."
