Court Fails To State Congress' Election Power

Decision On Texas Primary Law Still Keeps Power Of Congress In Background; Walsh And Reed Comment

WASHINGTON, Mar. 8.—(INS)—The powers of Congress to regulate senatorial primaries remained in doubt today despite the Supreme Court's action in holding unconstitutional the Texas law denying negroes the right to participate in democratic primaries there.

This was the concern among negroes after a stay at the Court's decision. They declared the Court had avoided a direct expression on the power of Congress to lay down rules for the conduct of primaries, his throwing the question back into the field of political discussion. At some time in the future, they said, the issue probably will be decided directly but only after Congress has enacted a new law attempting to control the primaries.

The decision fails to state whether Congress has the power or lacks the power to legislate on primaries. It observed Senator Thomas J. Walsh (D) of Montana, one of the Senate's best-known constitutional authorities, "It simply forbids the states from making any discriminatory election laws."

A similar opinion was held by Senator David A. Reed (D) of Pennsylvania, who has frequently maintained that Congress had no power to regulate primaries.

Winter Visitors Head Off Run On East Coast Bank

NEW YORK, Financiers Place More Than Millions On Deposit To Save The Farmer Bank Of West Palm Beach

WEST PALM BEACH, Fla., March 8.—(INS)—Quick action by a group of New York financiers who are spending the winter in Florida, today headed off a run on the Farmers' Bank and Trust Company following the closing of the First American Bank.

Frightened depositors had fled to banks to withdraw their accounts and were causing much uneasiness and confusion when the New Yorkers decided upon a quick move.

Polling all their resources it is reported they raised more than \$1,000,000 which was immediately deposited with President T. R. Rees of the Farmers' Bank and Trust.

With women and frightened men who wished to withdraw their funds were paid at once. The action of the financiers allayed the fears of the little depositors that they would lose the small amounts they had in the bank. As the crowd quieted down many began to return to their homes.

The names of the benefactors were not revealed.

The Citizens Bank and Farmers' Bank & Trust Company came through safely at 2 o'clock, closing time added by receipt of funds from the Miami Reserve Bank with more following if needed.

Northern financiers here of various hotels mingled with the crowds at the banks this morning, reassuring the people and asking them to avoid trouble by exercising common sense. These men also deposited all the cash they had been subjected to the most vile insults.

Wealth And Social Standing Influence Promotions In State Department, Is Claim

WASHINGTON, Mar. 7.—(INS) diplomatic charges that "wealth and social prestige" are allowed to influence promotions in the State Department's foreign service were disclosed today when it was learned that three officers have resigned in protest against this alleged discrimination.

Those who have tendered their resignations are Tracy Law, Consul-General at Buenos Aires, John F. Gay, foreign officer stationed in Panama, and Lawrence Dennis, second secretary at the legation in Nicaragua. To date only Gay's resignation has been accepted.

Tracy Law, who helped frame the Rogers Act, which was framed to do away with unfair promotion and to combine the consular and diplomatic services, has taken the stand that the State Department is not giving the provisions of the Rogers law in distributing positions equally among consuls and

The Dennis letter brought the following feeling of resentment to head. This directly charged that certain foreign officers who possess the necessary influence can accept or decline posts offered them as they wish, while other officers are given no choice in the matter.

The letter also asserted that political considerations are permitted to influence promotions.

Dennis has been transferred to the State Department and, it was learned today, has been offered an important position in the division of Latin American affairs, subject, presumably, to his withdrawal of letter of resignation. Under Secretary of State Grew refused to discuss either the charges raised by Dennis or the report that he will be given an important post upon reaching here early next week.

Tax Assessments From Everglades Drainage Area Total \$1,604,061.40

TALLAHASSEE, Fla., Mar. 7.—The tax assessments of the Everglades drainage district, comprising 4,257,638 acres, amounted to \$1,604,061.40 during 1925, according to the tax department of the trustees of the internal improvement fund today.

There will be collected from the district \$30,629.94 through the one-mill maintenance tax; \$1,669,769.97 from the Everglades drainage district; acreage tax \$1,861.85 from acreage tax from the railroad right-of-way; \$1,636.61 from the one-mill assessment of railroad and telegraph lines in the district; and \$163.63 from the one-mill assessment tax on personal property.

If the owners in the district fail to pay the taxes assessed against them, the land is offered for sale by the district, the same as state and county tax sales are sold. If individuals do not purchase the certificates of delinquent taxes, they are purchased by the trustees of the internal improvement fund and the drainage district is then always assured of the total collection of the assessed taxes for the carrying on of their drainage work, it was pointed out by the tax department today.

Palm Beach county had the largest assessment of the 11 counties in the Everglades drainage district. The county had 1,010,364 acres in the district at a valuation last year of \$90,629,629. The one-mill drainage tax on this county amounted to \$10,137.190; and the Everglades acreage tax amounted to \$554,671.70.

Broward county had 682,211 acres in the Everglades drainage district, value at \$9,011,664; the one-mill drainage tax assessed was \$3,911.67 and the acreage tax \$368,577.77.

Collier county, 335,708 acres; assessed valuation, \$335,210; one mill drainage tax, \$335.52; acreage tax, \$33,573.

Dade county, 1,005,940 acres;

assessed valuation, \$11,546,978; one-mill drainage tax, \$11,546,978; Everglades acreage tax \$309,032.50.
