

MILLION DOLLAR REFUND MADE TO SOME TAXPAYERS

American Tobacco Co. Is Returned 4 Million On Income Tax

WASHINGTON, Dec. 28.—(AP)—A stream totaling nearly \$4,000,000 flowed back out of the Treasury Department during the fiscal year into the pockets of taxpayers upon whom unusually high levies had been imposed, an analysis of a huge mass of figures submitted to Congress by Secretary of the Treasury revealed today.

In all, 108,601 separate tax refunds were made, ranging off the way from one cent to \$1,211,748 claim honored in the name of R. J. Reynolds Tobacco Company of Winston-Salem, N. C.

Five refunds went over the \$1,000 mark and one fell just a few thousand short. In addition to the Reynolds claim, the \$1,211,748 million dollar refund American Tobacco Company and subsidiaries of New York, N. Y., \$1,149,833.
