

'Mix' Parks, **Memphis Told**

WASHINGTON (UPI)-The Supreme Court unanimously directed the city of Memphis loday to "promptly" desegregate its parks, libraries and museums and served notice that Southern communities are moving too slowly toward integrating their schools. Today's ruling rejected a plan by Memphis which would have gradually desegregated the parks and other facilities over a delayed perlod of time. The court held that the constitutional rights of Negroes were being violated by the delay.

City officials of Memphis had relied on the court's famed 1955 edict that Negroes should be integrated into the schools "with all deliberate speed." This has been taken to mean on a graduat basis.


