If the motor can be recovered, and it has dunked itself in more than a year. salt water, quick treatment is indicated. Salt water and air, when it is brought to the surface can wreak havoc with motor parts. If in fresh water, it isn't so had - just remove the plug or plugs, dry the motor and fire it up.

Because of powerful chemical action against steel and aluminum which salt water produces, a salvaged motor from the depths of old briny must be torn down, thoroughly cleaned and reassembled. Those in the know advise strongly against leaving it in the air after the motor is taken out of salt water. Get to work on it at once, or have the experts start immediate reconditioning. Balt water almost always ruins or severely damages the bearings. Rust and corrosion are always at the beck and call of salt water. Best not give them the opportunity to try their evil works on your motor. To avert this, always determine that the motor is securely fastened to the transom
