U.S. Official Delivering Response To Iran's Demands

Deputy Secretary of State Warren Christopher left Washington for Algeria today to deliver a U.S. response to Iran's four demands for release of the 52 American hostages.

Warren Christopher, accompanied by a small party, departed Washington for Algiers this morning, the State Department reported.

"He will deliver to the Algerian Foreign Ministry for transmission to the Iranian authorities our response to the Iranian Parliament's resolution on the release of our hostages."

The State Department said Christopher and aides left Washington at 1 a.m. EST on route to Algiers. Algeria has handled Iranian affairs since the United States broke diplomatic relations with Iran.

The Washington Post, citing unidentified sources, reported Sunday the Carter administration was preparing to respond to the Iranian demands for release of the captives with proposals that will meet the spirit if not the letter of Tehran's position.

Iran had demanded the return of the wealth of the late shah, freeing Iranian assets frozen in the United States, a pledge of non-interference in Iran's affairs, and dropping of financial claims against Tehran.

In Tehran, there were no new developments to indicate the release of the captives, held for 372 days.

In a stunning development Friday, Former Foreign Minister Soleh Ghotbzadeh, who warned that radical policies in Iran were making the release more difficult, was imprisoned after allegedly criticizing both officials of the state radio and television and the militants holding the hostages.

Former media chief Masoud Eslami who also participated in the interview with Swedish television was ordered to surrender. He was being sought.

The once-powerful Ghotbzadeh was seized by revolutionary guards and hauled off to Tehran's notorious Evin prison used by the late Shah Mohammed Reza Pahlavi's SAVAK police.

Sunday, the newspaper Mizan run by Mehdi Bazargan, Iran's prime minister early in the revolution that swept the shah from power, called the arrests of Ghotbzadeh "treating a toothache with a punch and a hammer."

In the interview Ghotbzadeh, a former head of Iranian television, said the confusion surrounding the release of the hostages was a result of his country's prolonged experiment with radicalism.

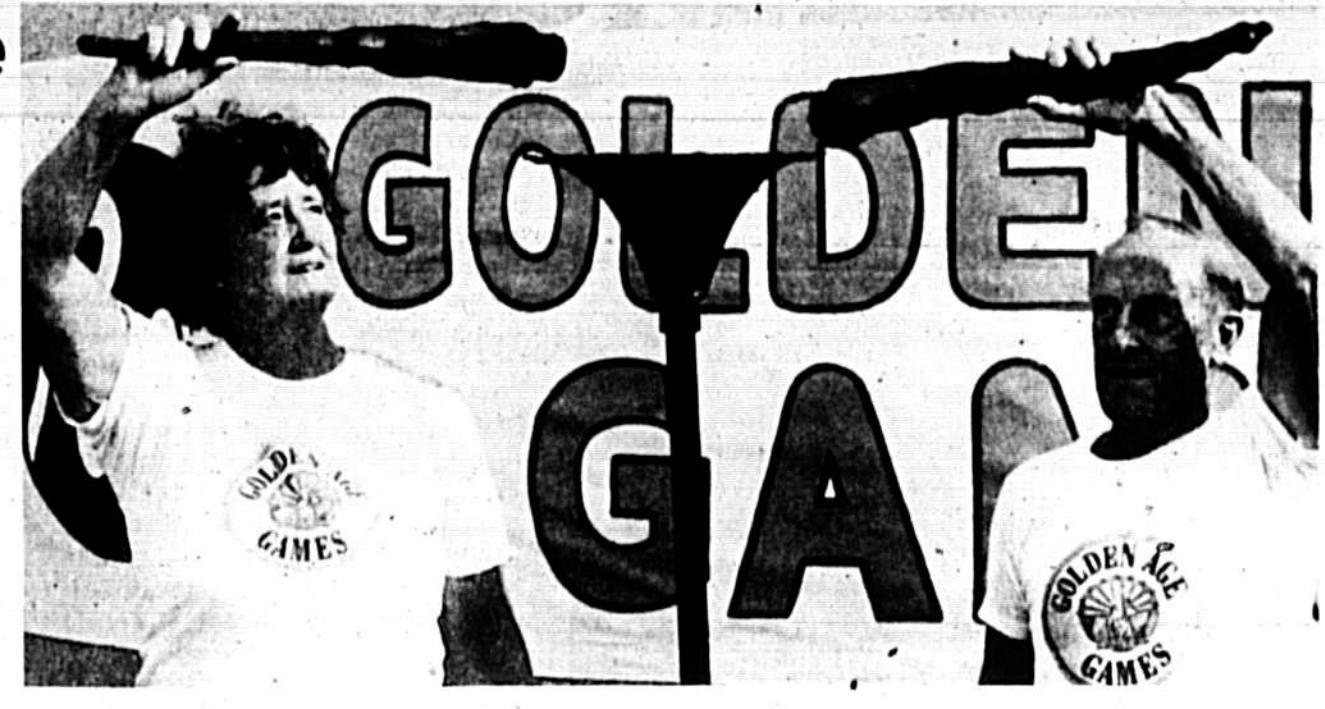

Agency Rejects Hospital

A stunned and astonished Seminole Memorial Hospital staff was told this morning the state has turned down Hospital Corporation of America's application for permission to build a new hospital in Sanford.

But Hospital Administrator James Tesar told an early morning staff assembly the rejection is "just a little setback."

Hospital Corporation of America (HCA) will appeal the decision of the state Health Services Agency's Health Facilities Commission, he said.

Gary Clarke, director of the office, said today his staff determined that it would be more cost-effective to renovate the Seminole Memorial Hospital than to build a replacement facility.

But HCA's analysis of the situation showed renovation to be a more costly alternative, according to its proposal to the county commission in November, 1979.

The rejection followed overwhelming approval of the proposal by the Seminole Sub-Area Council of the Health Services Agency of East Central Florida (HSA-ECF) and the full HSA board. HSA's are federally funded health planning agencies charged with making recommendations concerning new health facilities.

HCA officials in Nashville said renovation versus replacement was never an issue with the HSA.

"We were surprised that this would be the sticking point," said John Willson, HCA's director of health facilities planning.

"It is very unusual that we had no indication of this. We had no reason to expect this might happen," he said. "Usually we're in touch with what's going on."

HCA has built 85 hospitals in the U.S. and abroad and operates 181 internationally.

Clarke said HCA has the option of an appeal within 30 days to an administrative hearing officer appointed by the state.

That officer, he said, would hear all evidence in the case and render a decision. Then it is up to the Office of Community Facilities to accept or reject the recommendation.

Clarke, who has been director of the office just six weeks, said he considers the advice of his staff but he makes the final decision.

"The buck stops with me, I guess," he said.

"If HCA doesn't like his decision, they can appeal to a state District Court, Clarke said.

He added that his office is going along with HSA recommendations "90 percent of the time."

"That's the time we didn't agree with them," he said.

A spokesman for Clarke's staff architect said this morning it was determined that the hospital could be successfully renovated for \$6 million.

HCA estimated recently that the replacement hospital would cost about \$24 million. But in its November, 1979 proposal it said the cost of renovation would be approximately \$14 million with a loss of revenue during the construction running well over \$1 million.

Furthermore, HCA concluded that the renovated structure would have approximately half the life cycle of a new building and would be inferior in a number of ways.

Seminole Memorial Hospital Chief of Staff Dr. Kenneth Wing told the county commission, at a public hearing before HCA was selected as the firm to take over the hospital, that the building, which was in violation of a number of fire and safety codes, is extremely inadequate.

"Our operating rooms are not large enough to comfortably accommodate all the required people and equipment," Wing said. "We do not have enough treatment and examination rooms. The

Casselberry Mulls Sewage Agreement

A 747-unit multi-family dwelling complex, restaurant and clubhouse costing \$33 million will probably be built if the Casselberry City Council approves a sewage capacity agreement at 7:30 p.m. today.

The Granada Construction Corp., an Arizona company, and La-How Limited Partnership, a Florida firm, asked the council at its last meeting, for 150,000-gallon-per-day sewage capacity for the complex to be built on 14 acres east of State Highway 406 and west of Lake Howell Road.

After the council changed the percentage of the liquidated damages from 10 percent to 25 percent and set the completion date of the entire project for six years, the council informally agreed to the capacity last week.

Seminole To Review Judge's Insurance

Seminole County commissioners will be asked Tuesday to review restricted Judge Valde Williams' request to change his insurance coverage from hours worked on a quarterly basis to hours worked on an annual basis.

The commission will also meet at 7:30 p.m. to hear rezoning requests. — DIANE PETRYK

What Lies Ahead In Abscam

WASHINGTON — Today two more congressmen are scheduled to go on trial for allegedly succumbing to the temptations offered by FBI undercover agents in the ABS-CAM operation.

The pair, Rep. Frank Thompson, D-N.J., and John Murphy, D-N.Y., whose complete innocence of the bribery charges against them, the only misdemeanor in the ABS-CAM caper, they insist, was on the part of the FBI men who posed as representatives of a love-seeking Arab sheik.

But the scenes filmed by the FBI's hidden cameras will make a devastating case against Murphy and Thompson. Similar videotapes, played at the trials of two House colleagues, helped to convict them.

The secret videotapes, sealed by court order, have been reviewed by my associate Gary Cohn. Here's a preview of what the jury will see and hear at the trial of Murphy and Thompson: Two unwitting middlemen, Philadelphia attorney Howard Oriden and New Jersey building consultant Joseph Silverstein, also go on trial.

On Oct. 9, 1979, Thompson and Oriden met FBI agent Anthony Amoroso, who was posing as the fictitious Arab's henchman, in Washington, D.C., townhouse. Evidently coached by Oriden to blow his own horn — and blow it loud — Thompson told Amoroso: "Let me say this. My Democratic county chairman is a county chairman because I got tired of being the county chairman."

Could he help the "sheik" with his immigration problems? Deportation "can be stalled," Thompson said. "But it's very difficult. Very difficult."

"Well, that's what the money is for, isn't it?" asked FBI agent Amoroso. "Well, I'm not asking for any money," instead, he suggested the sheik deposit \$300,000 or \$400,000 in some Trenton, N.J., bank of Thompson's choice.

"Would that be any problem?" It would, of course, because such deposits couldn't be filmed by the hidden cameras, said Thompson, and Oriden picked up the bribe case.

On Oct. 20, 1979, Murphy and Oriden met the two undercover operatives at the Hilton Inn near Kennedy International Airport. Again, Amoroso had packed \$50,000 into a suitcase in view of the hidden cameras.

Could Murphy help with the sheik's immigration difficulties? "I don't think there will be any problem," said the congressman.

Amoroso said the sheik had told him, "Hey, take the money, go find the people that can do this for me."

He proffered the cash-filled briefcase. "Why don't you give that to Jack?" said Oriden.

But Murphy, like Thompson, would not touch the briefcase. "Howard, you take care of that," he said, and Oriden did.

Schools' Energy Marks

Energy-pitching in the schoolhouse may mean the kids need to dress a little warmer.

Two years ago, for example, 25 percent of all school buildings were heated by oil. In 1979, the figure had dropped to 19 percent.

Salmon said the use of natural gas is on the upswing. Fifty-five percent of schools used natural gas in 1978; 64 percent, in 1979.

The survey showed fuel options are growing among the schoolfests. More than one-third of respondents said their districts have at least one building that can quickly switch to an alternate fuel source in event of an emergency.

Other highlights: —Large school districts are more energy efficient than small school districts. They use fewer BTUs than small districts on a square foot and per pupil basis.

Nationally, maintenance factors, such as better upkeep of equipment and facilities, were cited by 64 percent of respondents as very important in holding down energy consumption.

Capital investment aimed at energy saving was named by 59 percent as important or very important. Changes in operations were cited by 47 percent and low cost energy, such as reducing wastage of bulbs, by 44 percent.

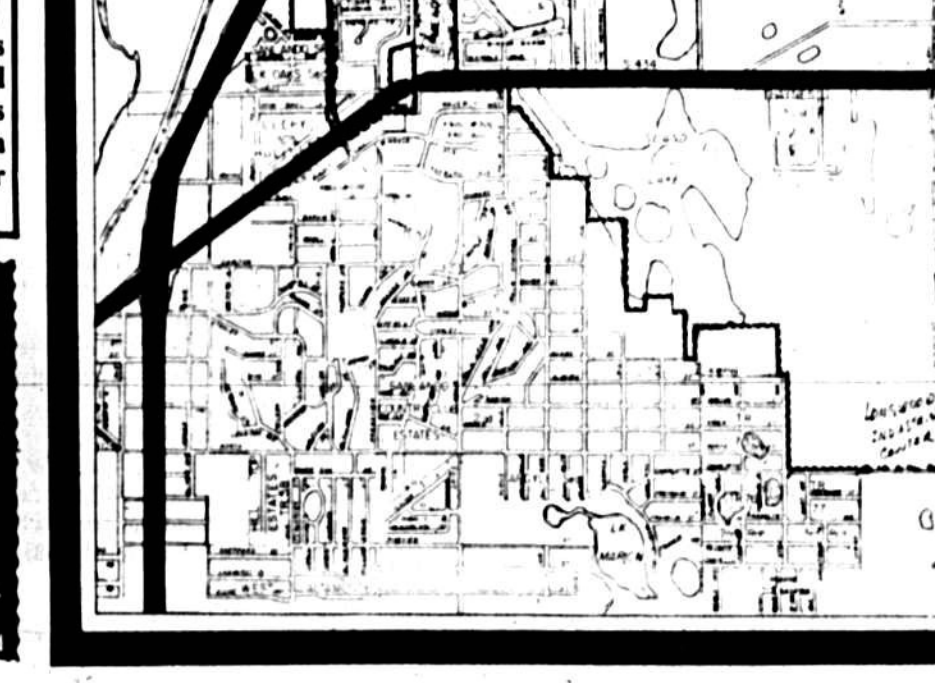

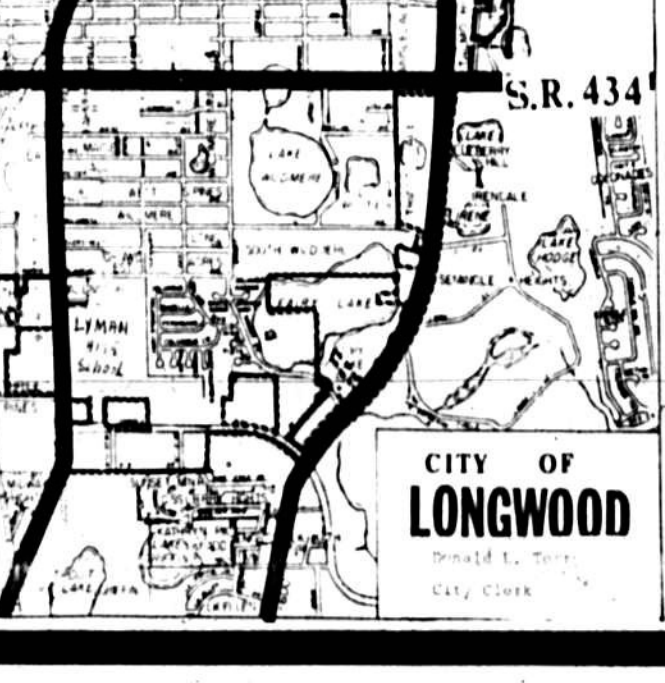

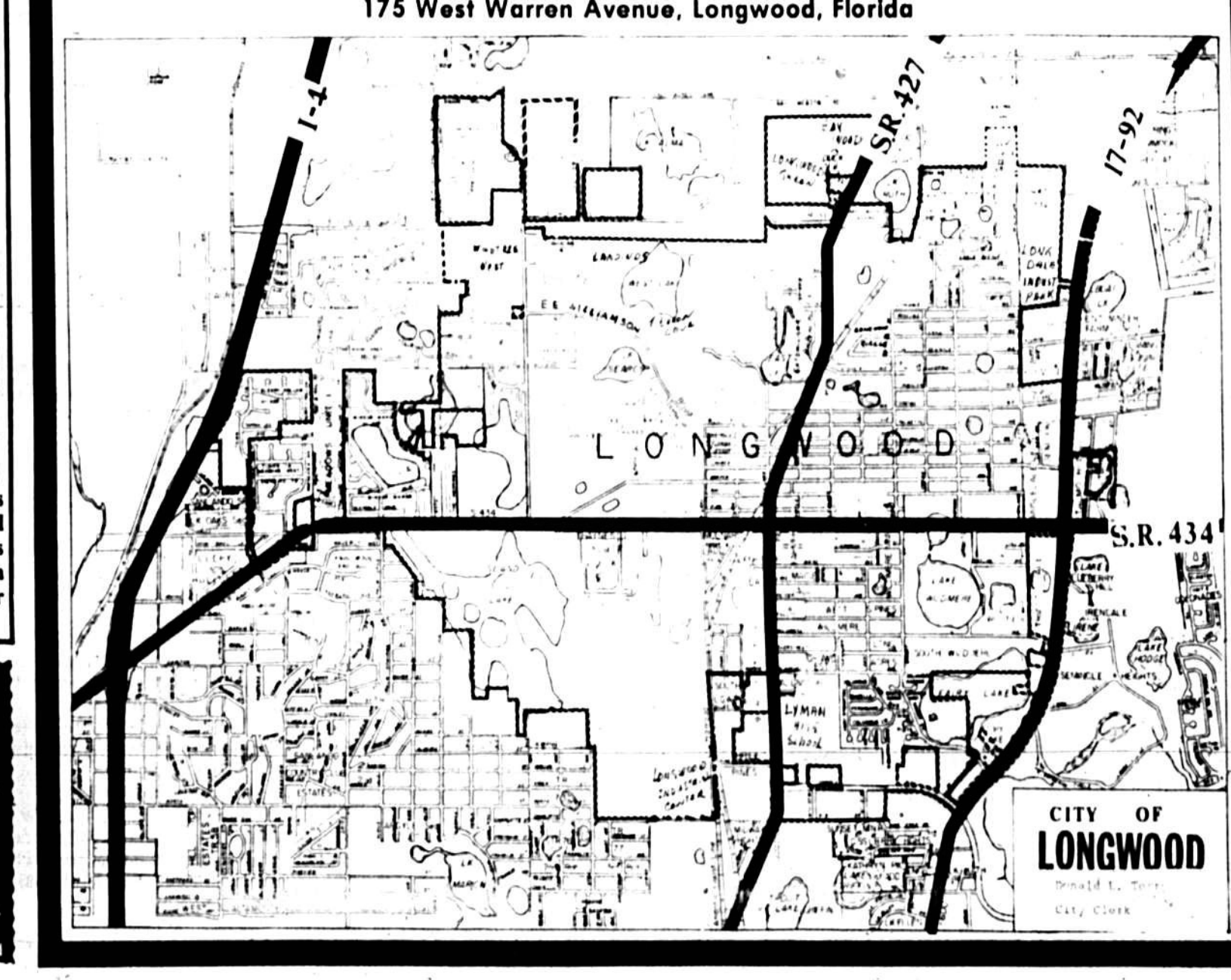
