Suzanne Lenglen Says Mary Browne Is Better Player Than Helen Wills

NEW YORK, Feb. 5.—There are two really great women tennis players in the world and the other one is Mary K. Browne, if the writer is to judge the purport of a statement given him today by Suzanne Lenglen.

She said, just so many words, that she thought Mary Browne was a better tennis player today than Helen Wills. To give Suzanne her due, she didn't even mention herself in this connection. She didn't have to. Everyone knows the lady is good. She may even support it herself.

However, it had been understood that everyone considered Miss Wills as the unofficial runner-up in a world ranking, amateur and professional, but it seems not there is a minority opinion and it appears to consist of Suzanne Lenglen.

"From facing Miss Wills at Cannes and Mary Browne in our series of professional exhibitions, I would be inclined to favor Miss Browne to win," Suzanne declared. "Mary's improvement during the trip has been marvelous. Her backhand once was weak; now, it is strong, oh, so strong."

"Her strokes are ever so much more severe, her service has become stronger and her court strategy is improved immeasurably. I never knew what to expect from her

next. If Miss Browne and Miss Wills were to meet today, I would favor Mary. I think she is the superior of Miss Wills, too."

Suzanne says she "adores" America and would be content to stay here indefinitely if her father was with her. This was one of her many observations during the interview.

Another was that California is "priceless" and a third contained the information that she had received invitations to put her "act" on in Germany, Denmark, Czechoslovakia, India, Japan, Australia and South America. She intimated that she would accept all the sundry at her leisure.

She didn't say so but her words gave the impression that clunk clunk pyle would turn up absent at the pay off if this tour is carried through. It may be suspected that Suzanne has discovered just what makes the managerial wheels go around and it is definitely known that her contract with the big sport and pile man soon will expire.

Her further observations were to effect that she would return to America very soon, perhaps next year on her way to Japan; that she will sail for home, regretfully or about Feb. 20, and that professional tennis is much to be preferred from her standpoint to the amateur game, since its demands were much less exacting.

DEMPSEY WILL BEGIN TRAINING GRIND SHORTLY

Former Champion To Sojourn At Wheeler Springs, Calif., For 1st Part Conditioning

French Net Stars Capitalize on Their Names Is Claim

NEW YORK, Feb. 5.—(INS)—Charging the United States Lawn Tennis Association with exploiting its amateur out status until they no longer are of value either to tennis or themselves, Vincent Richards today explained his action in turning professional as one of necessity and openly hinted that Henri Cochet and Jacques Brugnon, French stars, were far from amateurs. By inference, he indicated that Bill Tilden was not a simple pure, either, because he was capitalizing his name in newspaper articles.

"I suggest that when I wrote newspaper articles, they hired me largely to obtain the name of Vincent Richards, the tennis player," he said. "If this was true, I was capitalizing my position as an amateur player. I have intelligence enough to realize that Tilden wouldn't be a good enough newspaperman to care his living at it if it was for the fact that he is a great player."

Brugnon earns \$10,000 a year as the representative of Dunlop Company and he won't play in a tournament abroad in which the Dunlop ball is used. Cochet owns an airport and used.

A Statement TO THE PEOPLE OF CENTRAL FLORIDA by The Canaveral Orlando and Southwestern Railroad

1. A charter was granted by the State of Florida in 1923 authorizing the building of a Railroad from Canaveral to Orlando, to Sanford, to Sebring and points South and West.
2. The authorized capital stock of the Canaveral, Orlando and Southwestern Railroad Company was fixed at Five Million Dollars. The Stock is all Common, non-assessable and of the par value of One Hundred Dollars per share.
3. The officers of the Company deem the time opportune and the necessity imperative for the building of the road.
4. As a first unit it is now proposed to build a road from Canaveral to Sanford and Orlando by the most direct and most practical routes.
5. Rights-of-way have been secured conditionally along two or more parallel routes in some places, but the exact location of the road in its entirety has not been announced nor will it be until final surveys are completed and locations recorded.
6. It is estimated that the cost of the first unit will not exceed \$1,500,000.
7. The initial financing will be done by the immediate offering of 15,000 shares of the Company's Stock aggregating \$1,500,000.00 par value. The first block of this offering will be sold at \$110.00 per share.
8. The management pledges that all the money received from the Sale of Stock less only the cost of selling and certain necessary engineering and incidental expenses, will be held in local banks until a sufficient amount is in sight to insure completion of the first unit.
9. Among the assets of the Company are listed:
 - A. One of the most liberal charters ever granted by the Florida legislature.
 - B. Valuable rights-of-way mostly in the form of warranty deeds.
 - C. A large acreage of land contiguous to the right-of-way which will be greatly enhanced in value by the construction of the road.
