## LOVELOCK SETS NEW 1,500 METERS RECORD



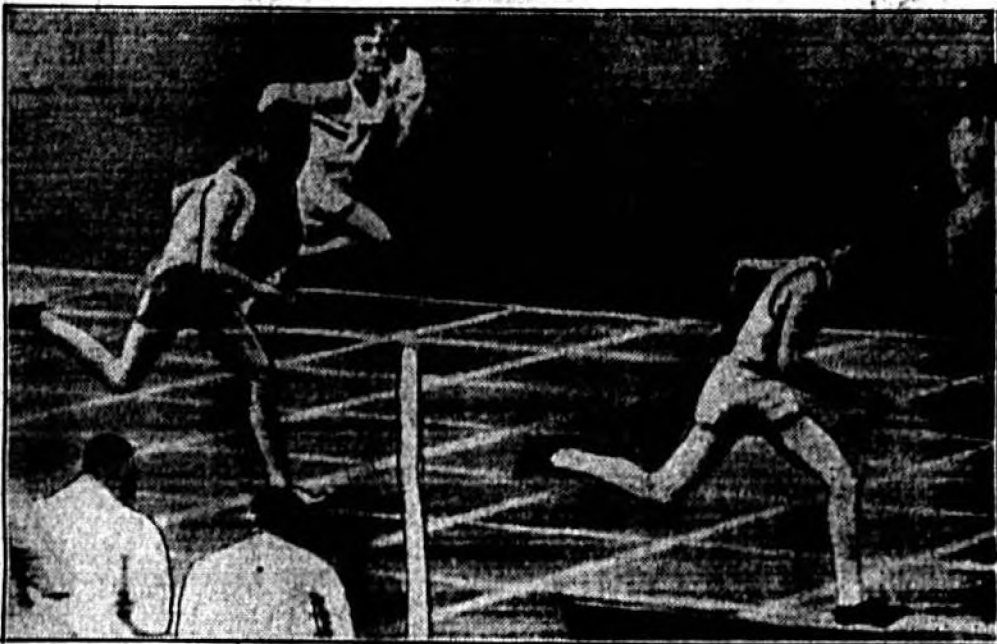

Negro Youth Confesses To Slaying Girl

All-Night Grilling Wrings Admission From Hotel Hall Boy In Asheville

ASHEVILLE, N. C., Aug. 10.—(AP)—Sheriff Laurence Brown today had announced that Martin Moore, 22-year-old negro hotel boy at a hotel here, confessed to the killing of pretty 18-year-old Helen Clevenger, New York University co-ed, early July 16.

Sheriff Brown said Moore signed a confession and re-enacted the scene in the hotel room where the young student's body was discovered that morning. He said robbery was the motive.

The officer quoted the negro as saying he first tried to gain entrance to Room 210, then Room 211 and found them both locked. He tried the door of Room 224. He said, and the door was open.

"Miss Clevenger was sitting on the bed," the sheriff quoted Moore as saying, "when I went in. Then she got up and said 'What do you want?' I told her that I thought the room was unoccupied. If you do not leave this room I will call the officer," she said and came toward me.

"I pulled a pistol from my belt and she was within 18 inches of me when she apparently first noticed the gun. She screamed and I fired. As she fell I struck her in the face with the butt of the pistol and fled."

The negro was formally charged with murder, Sheriff Brown said, and it was not decided immediately whether a special term of court would be called as the regular session meets toward the end of the month.

The sheriff said the negro was arrested Sunday night on the tip of Banks Taylor, negro pantry boy at the hotel, who was secretly detained last Thursday night for questioning. Brown said Moore was grilled all night before the confession was wrung from him.

Brown said Taylor told him Moore had recently come into possession of a pistol, which he said Moore had told him about. The sheriff said he then took Taylor to Moore's home where he was confronted with the statement regarding the pistol. Moore, at first, he said, vehemently denied it but finally said he had the pistol and led the sheriff to its hiding place beneath some plumbing under his house. The pistol, the sheriff said, was a heavy .32 calibre Spanish .22 shot automatic, fully loaded. The sheriff said the butt was stained with blood and blonde hairs clung to it. He said the hairs in the cartridges were identical with that taken from the body of the pretty hotel girl.

Miss Clevenger, who recently had come to North Carolina from her Staten Island home and was visiting in company with her uncle, Prof. W. L. Clevenger of North Carolina State College at Raleigh. Her green pajama-clad body was found sprawled on the floor of her hotel room about 8 A. M., July 16 by her uncle who called for her. A bullet had pierced her heart and lodged in her back and her face was mutilated from a severe beating.

Japs, Hollanders Lead Acquatics In Berlin Show

AMERICANS DOMINATE Springboard Diving Opening Event

BERLIN, Aug. 10.—(AP)—Swimmers from Japan and Holland, with the Nipponese carrying off most of the honors, today bested three Olympic marks as America's quarter in the men's 400-meter relay team progressed through the trials and her representatives dominated the opening of the springboard diving championship.

The women's 100-meter free style title was won by Holland's Rita Mastenbroek in a new record time of one minute, five and nine-tenths seconds. American girls, Olive McKean, Seattle, Katherine Rawls, Fort Lauderdale, kept pace the greater part of the time but faded at the end. Miss McKean finished sixth and Miss Rawls a seventh.

America's trio of 400-meter relay swimmers gave the semifinals. They are Jack Medina, Seattle, Ralph Flanagan, Miami, and John Macmillan, Philadelphia.

The first half of the springboard diving trials ended with Dick DeGower, Detroit, and Marshall Wayne, Miami, taking first and second places respectively.

The United States water polo team was defeated four and three by Belgium.

The United States won 12 of 23 first places in track and field competition now completed. It won the unofficial team title with 203 points.

Jesse Owen, Ohio State negro who won four gold medals, announced he would turn professional soon.

The International Amateur Athletic Federation approved 27 new men's track and field records, 10 of them by Americans.

Milk Products Of Sanford Are Rated Highest

Control Board Head Praises Seminole County Interests

Seminole County grade "A" dairies are producing milk second to none in the state, according to a statement made today by Henry Bryant, director of the State Milk Control Board, who attended a meeting of local dairy interests in the Court House this morning.

Mr. Bryant added that Florida ranks among the first five states in the union with regard to the quality of milk produced.

The director praised dairymen in this section for having retained a low price scale in retailing milk, despite the fact that the recent drought caused a rise in the price of feeds.

No advance in milk prices is anticipated here unless feed costs surge today with an unexpected vigor, according to Mr. Bryant.

In making suggestions of methods to prevent price rises, the director urged that housewives become "bottle conscious," that is, to make special efforts toward returning empty milk bottles.

Mr. Bryant said the dairy industry each year is forced into tremendous overhead expenditures merely because persons become careless with milk containers.

Today's meeting was called by County Farm Agent C. R. Dawson for the purpose of discussing future milk policies and to confer on violations of milk control laws.

It was announced that a Milk Control Board hearing has been called for the middle of the month in Tallahassee where it is hoped that a few small kinks in control regulations may be ironed out.

Local dairies represented at the Court House this morning were Howard Dairy, Moro's Dairy, Lee's Dairy, Baker's Dairy, Seminole Creamery, Hirock's Dairy, Biggers' Dairy, and the Stevens Dairy.

Dr. Peter S. Bay, a local physician, also attended the session.

Lawton Attending Instruction Course At Florida School

T. W. Lawton, superintendent of Seminole County schools, today is in Gainesville attending the school course for county superintendents given by the general extension division of the University of Florida.

During the four-day program, Mr. Lawton is scheduled to preside over the afternoon session Wednesday and will present an address, "Teacher Selection, Tenure and Retirement," in the morning session Tuesday.

Communities Facing Shortage Of Food, Water As Spanish War Result Spreads

Madrid Is Next Attack Target

Leftists Claim Capture Of Thirteen Revolution Cities

(By Associated Press) The capture of the town and province of Santander on the Bay of Biscay was announced by a Spanish Rebel radio station today as word filtered through that other far northern communities faced shortage of food and water as a result of Spain's civil war.

Targets of bitter attacks by both shell and rifle fire as the Rebels fought for access to the northern seaboard which would assure them more arms and ammunition, Northern Loyalist held the communities of San Sebastian, Reuter and Irun and were reported fighting doggedly for assistance.

Madrid heard that great concentrations of insurgent troops stacking arms and taking inventory south of the beleaguered bay towns are in preparation for an assault intended to wipe out every vestige of Leftist military control in the far north.

The capture of Santander, if Rebel radio report proved correct, would be a signal strategic victory for the forces attempting to overthrow Madrid Leftist rule.

A coincident with fresh insurgent claims of victory was a government announcement that the civil war is near an end. Leftists said 13 Spanish communities dominated by Rebels had been captured.

County Democratic Chairman Issues Plea To Electors

S. M. Lloyd, chairman of the Seminole County Democratic Committee, today urged all qualified voters in this county to visit the polls tomorrow and cast a ballot in the nomination of a Democratic candidate for the U. S. Senate.

"The vital necessity of using your franchise may not be apparent today or tomorrow, Mr. Lloyd said, "but you are responsible for the kind of government we have and by casting your vote you have served your country, party and state."

The chairman also urged that committee members canvass their respective precincts in an effort to draw out the largest number of voters.

Sanford's Junior Chamber of Commerce has been working consistently on a "get out and vote" campaign, one of the civic club's objectives.

Mr. Lloyd said the organization has been instrumental each election in helping to poll a large vote by using the motto, "Vote as you please, but please vote."

**Carlton's Record**

The period from 1929 to 1933 were very trying ones not only in Florida but throughout the entire country as well. Banks were failing on every hand, long established business houses were closing their doors, and bankruptcy sales were every day events. Factories were shutting down, farms were being taken over by mortgage holders and unemployment was increasing by leaps and bounds.

That was not a period when any reasonable person demanded the establishment of new world records for spectacular achievements. No business executive had a right to expect his sales manager to double, or even increase, last year's business. Most of us thought we were doing pretty well if we could stay out of bankruptcy.

It was as if a ship at sea encountered a hurricane. Some of the more naive passengers might ask the captain to prevent the boat from rolling, or to set a new speed record for the crossing anyway, or to fire the steward because a bowl of soup was spilt down a lady's neck as the ship pitched and tossed. But more seasoned sailors would be satisfied if the captain brought the ship through the storm without running on to the rocks or going to the bottom.

And so if Doyle Carlton had done nothing more than to serve at the helm of Florida's ship of state from 1929 to 1933 and steer a course through the dangerous shoals which surrounded him at that time, we would say that he had done a good job. We would not ask, "What new world's record did he establish? What monument did he build for future citizens to admire? Why didn't he do something besides just saving the State from disaster?"

At the time he took office the State was head over heels in debt in spite of the fact that it could not legally borrow money, and expenditures were averaging a million dollars a year more than all revenues from taxation. Carlton reduced operating costs by a million dollars a year and cut the State millage to 4 and 7-8, the lowest in over 30 years.

He also sponsored the constitutional amendment which resulted in the State inheritance tax. Although Carlton's administration itself got no revenue from this law, the deaths of such prominent millionaires as Alfred I. duPont resulted in the payment of some \$4,000,000 to the State during the Sholtz administration. So, many competent observers feel that Carlton not only deserves credit for saving the State during the depths of the depression, but for laying the groundwork for the accomplishments of more recent years.

As the Clermont Press says, "The State during the Carlton administration balanced the current budget, paid current obligations in full, retired boom-day debts, provided an additional \$4,000,000 per year for schools, obtained \$7,000,000 federal aid for flood control in the Everglades, and by allocating gas taxes to fixed indebtedness of the counties, wrought a saving in county ad valorem taxes of from 10 to 40 mills throughout the State."

It is for such reasons as this that The Herald believes Mr. Carlton is fully qualified and thoroughly competent to represent this State in the United States Senate and deserves the votes of Seminole County citizens in tomorrow's election.

**The Situation in Europe**

Though the nations of Europe seem to be rushing toward war in much the same manner and with much the same alignments as they did in 1914, there is one distinguishing difference. In 1914 it was the various governments themselves with all their imperialistic ambitions and the family jealousies of their reigning monarchs that were bent upon war. Today it is the masses, wrapped up in the petty prejudices of a class war.

And so we find in France, as Premier Blum concludes a seven power treaty which is to guarantee the neutrality of these European governments in connection with the revolution in Spain, and incidentally preserve the peace of Europe, cries from 100,000 citizens of "Arms for Spain" greet his announcement. The French people may want peace, but they want a radical victory in Spain even more.

And Dorothy Thompson, famous foreign correspondent, writes for the New York Herald Tribune: "The Russian government pledges non-interference, but the Russian masses parade in the Red Square; the Russian trade unions prepare to tax every Russian worker to raise a huge fund to help the Spanish Leflist government. The French government urges a pact of eight nations to promise hands off, but Frenchmen are today joining the Spanish government forces, and tomorrow other Frenchmen may be joining the Spanish Fascists.

"Britain is in the most serious dilemma, for the victory of neither side in Spain can be to the advantage of the British Empire. But meanwhile the British Trade Unions prepare to send financial aid to the Spanish Loyalists. The Trade Unions of the United States demand international peace, and one union—the Amalgamated Clothing Workers—prepares to send money to the Spanish government.

"It is a matter of the most vital concern to Russia, fearing as she does an eventual struggle with both Germany and Japan. But can the Russian government restrain the sympathies of the Russian masses, who have been taught for nearly a generation that a world struggle between communism and capitalism is inevitable? Have not Russian children been officially brought up to save their kopeks and contribute to the relief of fellow communists, suffering all over the world? Is not communism a world theory, a movement embracing the workers of the entire earth?"

"The dilemma of the French government is quite as serious. Can a government which came into power as a challenge to Fascism remain really neutral if another Fascist state threatens her on the south? What is neutrality? Can one prohibit the shipment of arms, and permit the shipment of men? Can one profess neutrality with a press which continually and bitterly takes sides? The issue: Communism, Socialism or Democracy versus Fascism: is not exclusively a Spanish domestic issue, no matter how much neutrality is preached. It is an issue everywhere in Europe today. It may be an issue here tomorrow.

"Only in the Fascist countries are the people and the government policy at one. At one that is to say, for all national purposes. If Hitler and Mussolini believe that it is desirable to force the issue now, or to allow the issue to force itself, they can do so. Inside the logic of Fascism, one can argue either way. Mussolini or Hitler can say that their governments are purely national; that what other countries do is absolutely no concern of theirs, or they can say that communism threatens to conquer the white race, and thus rally their people to a crusade. Or they can merely decide that for imperialistic purposes, now is the time to strike.

"Mussolini's interest in Spain is purely an Italian interest. It is possible that collaboration with a Spanish Fascist would win him new footing in Africa. That

(4) Quite O. K. But the Townsends could spend it faster. They are obliged.

(5) The aged that are still holding poorly paid jobs—leaving these jobs, will spend enough to help make jobs for others than the young!

(6) No. But they are being urged to accept these checks which they didn't ask for!

(7) We agree. (8) Quite true. (9) In our opinion neither of these taxes are at all hidden. They are quite noticeable. The small amount from a large number not oppressive. Big amounts from big business, naturally will be felt. Hence the opposition here!

(10) Agreed. (11) Agreed. (12) Your insurance company endowment policy would cost you \$2.00 where the transaction tax premium would cost 2 cents! A few years ago these companies gave their entire effort to selling straight policies. Today and since the Townsend Plan became a "Sure Pop" thing, these companies are trying to beat us to it selling annuity policies. A sure sign of a good thing. But they cannot do it at 2 cents on the dollar.

(13) The first part you grant. The second part you don't, because you do not seem to realize that this payment to the pensioner has nothing to do with any estimated possible average income for each man, woman and child in the country if it were distributed! The Townsend annuity is not for every man, woman and child in the country, until 60 years old.

(14) No. Additional money is not necessary. We have enough. The Pension money circulates, and the additional business done forces out other idle money so that circulation is still greater, because we are doing more business which will bring out still more idle money, and that is what we are after. By "rich" we mean that the tax comes largely from those doing big transactions, some legitimate, others on non-subsidized stocks of grains for instance, which we call gambling. Finally, as this terrible transaction tax and what you think its effect on the little folks will be, we append herewith a table of the transaction tax on a loaf of bread:

It requires a bushel of wheat to make 60 loaves of bread. It requires 60 lbs. of wheat to make a bushel. Therefore, 60 loaves of bread, retailing for \$6.00, represents one bushel of wheat for which the farmer receives \$2.50. The \$6.00 between the farmer and the consumer represents freight, handling, processing, manufacturing, advertising and retailing. We apply the tax to all these transactions—and the figures given below include all these costs—from farmer to consumer,—on 60 loaves of bread, selling at retail for \$6.00:

1st sale, farmer to local buyer one bushel wheat	\$2.50	1.25
2nd sale, local buyer to terminal market	1.50	.75
3rd sale, terminal market to miller	1.50	.75
4th sale, miller to baker	1.50	.75
5th sale, baker to wholesaler	1.50	.75
6th sale, wholesaler to retailer	1.50	.75
7th sale, retailer to consumer	1.50	.75
Total tax if passed to consumer on 60 loaves	10.50	5.25

If the compounded transaction tax totals 25 cents on 60 loaves, the amount of tax on one loaf, retailing for 10 cents, would be approximately one-half cent.

The farmer pays the freight, which is included in the original purchase (average farm price, crop year 25-34, was 58¢ per bushel, according to U. S. Dept. of Agriculture) we allow 20¢ per bushel commission for the local buyer and 10¢ commission for the terminal broker, (which allows for a period of storage; brokerage is at present fixed at one and one-half cents per bushel); we allow the miller 40 cents in addition to the millage, shorts and bran, for grinding a bushel of wheat into flour; we allow 5 cents per loaf for the cost of producing a loaf of bread in the bakery; and two cents per loaf for the retailer's profit.

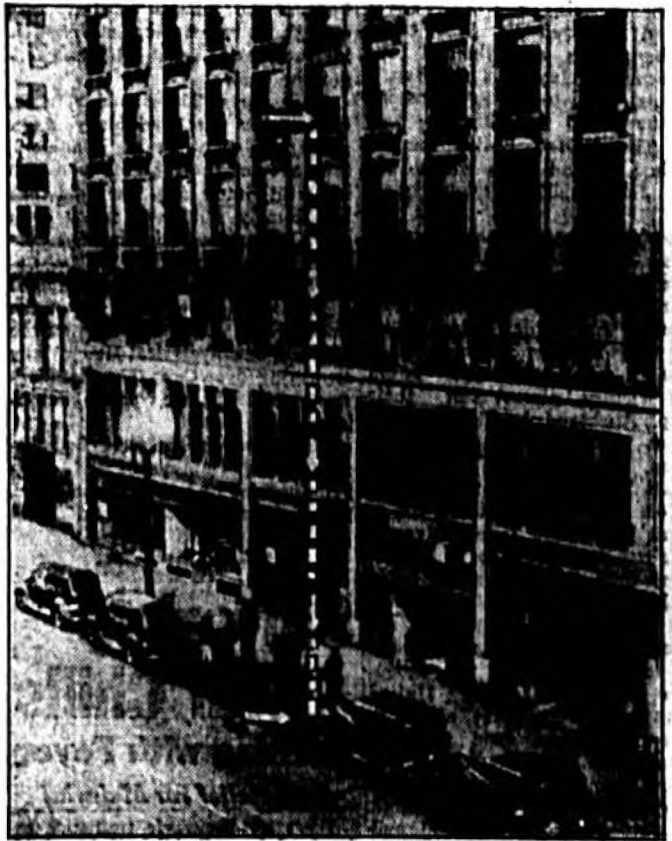
