Sharkey May Enter Arena A 2 To 1 Favorite Over Tom Heeney Next Friday Night

NEW YORK, Jan. 11.—In spite of the fact that the last seen of Jack Sharkey in these parts was in a touching agony over a ring of a late July evening, convulsed and distraught after the manner of a hummingbird that just had swallowed a boxing glove, the low down today was that the modern Demosthenes would be no worse than a 2 to 1 favorite over Tom Heeney on Friday night. No they haven't seen much of our John around here and apparently he means to have them see even less until such time as they pay \$22,500 for the privilege.

This ordinarily would be a circumstance to view with vast alarm but the sharpshooters are talking it right in stride. Their story is that they don't have to see Sharkey for this one. It seems that they have seen Heeney.

Pope Disapproves Proposed Union Of Christian Churches

ROME, Jan. 11.—(INS.)—Two Pope today issued an unexpected encyclical on the question of the union of the churches and recognized the praiseworthiness of the movement but he deplored the mixing of religion with politics.

The encyclical apparently has been prompted by the recent political discussions in Great Britain over the new Church of England Prayer Book, which has revived the movement there for a union of the branches of the Church of England with the Roman Church.

The encyclical points out that the promoting of religious union among all christians is equivalent to affirming that all religions are equally good, thus sapping the foundations of catholicism. After saying that "the religion founded by Christ is the true one, and has been, through the centuries, preserved in the Roman Apostolic Catholic Church," the encyclical adds, "it is a mistake of enthusiasts in the union movement to attempt an agreement upon fundamental points, leaving every one free upon the others."

The Herald representative visited the youth yesterday at the hospital, his greeting was cordial and friendly, "I'm having a fine time here," he said, they have been so good to me—the doctors and nurses—so fine I just feel better every time they come to see me." And Robert is a favorite with the hospital attendants and everyone who visits him.

"You can still shoot marbles but you won't be able to play baseball any more," the reporter said questioningly.

"I bet I will play 'ball too," he returned quickly.

And then upon second thought, he added, "I'm going to learn how to do everything anyone else does."

Robert is anxious to return to hospital and return to school. He is in the fifth grade and proudly proclaims, "I've made a grade a year and I sure don't want to lose out this year." He wants to go through school and then later, if possible, go to college.

"We have not engaged in a competitive building of war ships

and do not intend to do so. The cruiser tonnage of the first class light cruisers will be below the 5 to 5 ratio with Great Britain at all times during the period of construction and upon completion. The building program of this bill is not based upon the 5-5-3 ratio but will be well within that ratio as to Great Britain and only slightly above the 5 to 3 ratio with Japan unless she increases her program."

If the world should misconstrue our national purpose in this program, Wilbur concluded, it must at the same time place upon the shoulders of Great Britain the implied responsibility for resump-
