### Death Row Prisoners Win Hearing

PORT ST. JOE, Fla. (AP) — A hearing was granted for two men condemned to die for a double murder in which prisoners had confessed. The death row prisoners, Wilbert "Slingston" Lee, 30-year-old pulpwood worker of Pine Woods, and Freddie L. Pitts, 27, a Mobile, Ala., soldier, claim they had confessed under duress. St. Petersburg Circuit Court Judge Charles Halley was appointed by Gov. Claude Kirk to conduct the hearing in Port St. Joe on Sept. 23. Pitts and Lee pleaded guilty in 1963 to the slaying of two gasoline station operators, Jesse Burkett and Grover Floyd Jr.

### 'Catch Me' Killer Suspect Gives Up

PHOENIX, Ariz. (AP) — John Eriker, accused of being the "catch-me" killer of Hollywood, Fla., surrendered Sunday night to an off-duty sheriff's deputy and members of his family. Eriker, 24, a former policeman, held a .38-caliber revolver and threatened suicide as he talked for 45 minutes with Deputy Dave Koelsch and his mother, brother and sister, Koelsch said. The confrontation ended when Eriker handed the revolver to the unarmed deputy and rode off with him to the Maricopa County jail, where he was held for Florida authorities.

Eriker is charged with killing Marilyn Clark, 12, at Hollywood last month. The second degree murder charge was filed Saturday after officers with whom he formerly worked said it was his voice in a telephone call that said, "I just killed three people. I'm serious. Please catch me, please." He resigned from the force Sept. 5, and came here to visit his family. He disappeared Saturday when word reached here that he had been charged with killing the girl whose body he discovered. "I'm in trouble," Koelsch quoted him as telling his family. "I don't want you to be involved." Police found his abandoned car and, on Sunday, spotted Eriker's younger brother, Danny, near an apartment house. A down car scaled off the area, but stayed away from the apartment which Eriker rented Saturday. Koelsch, who normally works with juveniles, was advised by police to call a phone number. Police said the person who answered the number was Danny, who handed the telephone to his brother. "He told me he'd decided to commit suicide," Koelsch said of the accused. "I told him that was a bad way out. After we talked for a while he agreed to talk to me in person and told me where the apartment was."

**How Many Governments?**  
CHICAGO (AP) — U.S. government is large, but local governments manage to collect \$61 billion and spend \$49 billion of it each year, mostly for education, health care and police. House Commerce Clearing House said there are some 81,248 governments in the country. That is 10,000 fewer than the 1965 total because of a decrease in the number of school districts. Cost of education last year totaled \$32.2 billion, a 20 per cent increase from 1966. Transfers of federal government funds added \$14.6 billion to state revenues.

### Three Counties Lose Federal School Funds

TALLAHASSEE, Fla. (AP)—School Administrators in three Florida counties say the loss of some \$350,000 in federal funds for slowness in desegregation will affect some of their programs, but that they had expected to tighten their budgets.

The U.S. Office of Health, Education and Welfare said schools in the counties, Taylor, Lafayette and Baker, have been found not in compliance with the 1964 Civil Rights Act.

School officials in the counties said they had been preparing for the cutoff and did not consider the matter critical.

Taylor County School Supt. Alan E. Hart said: "I wouldn't call it a crippling blow. We'll be able to carry on all our basic programs."

Hart estimated the county could lose up to \$200,000. He had tried on the day before Friday's cutoff to get it postponed.

"Some programs will be eliminated before the end of the year," Hart said. "We're prepared somewhat for it."

Hart said desegregation is progressing in his county. He said more than 25 per cent of the Negro pupils are in previously all-white schools. He added, "We have 18 teachers assigned across racial lines."

Lafayette County lost \$42,000 in federal funds.



## Sanford Approves \$1.6 Million Budget

By a three-to-one vote, the Sanford City Commission last night approved a \$1,641,016 general operating budget for fiscal 1968-69.

Commissioners M. L. Raborn and A. L. Wilson voted "nay" and by their actions forced a second reading of the document scheduled for Sept. 23, before adoption can become official on Oct. 1.

Both commissioners had voted against the 50 cents per month garbage collection fee increase recently enacted by the city as a means of obtaining enough revenue to finance a five per cent across the board pay increase for city employees.

On this subject, Commissioner Earl Higginbotham desired the following statements be inserted in minutes of meeting: "Due to the state prohibiting city from raising millage rate after next year, we must raise our garbage service charge by 50 cents to meet our expenditures."

Higginbotham left no doubt that this action was a method used by city to get around state millage-raising law by making what would probably have been a millage increase onto a refuse pickup fee.

In a series of companion resolutions and ordinances all dealing with budget and taxes, the Commission approved: Resolution appropriating unexpended cash surplus of fiscal 1967-68;

First reading of ordinance making appropriations for 1968-69;

Ordinance determining and fixing rate of taxation and setting annual tax levy;

Resolution designating three local banks as city depositories for 1968-69;

Adopt new pay schedules and work hours, effective Oct. 1.

## Goldsboro Rec Contract Let

Manuel Builders, Inc., of Orlando, was awarded contract for construction of the Goldsboro Recreation Center by action of the Sanford City Commission last night.

The Orange County firm submitted the lowest of three bids and was given 105 days to complete the facility after the \$76,086 estimate was accepted.

Two other bidders were Harvey Spears Construction Company at \$80,000 and Shoemaker Construction Company at \$81,000.

Bids were tabulated in the office of John A. Burton IV, architect for the facility. Sheriff Peter D. Millitt, District 4 Peace Justice Agent, was present.

City Manager Warren E. Knowles got with property owners in an area near the Seminole High School in an attempt to annex property now contiguous with city limits.

Action along this line was touched off by an annexation request from Phillip Zank, a property owner in the affected area, who desires to construct an apartment unit. Commissioner M. L. Raborn visited the request at the "key" to city's southward growth.

## Port's Bid Forwarded

Application of the Seminole County Port Authority for a \$650,000 grant has been forwarded by the Economic Development Administration's regional office at Huntsville, Ala., to Washington headquarters.

The grant plus a \$900,000 loan from the Office of Housing and Urban Development (HUD) will authorize the port to build the Port of Sanford on the St. Johns River, Roumlat said.

## In Detention Of Young Mar Grand Jury Probe Asked

### Youth Jailed 5 Months Bulletin!



Sheriff Peter Millitt had this afternoon confirmed he had made a noon telephone call to state attorney's office requesting immediate grand jury investigation into charges made today before County Commission.

Grand jury probe into the apparent "illegal imprisonment" of John Burgess Jr. in the county jail for some five months was requested by the Board of County Commissioners today and Sheriff Peter Millitt.

Commissioner W. Lawrence Swofford joined by Commissioner Edward Yarborough initiated the action to determine the official responsible for the youth being held for the extended period though charges against him had been dismissed.

Agencies requested investigated by the Commission are the office of Sheriff Peter D. Millitt, District 4 Peace Justice Agent, and Public Defender Thomas Spaw.

Commissioner Chairman John Alexander in agreeing to the resolution, unanimously adopted by the board asking for the probe, said the case is a "point of public interest."

The incident first came to light when a representative from "After Care" state institution service for youths on probation, discovered the situation in a check of county jail for former inmates from Martinsburg Boys' School.

Burgess was arrested by Sanford police officers March 6 and charged with larceny of a radio. When the 18-year-old Sanford youth appeared before Peace Justice Davis, the charges were dismissed and he was ordered released due to failure of the accusing party to appear.

The "After Care" agent is reported to have contacted Davis' office and determined that Burgess should have been released five months previously.

At that time, Millitt said he later received a copy of the release with an April 18 date and released the prisoner Aug. 19. Millitt said the situation was regrettable but "We have to depend on the judges being accurate."

Public Defender Spaw was assigned to the case on July 29 almost three weeks before the (Continued on Page 2A, Col. 7)

## Whipping Case Report Asked

Sheriff Peter Millitt was asked to come before the County Commission today to "explain or deny" failure of his department to take action against the persons responsible for the alleged beating, whipping or attempted murder" of 18-year-old McNeil Simmons of Winwood Park.

Commissioner W. Lawrence Swofford, who first asked for a grand jury investigation into the matter said to have happened in June, later amended his motion to permit the sheriff to explain the incident.

Swofford said the youth was beaten beyond recognition with a machete or hatchet near the Negro community east of Altamonte Springs. "The people are quite concerned that no action has been taken," the district three County Commissioner said.

The victim is reported to have left the state on advice of the sheriff's department, Swofford declared. "I understand armed persons are regularly patrolling the neighborhood looking for the 'right man,'" the Commissioner said, explaining that the assailants of the 18-year-old Simmons youth had apparently mistaken him for another. "It is a dangerous situation."

Volusia County voters are going to the polls today in a special Democratic primary to name nominee for the office of county tax collector to succeed the late Mr. Geremia S. Paul. Runoff primary will be Oct. 1.

Candidates are County Commission Chairman Jim Dumas, Gray Williams, a former District 3 county commissioner; Constable Irving Weiss Jr., Lester Smith, Deputy Clerk of the circuit court, and Earl Pounds, former special investigator for State Attorney Anthony Greik.

Winner in the Oct. 1 primary will face Mrs. Dorothy M. Mills, Republican nominee who has been appointed by Governor Claude Kirk to fill three deaths and did millions of pounds worth of damage.
