Dern Mum On Return To Capitol From State

WASHINGTON, Apr. 5—(AP)— Secretary of War Dern returned to Washington yesterday from a week's inspection of Army engineering projects in Florida.

On his trip Dern spent most of his time going over the proposed routes of the Trans-Florida ship canal, but would make no statement concerning his attitude toward federal construction of the canal, or the proposed routes.

Dern will make a report on his personal inspection of the proposed project to President Roosevelt after the President's return from his Florida fishing trip. He will not, however, make any announcement now of what his recommendations may be.

More Auto Tags Sold To Date Than In 1933

TALLAHASSEE, Apr. 5—(AP)— Automobile license tag sales for this year already have passed the sales for the entire year of 1933.

The motor vehicle department yesterday announced its sales to date totaled 294,023 tags, against 265,523 for all of 1933.

New automobiles sold during this year will require new tags, as will cars brought into the state by persons who establish residences here. The tags will cost the same as for a full year, if they are bought prior to July 1. After July 1, half-year tags are sold.

Receipts from tags this year are \$1,000,000 less than last year, because of decreased prices for the plates. Total collections to date, the department said, are \$3,659,521, against \$4,023,200 for all of 1933.
