## Peruvians Will Make No Reference To Kellogg's Tacna-Arica Peace Plan

BUENOS Aires, Dec. 18.—(AP)—La Nacion's correspondent at La Paz, Bolivia, hears that the Peruvian reply to Secretary Kellogg's proposal in the Chilean-Peruvian controversy over Tacna and Arica will avoid any reference to the transfer of the provinces to Bolivia, as suggested by Mr. Kellogg.

It will urge a statement from the arbitrator, President Coolidge, regarding the report made by Major General William Lassiter as chairman of the Tacna-Arica

plebiscitary commission last June in which he declared a plebiscite impossible under existing conditions. The reply will maintain, the correspondent understands, that a solution through negotiations should only if it is impracticable to hold a plebiscite. Secretary Kellogg's memorandum to Chile and Peru Nov. 30 emphasized the "utility of attempting further to adjust the trouble by diplomacy or arbitration and urged that the disputed provinces cede to Bolivia.

## ENGLISH ENVOY IN CHINA GOES BACK TO PEKIN

### British Minister Confers At Length With Foreign Head Regarding Rise To Power Of Cantonese Government

### Definite Agreement Was Not Expected

### Missionaries Say In Report

LONDON, Dec. 18.—(AP)—Official advices were received today that the British minister to China, who has been holding conferences at Hankow with Eugene Chen, foreign minister of the Cantonese government, started for his post in Peking last night.

It was expected his conversations with Chen on the problems brought up by the recent rise of Cantonese power, will be resumed at an early date.

It was stated that the conversations between the British official and Foreign Minister Chen were explanatory in character, that no definite agreement was expected and that none was made. It is noted, however, that an exchange of views will be most valuable to the British position in China.

The foreign office also made clear that the dispatch of eight destroyers and one cruiser from Madras to China yesterday, merely brings the British naval forces in Chinese waters to normal strength.

The Baptist mission in Peking received a letter dated Monday, Nov. 18, from the British Mission, Clement Stockley, telling of conditions in the city and stating that foreigners could hold out for only a short time if allowed to keep the hotel food they had.

### MARX CABINET TO REMAIN IN OFFICE OVER CHRISTMAS

### German Reichstag Adjourns Until January 19 Following Attack On Chancellor And His Subsequent Defeat

BERLIN, Dec. 18.—(AP)—Indications are that the cabinet of Chancellor Marx, which resigned yesterday after a defeat in the Reichstag, will continue to guide affairs of state until the holidays are over. After passing the social Democrat motion of non-confidence, 249 to 171, the Reichstag adjourned until Jan. 19, and many members left the capitol to be with their families for Christmas.

The cabinet fell before an unnatural alliance between the left socialists and right nationalist factions, either of which group outnumbered any government party. The motion on which the vote was taken was introduced by Philipp Scheidemann, social Democratic leader, and was supported by the nationalities, communists and fascists.

Scheidemann, in opening his attack on Thursday, charged that rmas and rplnes were manufactured and hoarded in Russia for Germany through the functioning of a secret fund. This was denied by Chancellor Marx.

The cabinet, presenting its resignation to President Von Hindenburg last evening, was requested to continue in office pending the formation of a new ministry. Customary procedure would be to ask the socialists to form a government, they being the party responsible for the cabinet's defeat, but the nationalist leaders say the President was deeply hurt by socialist charges of irregularity in the administration of the defense forces.

use of proper fertilizers affords higher yields per acre at less cost and with less work, at the same time opening up much of their acreage to other plants.

The South Carolina Experiment Station has demonstrated that by the adequate use of chemical plant food alone a saving of over \$42 a bale in the production of cotton can be obtained, Brand reports.

The same is true with potato growing. In a recent demonstration in California, a 10-acre field adequately fertilized produced an average of 1,000 bushels of potatoes an acre.

Diversification of crops may not be the proper solution for a situation such as cotton got into this year, says Brand. For, he points out, although the southeastern states devote only 40 per cent of their tilled lands to cotton, they derive almost 61 per cent of their income from it.

With cotton the economical crop for the south, he intimates, and fertilizers costing less comparatively than other necessities, it would seem that one could help the other toward a more profitable basis.

USE OWN PRODUCE  
In many states farmers are finding that they receive from 70 to 100 per cent more for their crops by feeding them to livestock than they would if they sold the harvested crop.

That farm profits can be materially increased by the application of machinery and new methods is the conclusion of the advisory council appointed by Secretary Jardine, in connection with the Department of Agriculture's study of mechanical farm equipment.

**Experiment Station Cattle Herd Helps Dairying Industry**

The low average production of Florida dairy cows can be charged to a very large extent to the fact that too many of these dairy cows have been sired by bulls with little or no production behind them. In other words, too many people have bought bulls for service with no other thought in view than that of having fresh cows.

Bulls with the ability to transmit high production to their daughters will increase average production of cows in this state quicker and more surely than it can be increased in any other way, says John M. Scott, animal industrialist of the Florida Agricultural Experiment Station.

The herd of dairy cattle at the experiment station was established about 20 years ago for the purpose of demonstrating the fact that good dairy cows could be developed in Florida; that the agricultural student might have the opportunity of instruction along dairy lines, especially the chance to study types and families of dairy cattle; and to make available experimental work in breeding and management of a dairy herd. It has been functioning along these lines since its establishment. However, it has

been of service to the state in a much larger and perhaps less appreciated degree. By this we mean it has been of direct service to many of our dairymen. Young breeding stock, especially bulls, have been offered to breeders at very attractive prices, thus making available to these men higher class sires than were ordinarily for sale.

Today there are many bulls in service in all sections of the state that came from the Station herd.

Butter standardization is considered one of the major problems of the Oregon dairy industry. Considerable research work is being undertaken to develop a sweet cream supply and determine the best manufacturing process.

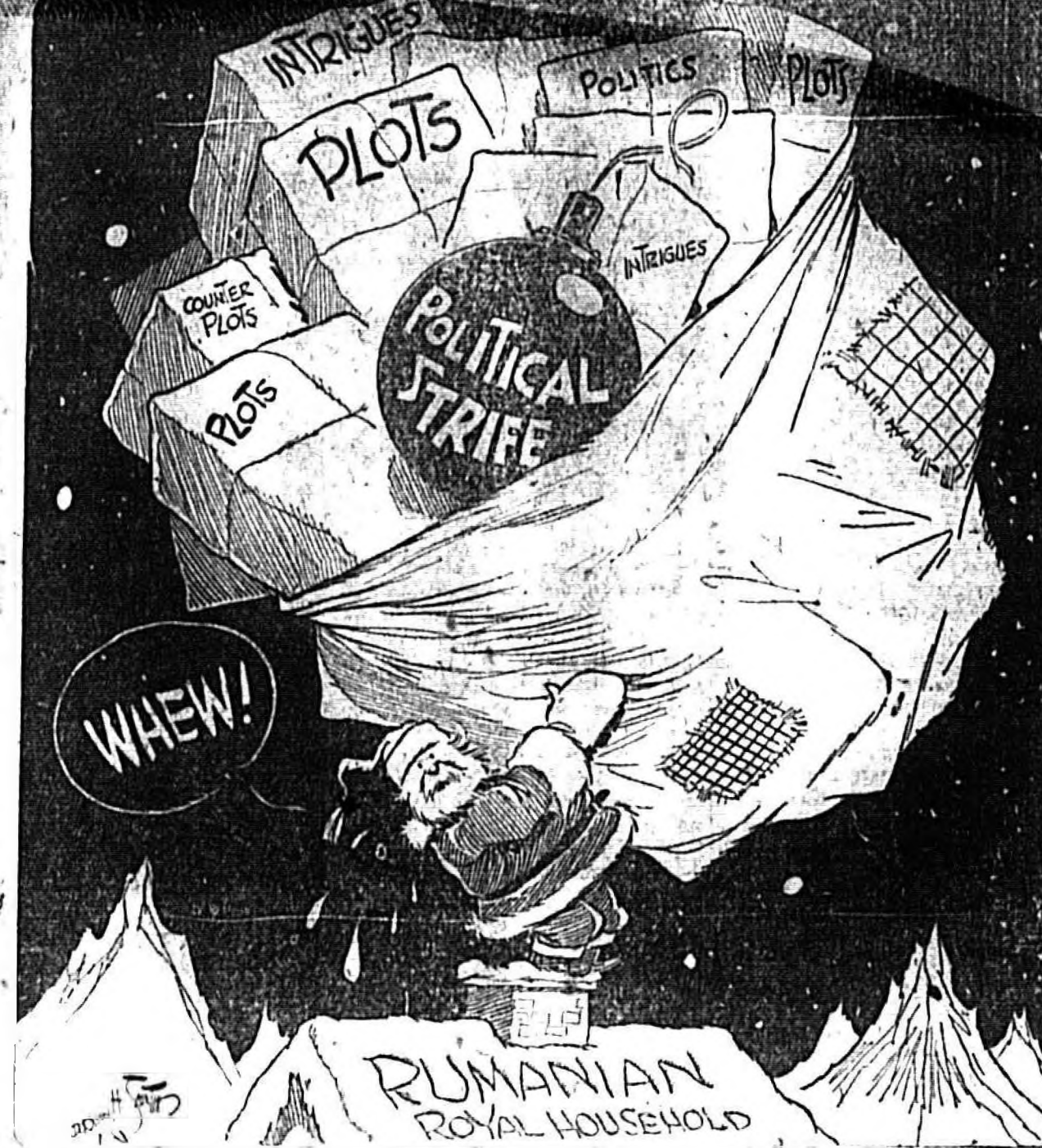

# East Coast Canal Would Give "Inside Route" From Great Lakes To Florida

JACKSONVILLE, Fla., Dec. 12. (P)—Adoption by the United States government of the Florida East Coast canal as a federal project, proposed in Congress by Senator Duncan U. Fletcher of Florida, will provide an "inside route" from both Great Lakes points and New York, to the tip of the Florida keys, all over fully maintained waterways.

"The whole route will have only about 180 miles of navigation without protection from the sea," said Col. Mark Brooke, district U. S. engineer here, said.

"That short outside passage is between Beaufort, North Carolina, and Winyah, South Carolina. Even if that strip of the route there is potential protection in coasts along the coast where craft can seek a lee of being caught out by a heavier weather than they can handle."

The inside route already is possible for craft of shallow draft, but addition of the Florida canal to the system would enable much better vessels to negotiate the passage than can do so under present conditions, the engineer said.

Col. Brooke told of seeing a through boat in the lower reaches of the canal on a recent inspection tour over the southern part of the state.

"But it was rather a small boat," he explained, "probably of not more than three and a half feet draft. As the Florida route now stands, under private ownership, little larger boats can make the passage, as the charter of the holders of the canal calls only for five feet of water in the channel." Specifications for the government project, given approval this week in the report of General Judson Wain, chief of government engineers, to Congress, call for a 75 foot channel, eight feet deep.

Only about twenty five per cent, perhaps less, of the Florida system is artificial, Col. Brooke said. The rest of the route traverses rivers and the sea behind protecting keys.

From New York the inside route of which the Florida East Coast canal forms a part, leads:

From New York to Trenton, N. J., by the Delaware and Raritan canal.

From Trenton to Delaware City on the Delaware River.

From Delaware City to the Chesapeake and Delaware canal into Albemarle Sound on the Albemarle and Chesapeake canal.

Down Albemarle Sound to Beaufort, N. C.

Thence into the 180 mile outside passage and down the coast behind the keys to the Jacksonville and into the Florida East Coast canal system.

"Almost any type of pleasure craft could negotiate the whole passage without going outside, if the Florida project is adopted and carried through," Col. Brooke said, "as well as commercial freight carriers which could operate with a greater degree of safety and efficiency, as well as closer to their sources of revenue, by the inland waterway route."

Yacht clubs are expected to interest themselves in the project as an aid in making Florida water more easily accessible from northern centers, as well as commercial organizations.
