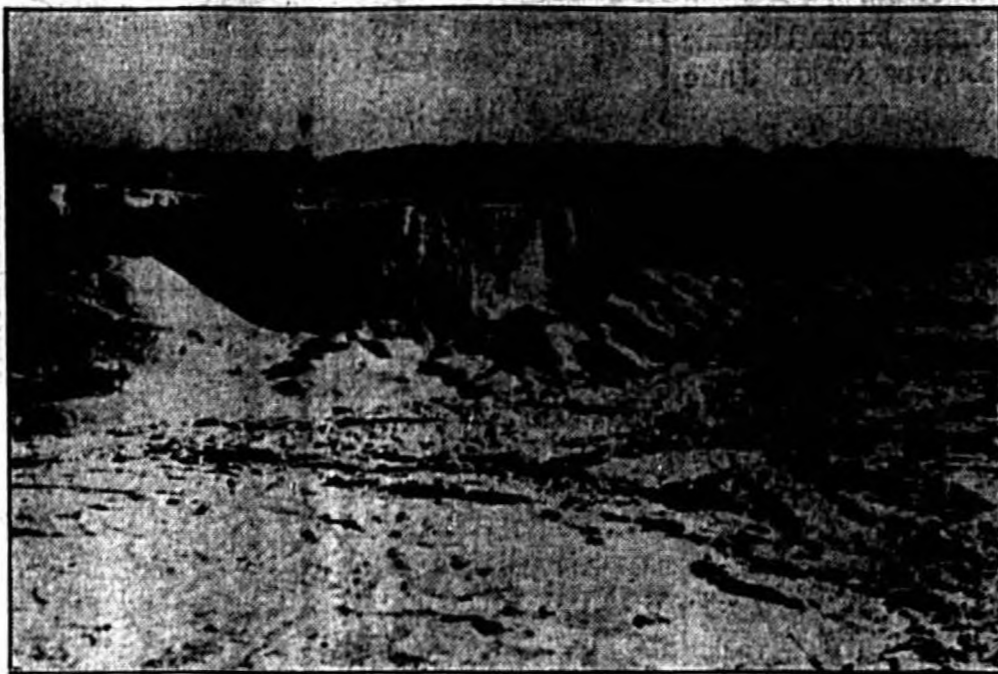

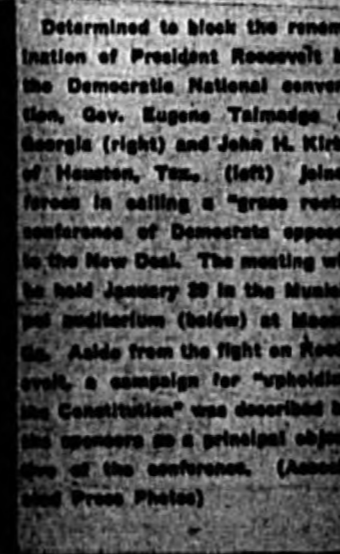

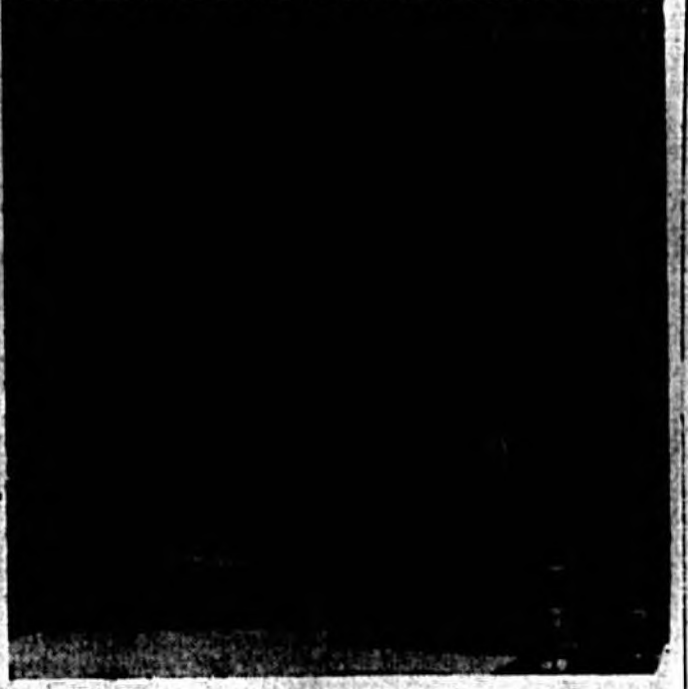

## Frost Danger In Florida Is Believed Past

### Crops Not Harmed By Cold; Below Zero Weather Continues Through The North

LAKELAND, Jan. 29.—(AP)—Meteorologist E. S. Ellison of the government frost warning bureau said today there is no danger of freezing temperatures or frost for the citrus and truck region tonight or tomorrow.

Today's sun fought through the clouds to bring Florida warmer weather after two nights of cold winds and low temperatures. There were no reports of crop damages. A fall of sleet was detected this morning in Tallahassee, but it melted as it touched the ground.

Valdosta, Ga., reported snow flurries. Warmer temperatures prevailed as far north as the Ohio River today, but snow fell over a wide area. The weather turned colder in the Rocky Mountain states whence come the nation's blizzards. Kansas, Nebraska, Iowa and South Dakota were colder. The sub-zero area extended south almost to Kansas City.

The Great Lakes region had snow flurries, but generally clear weather extended over most of New England.

## Jax Votes \$12,000 Canal Lobby Fund After Stiff Fight

### Council Members Declare That It Is "Waste Of Money"

JACKSONVILLE, Jan. 29.—Proponents of the cross-state ship canal last night overrode stubborn opposition to secure enactment of an appropriation of \$12,000 in the City Council for promotion of the waterway.

Opposition to the canal appropriation was as unexpected as it was vigorous. Leading the fight was Councilman Fuller Warren, who insisted the expenditure would be a "waste of money."

Others who joined him included Lee M. Booth and Wilbur D. Jobe. Joining the trio were six others, who made up a total of nine votes cast against the appropriation. The total vote was 13 to 9. Besides Warren, Booth and Jobe, dissenting votes were cast by Councilmen Boyd, Miles, McCall, Farmer, Ross and Sweet.

The voice of Mayor Alsop, lifted in vigorous defense of the canal and the President, probably had a marked effect in influencing the Council to vote favorably for the appropriation.

Warren, in a lengthy talk, said "looks like we are carrying this thing too far." He described the \$12,000, already appropriated by the city, as a "slush fund," and said it had been thrown in a "rat hole."

The councilman said to appropriate more money would be like "pursuing a phantom," and added that Florida's delegation in Congress "does not seem able to do anything for us."

He expressed doubt that the canal would ever be completed, and offered to row the first baton. (Continued On Page Two)

County Agent C. R. Dawson stated that among the plots are 14 different fertilizer combinations, showing the value of the so-called raw slimes, and there are also plots regarding the various diseases, blights and time of application.

The cost of production of this entry will be announced and this should prove interesting, Mr. Dawson said.

## Robinson Denounces Smith As Turncoat Deserting To Opposing Party Under Fire

### Senate Probe Of New Deal Critics Being Considered

WASHINGTON, Jan. 29.—(AP)—An inquiry to determine "who truthfully contributed" to the American Liberty League and six other organizations which have been critical of the New Deal is revealed by the Senate lobby committee.

A committee questionnaire was addressed to several hundred individuals and corporations. It was prepared, committee men said, long before Alfred E. Smith's anti-Administration league speech Saturday night. Through it, the investigators sought particularly to find whether there have been any "dummy" donors.

Chairman Black (D. Ala.) refused to discuss the purpose of the inquiry except to emphasize it was far from an attempt to persecute Smith.

Other members said the aim was to ascertain if, as in the campaign against the utility holding company regulation act, contributions have been made to the private organizations by individuals using knowingly or unwittingly as "dummies" to indicate mass opposition or favor on a particular question.

Investigators denied a copy had gone to former Governor Smith.

They also said an effort would be made to determine if any of the organizations had run a part of the corrupt practices act in failing to report political contributions to Congress.

The Liberty League recently reported it had received \$482,275 in loans and contributions and had spent \$389,971 in salaries, traveling and office expenses. The Delaware duPonts were listed as heavy contributors.

Those receiving the questionnaire were asked particularly if they had contributed to the league, the Crusaders, the Crusaders National Organization, Inc., Sentinels of the Republic, New York State Economic Council, American Federation of Utility Investors, Inc., now known as the American Federation of Investors, and the American Taxpayers League.

They also were asked: "Have you been reimbursed in any amount by any individual or organization for any contribution made?"

Black will not say when he intends to resume the lobby inquiry.

## W. W. Wilson Dies In Hospital In Orlando

W. W. Wilson, 84, father of James Wilson of Chuluota, operator of farms in the Chuluota and Oviedo sections, died yesterday in an Orlando hospital. Funeral services will be conducted at 11 o'clock tomorrow morning from the Carey Hand Funeral Home in Orlando.

Mr. Wilson came to Seminole County about 15 years ago from Pennsylvania, where he was a coal operator for many years. Another son, Dr. Dwight Wilson, resides in Pittsburgh. He is also survived by his widow.

## Flower Sale On Streets Saturday To Raise Fund For Publications For Blind

An appeal to citizens of Sanford will be made Saturday by the American Brotherhood for the Blind through the sale of flowers on the streets, under permission granted by the City Commission. Contributions received will be used by the Brotherhood's various Braille publications that are given to the blind without charge.

Headquarters for the flower sale will be at the Valdez Hotel with Miss Lucie's Bels in charge. The committee sponsoring the affair includes the Rev. W. F. Brooks, Jr., Mrs. Stella P. Arrington, Mrs. J. C. Mitchell, Mrs. Walter Cooper, the Rev. Martin Bram and members of the Lions Club.

Directors of the flower sale stated that the American Brotherhood for the Blind is supported entirely by voluntary contributions, and through the flower sales it has published more than 10,000 volumes in Braille during the last years and has placed them free in libraries and elsewhere among the blind. The Brotherhood also publishes the "All Story Braille Magazine," the only fiction magazine made in the United States for the blind. It circulates without cost to sightless readers in every state and in 17 foreign countries.

At the request of the Veterans Administration, Washington, it is being sent to blind veterans throughout the country.

## Farm Subsidy Bill Reported To U.S. Senate

### Measure To Replace AAA Is Merely Reported But Without Okch. Of Committee

WASHINGTON, Jan. 29.—(AP)—Burdened with constitutional doubts and threatened with inflationary attacks, Administration soil-conservation subsidy plan for replacing the AAA was ordered reported to the Senate today by its agricultural committee. The vote was 18 to two.

Chairman Smith of South Carolina expressed "grave doubts" as to the measure's constitutionality and said he and several others of the 19 on the affirmative side voted merely to report it instead of favorably reporting it.

Smith said the committee meets tomorrow to decide whether to include in its report, but not in the bill, the argument by Senator Thomas of Oklahoma for more and cheaper money to keep up farm prices. Smith, an advocate of inflation, said: "I don't think this will be included in the report."

## Doubt If Bill Is Constitutional

The President let it be known that due to the effect on the Treasury of bonus payment had the invalidation of AAA's processing taxes the Administration is studying the whole situation to determine whether any levies are necessary.

## More Storm Dead Are Discovered On Florida Keys

TAVERNIER, Jan. 29.—(AP)—Nearly five months have passed since a hurricane wind and water ravaged the low-lying coral keys south of here, yet the awful hunt for the dead goes on—with 29 bodies found this month.

Four were taken from the tangle of tenuous mangrove roots on Lignumvitae Key yesterday, while the fifth, mummified by the sun, was lowered from a treacherous wave had plied the victim with a railroad cross-tie.

Twenty-three other bodies, including those of half-dozen children and several women, were found Jan. 9 after wearisome examination of great heaps of storm debris on the west side of Upper Matecumbe.

At least 450 persons perished, directly from the Labor Day storm that swept Upper and Lower Matecumbe, wiping out civilian settlements and three camps of World War veterans engaged in building a bridge.

## Terms In Prison Are Meted Out To Liner's Officers

NEW YORK, Jan. 28.—(AP)—Federal Judge Murray Hubert sentenced Eden S. Abbott, chief engineer of the liner *Neve Castle*, to four years in prison and William F. Warren, acting captain, to two years. They were convicted of criminal negligence in connection with the sinking of the ship Sept. 8, 1934, with a loss of 194 lives.

Henry E. Cabot, vice president of the New York and Cuba Mail Steamship company, operators of the liner, was given a suspended sentence of one year, and fined \$10,000.

Judge Hubert vigorously criticized all the defendants, but said: "My regret," he said, "is that they stood before him in the face of the fact that the company is a corporation and the statute provides only a limited sentence to them."

## TWO PILOTS KILLED
