PROHIBITION OFFICERS RAID ROOM JUST ABOVE SUPERIORS IN ESTHETIC BOSTON TOWN

Governor and State Prohibition Head Were at Banquet

DINNER GUESTS

WERE IN ROOM WHERE LIQUOR WAS SEIZED AND TABLES FILLED WITH BOOZE

(By The Associated Press) BOSTON, Dec. 21.—Prohibition officers raided a room in the Quincy House last night directly above the room where Governor Cox, of Massachusetts, was being entertained at dinner of Republican leaders and seized twenty bottles of cocktails, and four bottles of whiskey. State Prohibition Director Potter was present at dinner. According to officers, several of the dinner guests were in the room where the liquor was found. Officers said when they entered the room they found in addition to liquor two long tables on which were two hundred whiskey glasses, twelve empty whiskey bottles and sixteen empty water bottles.

(By The Associated Press) CLEARWATER, Dec. 21.—Authorities today planned to exhume the body of Eston Durrance killed Saturday night at a dance near Safety Harbor in an effort to prove the size of bullets the same as those contained in a pistol said to have belonged to Carter Pierson. An examination of the body of Mrs. Robert Pierson, sister-in-law of Pierson, also killed, showed she died from a wound from the bullet the same calibre as the weapon said to have been used by Pierson.

Bishop, of this city, was seriously injured this morning when a bullet from a small rifle being used by two boys entered the window, struck the back and glanced off, penetrated her forehead. Although suffering intense pain she entered her automobile and drove down town to her husband. She will be taken to Jacksonville this afternoon for immediate operation.

CUT FEDERAL DISCOUNT

ATLANTA, Dec. 21.—A reduction in the interest rate on all classes of paper from 5 1/2 per cent to 5 per cent, was announced today by M. B. Wellborn, governor of the Sixth Federal Reserve Bank.

GOVERNMENT IS LOSING BILLION DOLLARS A YEAR

WASHINGTON, Dec. 20.—Modification of the national prohibition amendment to permit the sale of beer and wine would mean an addition to the government's revenue of half a billion dollars a year, high treasury officials said today. Estimates made in connection with the proposed legislation to legalize the sale of beer and wine have revealed, officials said, that \$500,000,000 yearly would be collected in taxes from this source.

WOMEN VOTERS WILL FORM COUNTY LEAGUE

SEMINOLE COUNTY WOMEN TO MEET HERE DECEMBER 28TH

At the urgent request of the state officers of the League of Women Voters, a call has gone forth to the women of Seminole County to attend a meeting on Friday, December 30th at 2:30 p. m. at the Court House in Sanford, to consider the feasibility and wisdom of forming a league in this county.

This is an organization absolutely non-partisan, which has become national in scope, and which is now being formed in the various counties of Florida. Its slogan is "Better Schools, Better Children, Better Citizens."

The object of county organization would be to study the conditions and needs of our public schools especially, and the moral and physical environment of our children, and youth, and to take such action as might seem wise to correct any lack of proper conditions that might appear. It is a program which must make its appeal to every woman, and which cannot be answered save by concerted action.

The annual meeting of the State League, of which Mrs. J. B. O'Hara, of Lake Worth, is chairman, occurs in Jacksonville on January 6th and the call is made now for Seminole county to decide her position before that event.

On behalf of a group of interested local women and at their request, representative women throughout the county have been invited to take the lead in their communities by Mrs. W. F. Blackman, of Lake Monroe, and to bring the women together for this conference.

ANTI-LYNCHING BILL LAID OVER UNTIL AFTER XMAS, HOUSE LEADERS AGREE

Democrats Hide Out And Congress Was Quorumless for Two Hours

WASHINGTON, Dec. 21.—An agreement to postpone consideration of the Dyer anti-lynching bill until after the Christmas recess was reached late yesterday by house leaders after several hours of ineffectual efforts to maintain a quorum.

Opponents of the measure blocked efforts to begin debate by an effective filibuster. For several hours business was suspended through lack of a quorum.

Under a resolution adopted Monday night after a spirited fight the bill had right of way with the understanding it was not to be pressed to final vote before congress suspended activities for the holidays.

When Chairman Volstead of the judiciary committee, which favorably reported the bill, attempted yesterday to call it up, Representative Garrett, Tennessee, Democratic leader, forced one roll call after another, each taking up nearly half an hour's time. When a roll call finally showed less than half of the house membership

present, Mr. Garrett made a point of order that a quorum was not present and Speaker Gillett instructed the sergeant-at-arms to round up absent members.

Declaring that less than half a dozen Democrats were on the floor the speaker charged they were attempting to obstruct the bill.

Ten deputies attempted to locate absentees, 30 of whom were needed on the floor before the House could transact business. After a two hour session with little prospect that absent Democrats would appear to provide a quorum, Representative Mondell, Republican leader, agreed in conference with Mr. Garrett to delay beginning of debate of the Dyer proposal until after the recess.

With a compromise agreed to enough Democrats trailed back into the House chamber to furnish a quorum when the anti-lynching bill was read by a clerk and the House adjourned to take up a variety of other legislation until the recess begins.

WATSON'S PROOF DIFFICULT TO MAKE ANY SHOWING —NO EYE WITNESSES

Six Former Soldiers Tell of Alleged Executions But No Evidence

WASHINGTON, Dec. 21.—None of the six witnesses appearing yesterday before a senate committee was able to give first hand evidence to support charges by Senator Watson, Democrat, Georgia, that American soldiers had been hanged without trial in France. George H. Taylor, of Philadelphia, thin and frail and under treatment, as he himself explained, for epilepsy, declared he had seen twelve soldiers hanged, or one more than the number officially listed by the war department as executed in accordance with court martial verdicts, approved by General Pershing. Taylor, confused as to the number of victims, testified at first he had seen three, and then under direct questioning, increased his figures to four, jumping finally to twelve. All of these, he declared, were put to death in and around Is-Sur-Tille in the period from April to June, 1919.

In no instance could the witness say he knew whether any or all of them had been tried by a military court.

Because of the evident physical weakness of the witness, Senator Watson suggested that army officers, including Colonel Walter Bethel, assistant judge advocate general, retire from the room, explaining that Taylor was subject to epileptic attacks and that the presence of officers might disturb him. But the former soldier announced he wanted the officers to remain.

BRITISH DELEGATION CANCEL RESERVATIONS ON STEAMER —CANNOT LEAVE FOR HOME

Members Think But Little Chance Being Able to Leave Now

SERIOUS PROBLEMS

REGARDING ABOLITION OF SUB-MARINES AND THE DEMANDS OF FRANCE

(By The Associated Press)

WASHINGTON, Dec. 21.—The British delegation to the arms conference today cancelled their reservations they had made on a steamer sailing from New York December 31. It was stated that members of the delegation think there is little chance of their being able to leave before the middle of January.

The British delegation is said to feel the action of the Japanese delegates in calling upon Tokio for further instructions in regard to Shantung would involve considerable delay in settlement of that question.

WASHINGTON, Dec. 21.—The acceptance by France with reservations of the American proposal of 175,000 tons in capital ships each for France and Italy swept the arms conference forward last night to its next major problem—the submarine issue. Italy, it was stated officially already has accepted the 175,000 ton figure, conditional only on its acceptance by France.

Formal announcement of French acceptance and details of French reservations apparently were reserved by the sub-committee of fifteen for the full naval committee of the naval committee of the conference. The sub-committee did break its silence sufficiently, however, to publish the messages exchanged by Secretary Hughes and Premier Briand which led up to the action of the French delegation. The messages were read and discussed by the subcommittee but the official communiqué disclosed no more than the texts of the telegrams.

DAIL DEFERS RATIFICATION AGREEMENT

FINAL ACTION IS NOT EXPECTED BEFORE CHRISTMAS

DUBLIN, Dec. 21.—The Dail Eireann today entered the third day of its public discussion of the Irish peace treaty with the outcome of a vote on the question of ratification still in doubt. Claims of opposing factions rang from majority or two against treaty to ten in its favor.

Opposition to referring Anglo-Irish treaty to Irish electorate was voiced by George Duffy, one of its negotiators, in his argument for ratification of the pact delivered in this morning's session of the Dail Eireann. He opposed this course because plebiscite campaign, he asserted, would rend the country from one end to the other.

DUBLIN, Dec. 21.—At the close of yesterday's session of the Dail Eireann it was clear that a decision on the treaty would not be taken before Thursday afternoon at the earliest. Some of the members were even of the opinion that adjournment over the Christmas holidays may be necessary, among them Michael Collins.

The trend of sentiment in the parliament is eagerly watched, and observers present throughout the day's proceedings were of the opinion last night that the prospects of ratification have improved. One speaker sharply criticized the attitude of some of the members suggesting that though they would vote against the treaty they really hoped it would be approved.

"And I regard Lenin," he continued "as one of the two or three great intellects uncovered by the war. I may say, too, that the government there is better than the Czar's government. It has potentialities and possibilities."

TRAMMELL WANTS MORE FARMERS' AID

WOULD PROVIDE \$50,000,000 ADDITIONAL THROUGH FEDERAL BANKS

WASHINGTON, Dec. 21.—(Special) Senator Trammell today introduced two bills of great importance. One of his measures provides for an additional fund of \$50,000,000 a year for loans to farmers through the federal farm land banks. Senator Trammell says thousands of farmers at present are denied long-time loans from the federal land banks because the funds are not available.

His other bill provides for the War Finance Corporation to have authority to make advances and loans to farmers and cattlemen through banks until July 1, 1923, instead of having this relief to the agricultural interests terminated in 1922, as provided by the present law.

Under the law which Senator Trammell seeks to have extended for one year longer the citrus fruit and cattle industry have had advances of large sums made to them through Florida banks by the War Finance Corporation. With the law extended for one year beyond the present life of Florida will no doubt receive further substantial aid.

SEN. FLETCHER SAYS TREASURY DEPARTMENT HAMPERS AGRICULTURE

WASHINGTON, Dec. 21.—Control of the treasury department over the affairs of the farm loan board has resulted in defeating the aim of legislation enacted for the purpose of aiding the farmers of the country, Senator Fletcher, Democrat, Florida, charged today. While the farmers were in "distressing condition," he asserted, the agency created by congress to aid them was being restricted by the treasury department to annual bond issues of between \$150,000,000 and \$200,000,000 whereas, the amount of issue he said, should be several times greater. He estimated that bond issue of \$1,000,000 a day is necessary to meet present conditions.

"But the treasury department is not interested in agriculture," Senator Fletcher asserted, and does not want the bonds for the farm to come into competition with other bonds to aid commercial, industrial business and trade enterprises.

TO PROHIBIT BLOCKS IN CONGRESS IN FUTURE, BILL TO BE FRAMED

(By The Associated Press) WASHINGTON, Dec. 21.—A bill prohibiting the formation in congress of blocks based upon particular pursuits or geographical locations for the purpose of in anyway affecting legislation was introduced today by Representative Ansorge, Republican, New York. Senators and representatives would be subject to a fine of five thousand dollars in case it proved they belonged to a "block."

New Sprayer Invented
That Will Benefit the
Truck Growers of Fla.

Prof. Heyer, of Florida Experiment Station, Has New Idea

(By The Associated Press) GAINESVILLE, Dec. 20.—A new sprayer which it is believed will be a great benefit to the trucking industry has been designed by Professor A. H. Heyer, of the Florida Experiment Station here. The apparatus is intended for spraying young truck crops and its use makes it almost impossible not to kill insects that formerly succeeded in flying away unharmed before the spraying machines heretofore used.

Prof. Heyer, in addressing a gathering of scientific men at the University of Florida, recently, stated that his experiments had been principally with the bean跳虫, a small rapid flying insect, but that he believed his apparatus and method would be easily applicable to almost any insect, or disease, occurring on any truck crop.

He plans to conduct extensive experiments and tests along these lines within the next few months.

During the last year the bean crops of the Florida Experiment Station have been complete failures, except where the new spraying apparatus was employed. In every case where it was used the beans were good.

The apparatus is simply of design and the method is one easy to understand. Three nozzles, leading from one common force pump to closely and just above and on either side of the row of plants, turn loose a veritable haze cloud of fumes of the spraying material. About the nozzles is a cylindrical canvas shield which keeps the spray close into the plants and prevents the flying away of the bugs. The plants are literally drenched; every leaf is covered with "bug-death" on both sides, a thing heretofore practically impossible to do.

Two men and one horse have been found sufficient to operate the outfit, which can make nearly as much time as a one-row seed drill. Different sized spray tanks can be used and any one of a number of compression methods are applicable.

It is the consensus of opinion of the specialists of the University of Florida and of the State Plant Board that Prof. Heyer's discovery, or invention, will prove of inestimable value to the trucking industry of Florida and the nation.

TAMPA REDUCES
GAS RATES JAN. 1.
BIG REDUCTIONS

TAMPA, Dec. 20.—Agreeing to a substantial reduction in rates to the consumer, effective with the first of the coming year, the Tampa Gas Co., was released from its contract for street lighting with the city of Tampa at a meeting of the commissioners held in the commission room at 11:45 o'clock Monday morning.

Mayor Charles H. Brown called the meeting to order. In addition to the commissioners, Clerk Duncan and newspapermen present in the commission room, John C. Gribbel, president; Mr. D. J. Collins, vice-president of the Gas company; Mr. J. D. Shattuck, one of the directors, Roscoe Nettles, secretary and manager.

Under the new rate, which will go into effect January 1, 1922, the first 10,000 cubic feet of gas will cost \$2.14. The present rate is \$2.25 for the first 10,000 cubic feet. The difference is 11 cents.

A reduction of 19 cents will be allowed on the next 10,000 feet, the price being reduced under the new schedule from \$2.25 to \$2.06. A reduction of 27 cents on the next 20,000 cubic feet is announced, the reduction being from \$1.94 to \$1.67.

The present rate for gas over 40,000 cubic feet is \$1.67. The new price will be \$1.45. The present minimum rate of \$1.11 will hold under the new schedule.

ROLLINS DORMITORY
PARTLY DESTROYED

WINTER PARK, Dec. 20.—Lake-side Cottage, one of the boys' dormitories on the Rollins College campus, was partly destroyed by fire which was discovered shortly before 7 o'clock last evening. Two rooms on the second and third floors were badly charred and the entire building was flooded with water. The damage is estimated at around \$1,000.

Charles Holloway, a student rooming on the third floor, was overcome by the smoke, but was rescued by fellow students. Students rooming in the dormitory battled the flames until the arrival of the Winter Park fire department to their assistance.

The fire, which was caused by defective wiring on the second floor, gained considerable headway before a stream of water could be brought to play upon it. It was necessary for

the fire department to lay a long line of hose to connect up with the fire hydrant of the city which was at a considerable distance from the building.

A. C. L. SHOPS AT
LAKELAND CUT FORCES

LAKELAND, Dec. 20.—Notices were posted at the local shops of the Atlantic Coast Line Railroad here today announcing that effective December 24, the force will be reduced approximately 50 per cent. About 100 men will be affected by the order, which involves, mostly the car repairers, machinists, boiler makers, pipe fitters, blacksmiths and helpers.

WOMAN KILLS SELF
IN JACKSONVILLE

JACKSONVILLE, Dec. 17.—Mrs. Warren St. John of Lakeview, Ind., ended her life in a local family hotel late today by inhaling gas fumes. Beyond the statement of the proprietor of the hotel that she told him when she arrived two days ago that her health would not permit her to continue her travel, no reason is known for her act.





