## House Passes Bill Providing Arms For Non Red Countries

### Record Speed Comes After Assertion That Russia Cannot Be Trusted

WASHINGTON, Oct. 14 (AP)—With record speed, the House passed and sent to the Senate today a bill providing \$1,314,010,000 to arm non-Communist nations. Passage was by voice vote.

The bill also carries \$1187,000,000 for new military construction. In sending it to the House floor, the Appropriations Committee also sent a state department assertion that Russia no longer can be trusted.

The bill also carries \$187,000,000 in cash to help arm friendly nations and \$95,000,000 for military projects in Alaska and Okinawa. In addition, there is \$500,000,000 of contract authority for foreign arms and \$92,000,000 for the military projects. This authority amounts, in effect, to telling the officials administering the program that they can run up debts to that amount and that Congress will pay them.

Actual cash in the bill totals \$1,088,500,380. Along with the billions for foreign aid and military construction there are smaller amounts for shipbuilding, hospital construction, veterans' facilities, unemployment compensation, schools, and public works planning. Leaders scheduled the bill for House action today.

### Ways Of Cutting Costs Are Hunted By Atlee Regime

LONDON, Oct. 14 (AP)—The British Labor government today hunted for ways to cut expenses in answer to opposition criticism against its refusal to call a general election this fall.

Prime Minister Atlee called his cabinet into session for the third time this week. It is expected that the government will be reduced to a five to 10 per cent staff in administrative spending. Atlee will not permit cuts in defense costs or any reduction of government health services.

A five percent cut would save about \$100,000,000 (\$400,000,000) a year. The committee also will study possible cuts in the government's (Continued on Page Eight)

Cooner of Route 1, at \$150, according to R. D. Hamilton, state highway patrolman who investigated the accident. Cooner faces a charge of violation of the right of way.

## Multi Billion Dollar Suit Filed In Court

LOS ANGELES, Oct. 14 (AP)—A damage suit for \$71,100,000 was filed in federal court today by two Los Angeles attorneys. Attorneys said it was the largest damage action in history.

Arthur R. Van Wyke and A. H. Harrison, Los Angeles, charge that a metallic lubricant was adulterated, resulting in huge losses for the plaintiffs. Several former employees of the Standard Oil Co. of California, A. D. Irwin and Associates and John Doe Inc. are named as defendants in the suit. The suit was filed in federal court today.

## Stalin Praises East Germans On Red Government

### Soviet Bloc Expected To Sign Peace Pact By January

BERLIN, Oct. 14 (AP)—Joseph Stalin today told East Germany's new Communist republic that the Germans and Russians together could keep Europe peaceful by fighting as hard for peace as they fought in war.

Stalin's message of congratulations to East Germany's Communist leaders brought predictions from pro-Soviet sources here that the Soviet bloc would sign peace treaties with the new Red Satellite by January.

These sources tentative drafts of such treaties already have been prepared. Stalin's congratulatory message last night to East Germany's Premier Otto Grotewohl called establishment of the satellite regime a "turning point in the history of Europe."

He declared that the Russian and German peoples made the greatest sacrifices in World War two. "If both people, Stalin continued, will show the same determination to fight the same intensity of effort for peace with which they waged war, then peace in Europe can be regarded as secure."

The statement was distributed here by ADN, the official Soviet News Agency. It was given prominent space in Moscow newspapers today.

"There is no doubt," Stalin said "that the existence of a peace-loving, democratic Germany, along with the existence of a peace-loving, democratic Soviet Union, excludes the possibility of new wars in Europe, makes an end to European bloodshed, and makes impossible the servitude of European countries under world imperialism."

"Both these peoples," the Russian premier declared, "have the largest potentialities in Europe to complete the great actions of world significance."

The sources who reported the impending peace treaties said the pact would bind the German republic to renounce forever any claim on the former German territory now held by the Soviet Union, Poland and Czechoslovakia.

Two films were shown later, one dealing with correct methods of soldiering in combat and the other with the activities and importance of the new National Guard.

Lt. Kader announced that the recruiting drive is progressing very well and welcomed any young men who are interested in joining to come to the regular meetings held every Thursday night.

Main speaker at last week's meeting was Chaplain Lytle Zimmerman who told of the importance of a Chaplain's duties during war time and the primary objective of bringing God to the soldier.

## Lewis Urges AFL Funds For Steel Strike

### Mine Workers' Leader Would Unite All Labor Behind CIO's Drive For Pensions

WHITE SULPHUR SPRINGS, Oct. 14 (AP)—United Mine Workers President John L. Lewis today urged AFL President William Green to throw in \$2,500,000 a week to assist CIO President Philip Murray in his steel strike and promised the miners would help.

Lewis, in an amazing bid for labor union cooperation in the two major strikes now on, called upon Green to create a fund in which 10 AFL each union would put up a quarter million dollars every week to help the steel workers "win beyond peradventure."

Lewis said he would match the \$250,000 every week from the treasury of the United Mine Workers. His 400,000 miners have been on strike since Sept. 19.

In a letter to Green, Lewis urged the AFL President to "unhinge" every other consideration and rise to meet in this fashion the stark adversity which would demoralize the major units of organized labor.

In this way, Lewis who has fought both Green and Murray in the AFL and CIO, appeared to be making a tremendous bid to bring all of the major labor organizations into a drive to fight what he called yesterday "a combination" of powerful steel and financial interests to break down unions.

Lewis urged unity among labor pressed into the background for the moment the negotiations he is conducting here with northern and western mine owners. (Continued on Page Eight)

## Jack Davis Tows Body Of Drowned Fisherman Ashore

The body of William Savage, negro (familiarly known as "Peg Leg"), was today recovered from Luke Monroe about 900 feet from shore near Mills Creek by Jack Davis, sign painter, who while fishing at about 9:30 o'clock, sighted the rope, rowed to it and after tying a rope around it, towed it ashore. Savage was drowned Wednesday afternoon when his row boat overturned.

Game Warden Bill Johns arrived at the scene this morning and advised Davis in removing the body from the row boat and placing it on the shore.

Police Chief Roy G. Williams had meanwhile sighted the body floating in the water prior to the time Mr. Davis went to it, and had notified the Sheriff's office. Sheriff P. A. Mero and State Highway Patrolman R. D. Harrison arrived on the scene shortly afterward. The body was taken to Horton's Funeral Home.

Savage was drowned shortly after 9:00 o'clock Wednesday afternoon when the rowboat in which he and William Hamilton, negro, had been fishing, overturned in rough water. Hamilton clung to the overturned boat for more than an hour before he was sighted by a negro woman and officers arrived in the police boat to rescue him. Efforts by police to drag for the body of Savage yesterday morning were hampered by the rough water, said Capt. Tills.

## Three Federal Judges Study Rail Merger

ATLANTA, Oct. 14 (AP)—Three federal judges had under consideration today a proposed merger of the bankrupt Florida East Coast Railroad and the Atlantic Coast Line. Oral arguments for and against the plan were aired yesterday in U. S. court of appeals. AOL is fighting the Interstate Commerce Commission on a \$100 million per cent of the F.E.C. refunding bond holders are fighting the proposal. St. Joe Paper Co., a Du Pont concern which owns 81 per cent of the \$48,000,000 of refunding bonds, heads the opposition.

U. S. POPULATION WASHINGTON, Oct. 14 (AP)—The United States population will go above 160,000,000 "some time this month," the Census Bureau predicted today. Acting Director William M. Hauser said the Bureau's estimate for 1949 is 160,000,000, and that the current rate of increase is 1.5 per cent.

## New Trailer Park Opened Near Longwood By R. A. Wilhelm

Sanlando Trailer Park, beautifully landscaped and shaded and with every modern facility that the tourist may desire was opened yesterday by Mr. and Mrs. R. A. Wilhelm, former citizens of Flint, Mich.

The Park is located nine miles south of Sanford on the Sanford-Orlando highway where the cross road branches to Longwood. Its nearly three acres of ground contains circular clay surfaced roads arranged as to provide easy entrance and exits for trailer units, and 30 large trailers may be accommodated, each with a "front yard."

## Moch Is Elected French Premier By Narrow Margin

PARIS, Oct. 14 (AP)—The French government today formally rejected Russia's recent protest against the establishment of a western German state at Bonn. The rejection was pronounced in a note from the French foreign ministry replying to the Soviet note of protest delivered Oct. 1. Russia had claimed the Bonn regime violated the Potsdam agreement for Germany's political and economic unity.

Announcement of the final result could not be made for almost three hours after the ballots were cast because of disputes over the vote of several deputies. Two absentee votes put the new premier in office.

Much of the retiring interior minister, gained a reputation as a "strong man" last winter when he crushed a Communist led wave of strikes. Now he faces the task of naming a cabinet which can cope with the nation's mounting wage-price crisis.

It appears that his cabinet will have only a slim chance of surviving for any length of time. He received the lowest postwar total for any premier in a vote of 311 to 223 vote.

## Blood Tests Prove Child Not Thompson's

ANN ARBOR, Mich., Oct. 14 (AP)—Laboratory blood tests showed conclusively today that an abandoned six-year-old boy found here is not the kidnapped son of a Dayton, Ohio couple.

Result of the tests was reported by Dr. Charles Carstensen of the University of Michigan heredity clinic. He said the tests were "conclusive."

For two days the parents of six-year-old William Thomas O'Neill had been in question. Mr. and Mrs. Arthur Thompson, hoping Tommie had come home, had kidnapped five years ago from their Dayton, Ohio, home.

In the tests, Tommie's blood was compared with that of Mr. and Mrs. Thompson.

ORLANDO, Oct. 14 (AP)—Florida merchants today received the answers to some of the questions that have been bothering them about the state's new sales tax.

Comptroller C. M. Gay disclosed some of his administrative ruling on taxes of a clinic sponsored by the Florida State Retailers Association.

Re-tailment men, furniture and automobile dealers faced their questions of tax during the morning session.

Here, some of the things told them about the new 3 percent levy which will become effective Nov. 1st.

Although many dealers felt that one cent in tax plus a combination of such sales by a group of customers at the same time will bear the tax. In other words, five men could buy individual cups of coffee in a restaurant at five cents each but pay five cents tax.

## Dixon Is Ordered Held In Death Of Carroll English

A coroner's jury, announced this morning to make further reports into the death of Carroll English, Oct. 3 at a firing camp at Lake Jessup, reported that Jay Dixon, alias "Mule" Dixon, had made an assault with a cut-throat razor and inflicted a mortal wound on English and had killed Carroll English from a premeditated design.

Dixon, 17, is being held in the county jail in pending action of a grand jury, said a sheriff. A coroner's jury, not including Dixon, was called this morning.

W. E. Watson, medical examiner, said that English's wounds were fatal. He said that the wounds were inflicted on the back of the neck and the chest.

Shirley P. A. Mero reported that Dixon had admitted shooting English at the Jessup camp following a quarrel in which Dixon and English had "snatched" money and knocked a pipe out of English's mouth.

Shirley Mero also reported that Dixon had led him home where he was found by a neighbor. Another man which had been fired, was found close to the body of Carroll a day later.

O. R. Smith of the Jessup Fire Department told of the shooting wound in the neck of English. He said that the wound was sufficient to cause death, and that in other wounds were found.

He sent his congratulations to the government attorneys who handled the case and issued a statement saying: "Whatever the outcome of this case might have been, American public opinion would have to be told that the more have been called upon to exercise greater patience and fidelity to the instructions of law and justice."

Eight of the defendants had been free on \$5,000 bail. Immediately afterward, Federal Court Judge Harold R. Medina found five of their lawyers guilty of criminal contempt during the nine-month trial and sent them to jail for terms varying from 30 days to six months.

Engene Dennis, a defendant who acted as liaison lawyer, also drew a six-month contempt sentence.

BUENOS AIRES, Hungary, Oct. 14 (AP)—Hungary's court of appeal today ruled that Gyula Raik, former Communist foreign minister, and two fellow plotters must be executed for treason. They confessed conspiring to make their country a satellite of Moscow's Yugoslavia.

The court sentenced the three death sentences and also upheld prison terms decreed for three other men who admitted conspiring with Raik to overthrow Hungary's Moscow-backed regime. Two were given life imprisonment, the other a 10-year term.

The sentence on Raik imposed upon him by a Budapest people's court after a secret trial, had been upheld by the government's supreme court.

## Gay Completes Big Force To Get Sales Tax

### Permit Applications Are Mailed To Over 100,000 Merchants As Collector Agents

TALLAHASSEE, Oct. 17—(AP)—Comptroller C. M. Gay said today he has virtually completed his sales tax collection force and has taken the first step toward bringing in the money.

Applications for permits to do business in taxable classifications have been put in the mail to nearly 100,000 merchants, hotel and restaurant operators and amusement establishments.

The permits will be returned by Nov. 1, when the sales tax law becomes effective, accompanied by fees of \$1. They need not be renewed in the future unless the business changes hands.

The permit holders will be the actual collectors of the sales tax as it is paid by their customers. They will start adding the tax to the customer's bill Nov. 1 and must take their first remittance to the state by Dec. 10.

Comptroller Gay said he has "practically filled out the force" of some 50 field men who will work with the merchants throughout the state.

He said he based this on the refusal of the conferees, on three occasions, to report back to their respective houses that they are unable to agree.

## Greek Rebels End Civil War; Retain Arms

### Commie Stop Seen As Move To Evade U.N. Peace Intervention; Greek Forces Wary

ATHENS, Oct. 17—(AP)—Communist-led rebel forces, staggered by the government's recent drive on last strongholds near the Albanian border, announced today they have stopped the civil war but won't lay down their arms.

The Greek general staff reported monitoring the rebel radio announcement which came as United Nations moves to settle the Greek Balkan conflict neared a climax.

War Minister Panayotis Kanelopoulos declared, however, he wasn't impressed by the rebels' announcement they had stopped fighting. He said: "It merely admits an accomplished fact of the complete defeat and disappearance of Communist bandits from Greek soil."

"The guerrilla army remains intact, strong and on the alert," the rebel broadcast heard here this morning declared. "We have not laid down our arms. We have just stepped the bloodshed in Greece."

Greek government officials and U. S. army observers here say the rebel radio is located at Buzarezi, a mountainous area near the Albanian border. The United Nations special commission on the Balkans, established to report on fighting in Greece, has charged that Communist Albania and Bulgaria have been actively aiding the Greek guerrillas.

"We are not going to adjust the Baltimore city court put in a bad situation," Caldwell referred to a Baltimore court ruling against a desegregation plan.
