Dakota Gets Big Victory On Tunisia Visit

Assures Boy Of Tunisia Protectorate Will Be Defended Against Italy

France's touring fleet was on an ovation today in Tunisia on his Mediterranean trip under- scoring French intentions of defending her territory from Italian aspirations while the wars in Spain and China took on new complexities.

Premier Daladier, fresh from a triumphal visit to the island of Corsica, assured the Boy of Tunisia that the French North African protectorate would be defended even if it meant war with Italy.

The Bank of France, meanwhile, lowered its discount rate from 3 1/2 to 2 percent, the second cut since it was raised to 3 percent during the Czechoslovak crisis.

Beneath the outward calm of Tokyo's New Year ran an undercurrent of political unrest. The so-called Fascist and Liberal forces were contending over poli- tics in China and it was believed a cabinet re-organization was possible.

While insurgent commanders in Spain established their forces along the Gijon front for an apparently intensified drive against Barcelona, Britain asked Generalissimo Franco for confirmation of a report that British Pro-Consul Ernest Goding had been arrested at San Sebastian on a spy charge.

Congress Is Told New U. S. Naval Bases Are Needed

Secretary Swanson Submits Report Of Needs For Normal Operations

WASHINGTON, Jan. 7.—(AP)—The Navy Department told Congress today it was in urgent need of 25 new air, submarine, destroyer and mine bases in the United States and its outlying possessions to meet the "normal operations" of the fleet.

Secretary Swanson submitted to Speaker Bankhead a 90-page report for a special naval board which surveyed the requirements of the fleet.

The most important projects, the board said, were naval air bases at Kaneohe Bay, Midway Island, Wake Island, Guam, Johnston and Palmyra Islands in mid-Pacific, Kodiak and Sitka Islands in Alaska and one at San Juan, Puerto Rico.

Mr. Ballard is beginning his second term as County Commissioner from District No. 3, having been victorious over two candidates in the primary election.

The first official action of the new board was the re-appointment of E. F. Housholder as County Attorney for two years. Mr. Housholder has served in this capacity with the County since 1933.

The Lynching Record

If any members of Congress feel disposed during the current session to wait the time of that important body...

Accidents Decline

Despite a hurricane, floods, tornadoes and the most serious railroad accident in recent years, the general picture of accident mortality in the United States during 1938 showed a decided improvement...

A total of 95,000 persons died in 1938 as the result of some form of accidental injury, as compared with 106,000 in 1937, and 110,000 in 1936, the largest number on record...

Motor vehicle accidents caused the death of 8,000 fewer persons in 1938 than in 1937 and as a result were probably less frequent than injuries received in the home...

"This improvement has been consistent" throughout the year, for month after month the motor vehicle accident record was better than in the corresponding month of the preceding year...

Deaths resulting from accidents occurring in public places, other than those in which motor vehicles were involved, and accidental deaths arising out of or in the course of employment, also declined somewhat.

Catastrophes claiming the largest number of lives were the September hurricane and flood which swept the Atlantic Coast States and caused the death of 682 persons; the floods of Southern California, in which 181 persons were killed; and the plunge of a train through a bridge in Montana, which resulted in the death of 47 persons.

All but \$14,000 worth of the old bonds have been refunded and these cannot be located, officials said. It is believed that these bonds have been lost since the attached coupons have not been presented for payment.

While the refunding program did not reduce the principal of the County's bond obligations, the date of maturity was postponed by the refunding bonds which have a 30-year maturity date.

The old bonds, a number of which reached maturity this year, would have become due in such large amounts that default on the part of the County would have been necessary, officials stated.

The new bonds are subject to call by the Board in such amounts as it sees fit after 1950. In addition to the refunding program, the County's bond debt has been reduced by \$32,000 in the past two years, making the present bond debt \$2,123,000.

After a visit to the State Road Department offices in Tallahassee and presentation of this county's road problems at several meetings of the State road group, the Commissioners have succeeded in getting the right-of-way cut for the improvement of State Road 228 with commitments to begin the work as soon as possible.

One of the biggest problems, however, has been the improvement of State Road 44 to the East Coast. The road department has agreed to give this project consideration in ranking up its budget for the coming year and the Commissioners have been given the assurance that construction of a new bridge and fill across the Wekiva River will begin early this year.

The old Board has also sponsored a number of WPA projects throughout the county. These have been chiefly projects for improvement of the County's roads and bridges, one of the largest of which was the improvement of Sipes Avenue.

According to the audit of the County's records, the financial condition of the County has grown stronger during the past two years. Clerk Herndon also reported that the County has handled all of its transactions on a cash basis.

CHEYENNE, Wyo., Jan. 3.—(AP)—With streamliners a reality, the railroads now think it about time to rebuild caboosees.

The Union Pacific is spending \$4,000 a month modernizing the cars that tail-end freight trains on the Sidney, Neb., to Ogden, Utah division. Similar projects are underway on other divisions.

Most important change, railroad men say, is that of discarding the old, smelly kerosene lamps used in the cabooses for 50 years. They are being replaced by kerosene mantle lamps that utilize a bright-burning mantle instead of the old-fashioned wick.

The new ones also "wear" a modernistic shade.
