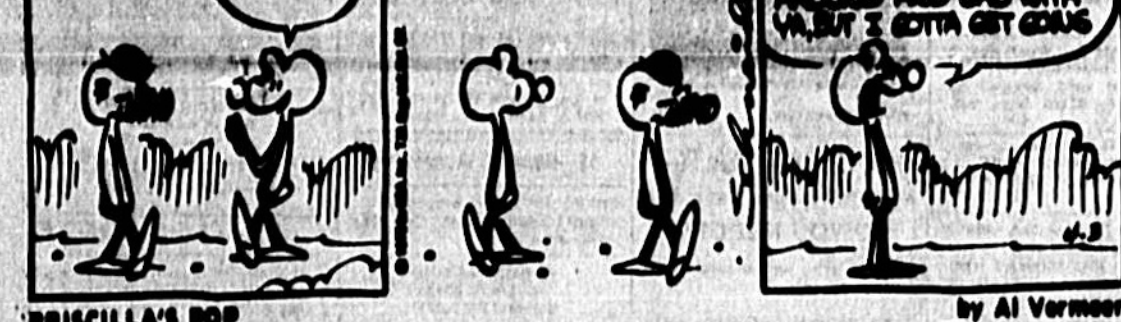

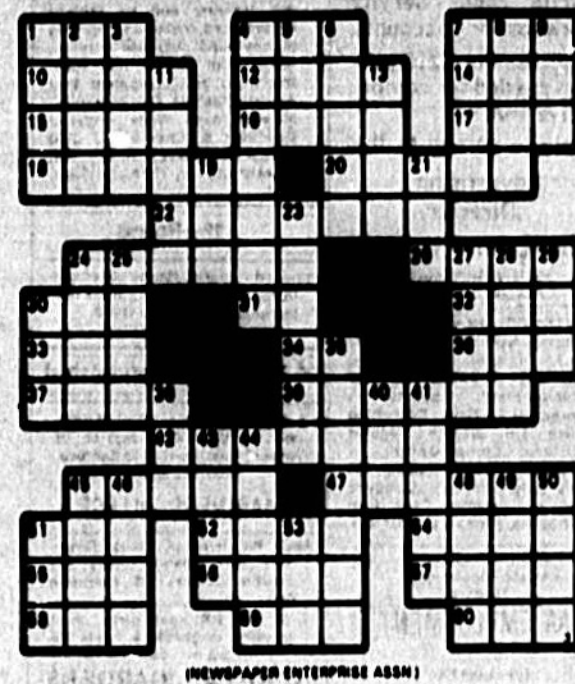

Triglycerides, A Fat By Any Name

Dear Dr. Lamb: My wife and I are both on a low-fat diet. She has been told to eat less than 30 grams of fat a day. I have been told to eat less than 40 grams a day. I am confused. Can you help me?

Sanford developer William S. Greasy and a Miami attorney face criminal and civil charges in connection with an alleged land fraud deal in Volusia County.

Charged with Greasy is Milton R. Worman. Greasy lives and operates his business, Greasy Construction Co., from his home at 511 S. Palmview Ave.

The criminal charges were filed by the Volusia County state attorney's office. Greasy and Worman have each been charged with three counts of selling unregistered securities and three counts of selling securities by an unlicensed agent.

The suit alleges the men sold three million shares of stock in connection with the Trader's Cove Condominium Inc., a purported mobile home community near Deltona.

The "investments" were to return an annual 18 percent interest.

to investors, the suit alleges, however none of the money was paid.

State Attorney Stephen Blythe in Deltona said the victims covered in April and May 1977 and the charges were filed on Monday just before the five-year statute of limitations was to expire.

The suit identified Worman as president and attorney of Trader's Cove in the name of the defendant and as a partner in the suit. He had sold 100 shares of stock to five investors and a total of \$100,000.

The civil suit was filed by state Comptroller Gerald Lamb with the State-Attorney General's office.

It calls the men to be restrained from selling unregistered securities without a state license.

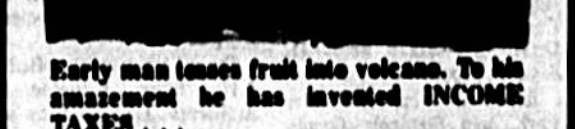
The suit alleges the men withheld information from investors concerning a 148,000 mortgage on the property and its location in a flood prone area.

The civil suit also notes the 18 percent guaranteed return offered investors and that European brokers for Trader's Cove received more than \$1.5 million in commissions.

A federal grand jury investigated Worman and associates in 1976 and he was the subject of civil suits by investors in 1977 and 1977, records show.

County Is Expanding Interstate Mail Office

Residents in southern Seminole County will receive full-time assistance in obtaining license tags, registering to vote and filing for absentee ballots as a result of Seminole County Commission action today.

Most of these duties had been handled at the county's Sanford office.

The commission voted unanimously to authorize Chairman Dick Williams to sign a two-year lease with the Interstate Mail, Altamonte Springs, to occupy 1,200 square feet of office space. Presently only the license office operates in a 900-square-foot facility in the mall.

The county is paying \$4 per square foot or \$4,700 monthly for use of the current office space, according to Robert Ellis, director of administrative services. Under the new lease agreement, the county will pay \$7.75 per square foot the first year and \$8.75 per square foot the second year. That amounts to \$1,200 for the first year and \$1,500 for the following year of the two-year part.

Ellis said last week with Mrs. Constance Brown, supervisor of administrative services, last October and Terry Gumbel, property appraiser. The meeting centered on the need for a larger office space for the county's license tag branch office.

"On the positive side of that same coin," Ellis said at the meeting, "we did reach agreement for the construction of a new building on the site of the present building during the meeting, and Ellis said that the new building will be finished in 1980 and will be a 100,000-square-foot building when needed.

"This will make it a full-time full service facility," Ellis said at the meeting. He also said the county planned to pay for the new building, Page 14

Casselberry May Refinance Water-Sewer Bond Issue

The Casselberry City Council for the second time in 11 months is considering refinancing its \$5 million water and sewer bond issue—this time to save a reported \$200,000.

Although the idea was presented in the council meeting night by a representative of the Casselberry Water and Sewer Utility, the city council and that proposal will be accepted from any firm willing to make one.

Formal proposals must be in the city clerk's office at city hall by 5 p.m., Tuesday, April 10, to be considered.

Each meeting of the Casselberry Water and Sewer Utility Board told the city council Monday night that \$400,000 in savings can be realized by again refinancing the city's \$5 million water and sewer bond issue.

Monday, saying the city could level its treasury "bank entry level," urged a new refinancing technique to meet. He explained that under a new lease the city could defer annual payments on

the bond issue for 18 years and invest those funds instead in new treasury "bank entry level."

At the end of the 18 years, he said, some invested plus interest would be sufficient to make up the payments delayed plus give the city \$200,000 profit from the interest.

Monday said the new technique has been approved by the city council.

He said the new technique of refinancing is allowed only to state and municipal governments. Monday said the new technique has been available for only the past six months, and then could not have been used when the original financing was accomplished last year.

Monday presented the council with a contract which would have permitted only his firm to conduct a study and prepare a formal proposal on the matter. However, George D. Head of William R. Head and Co. asked to be permitted to prepare a proposal on the matter. Head said that his firm also has been using the technique. Casselberry's Frank Schulte pointed out that during negotiations

of Casselberry and South Seminole Utilities Co. (CSASUBCO) when it was a privately owned utility and before it was sold to the city.

City Attorney Fired

The majority of the Winter Springs City Council, unhappy with the services of its legal counsel since early this year, voted 6-1 Tuesday night to fire City Attorney Gary Massey.

In another part of the county, the city of Lake Mary, which also uses Massey's services as city attorney, is happy with him, and intends to keep him according to Mayor Walter Surran.

"By and large, we are happy with Massey," said Surran today. "I don't suppose he's quite as perfect, but then I don't think anyone would be."

"I think we got from Mr. Massey the level of research warranted as a general rule, certainly the level of research requested," said Surran.

It was the question of such research that led to Massey's dismissal in Winter Springs. It came in the form of last week. Councilman John Daniels, opposing the move to cut his salary and a statement by Massey last week on the utility-tax issue indicated Massey had not been providing "first-class legal services to the city."

Early in March, Florida Public Service Commission lawyer, William Shrovet, challenged the legality of Winter Springs collecting a utility tax on sewer service.

Instructed to research the matter, Massey reported to the council that the tax is illegal and not authorized under state law. He said that cities may levy only those taxes authorized by state law.

Massey had prepared the utility tax ordinance reducing the rate of taxes from five to four percent.

When questioned by council members on why he had permitted the council to adopt an illegal ordinance, Massey said that he had been unaware of the law.

"If I had known I would have said no," said Massey. "If you want me to research everything that comes up at meetings, you would have to pay me \$20,000 to \$30,000 a year as a salary, rather than what you are paying." Massey had the council last week.

Massey has been paid a flat fee of \$750 monthly by the City of Winter Springs and \$750 monthly by the City of Lake Mary. It is not clear the arrangement

was put in place to a test of council confidence. He said Tuesday night that leaving the city without an attorney is prohibited in the city charter.

Walden agreed with Massey, that the city must have a city attorney, in accordance with the city charter. He advised that the council would have to terminate the city attorney and appoint a new one almost immediately.

Daniels changed his motion from an immediate termination of Massey to an effective date of April 11 to give Massey an opportunity to seek a replacement. To Massey's and Walden's satisfaction, the charter requires the city to have an attorney, Daniels stated from the chair.

The charter says, said Daniels, "There shall be a city attorney appointed by the mayor and approved by the city council, who shall represent the city in all legal proceedings and shall perform all other duties assigned to him by the city council."

Planned said he is not sure he will be prepared to name an attorney by next week, leaving that Massey will continue to serve until a new city attorney is appointed.

"I'm not going to be placed in a situation to support a council decision," Planned said. The mayor threatened to get an attorney general opinion if the motion passed, urged the council to grant Massey the courtesy of holding up the firing until he was present, and insisted the council had not been properly considered since it was not on the agenda.

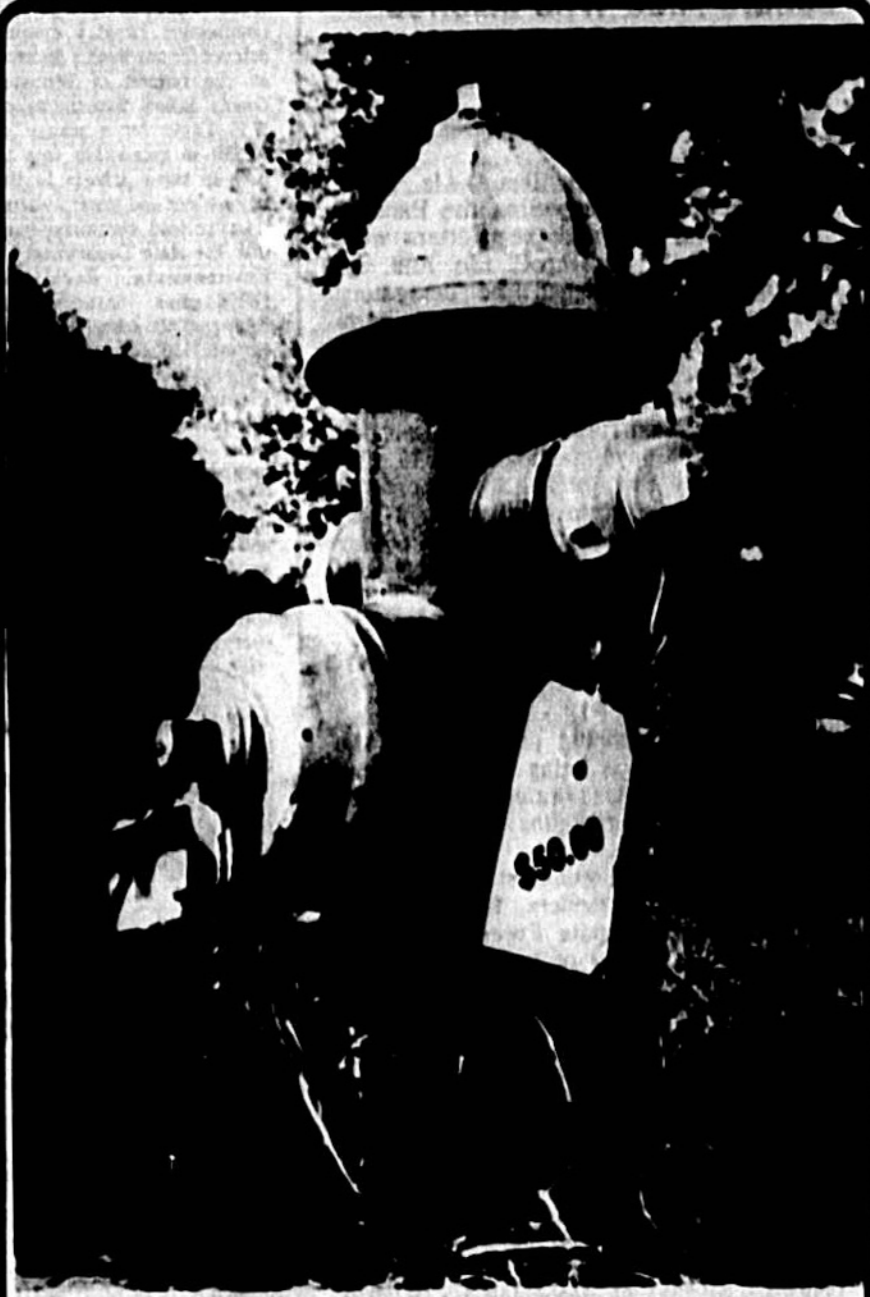
Daniels brought the item up during his report on city finances.

"You don't have the guts to do it while Massey is here," said Planned to Daniels. Planned told the council he would be giving direct consideration to their positions.

Planned told them to continue with the action. "If you think it is fair and proper and being done in a democratic manner," Planned said.

Sanford called for a five-minute adjournment at the conclusion of the voting. "Change that, John Daniels. Change that," he said returning to the podium at the end of the session.

Massey, according to his office, was in court this morning and unavailable for comment.

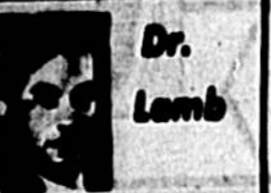
Labels On Content Can Be Misleading

DEAR DR. LAMB — I am on a low cholesterol diet and am constantly looking for food I can eat. I bought a coffee creamer which said it was low in cholesterol, but the label says it contains coconut oil. I was under the impression that this oil was high in cholesterol. I am confused by the label with the ingredients and also I was under the impression that shell fish — shrimp, clam, lobster and oysters — were high in cholesterol and should be avoided. However, I heard recently that these foods were no longer in this class and could be eaten without fear of raising the cholesterol count. Is that the case?

DEAR READER — I think labels that advertise low cholesterol in the contents of or claims of are misleading. These vegetable products do not contain cholesterol — that is why the number of people who eat with it. But the saturated fat content may stimulate your own body to produce more cholesterol and the type of lipoproteins particles you associate with vascular disease that cause heart attacks and strokes. Most of the people who eat coffee cream substitutes are not as good as ordinary coffee cream from a health standpoint.

Shrimp is moderately high in cholesterol and should be eaten in only moderate amounts. Its price controls that problem for most people. The same is true of lobster, although both are very low-fat foods. Clams and oysters are low-fat and also low-cholesterol foods. The thinking about these has changed because of more recent research on cholesterol.

You will have to limit your coffee from all sources if you want to be successful with a low-fat, low cholesterol diet. The low-cholesterol foods will
