## Methods Used In Processing Iron Given Kiwanians

*(Continued from Page One)* dominate the charge for the blast furnace in which the melting and reduction takes place, it is composed of alternate layers of coke, stone and iron ore.

The simplest possible statement of the reactions in the blast furnace is that the oxygen of the coke combines with the carbon of the coke to form the acids combined with the bases to form a fluid slag. The iron, being heavier, settles to the bottom or hearth of the furnace and the slag, being light, floats on the top of the iron.

"At various intervals, a plug is drawn from the side of the furnace and the slag runs off. At other regular intervals, a hole is tapped to the bottom of the furnace and the iron is forced out. This iron may be at once molded into suitable size pigs for shipment as pig iron or it may be taken in the molten state to a steel mill for further refining to various grades of steel.

"The principal difference in pig iron and steel is the carbon content. Pig iron contains from 3.50 to 4.00 percent carbon while steel may contain as low as 10 percent of carbon. Automobile body sheets contain 10 percent or less of carbon while cutlery steel will contain in excess of .50 percent of carbon.

"The air, furnishing oxygen to support combustion, is pumped in at the bottom of the furnace and the weight of such air is in excess of the solid materials used. Three and one-half tons of solids and approximately three and three-fourths tons of air.

"It will thus be seen that all blast furnace plants must be equipped to supply hot air in generous quantities. The iron blast furnaces may properly be called a chemical laboratory and the action and reaction, physical, chemical and mechanical, which occurs is so vast and complicated that volumes have been written about it and yet much remains to be learned."

Warning Against Fire Hazards Is Made By Cleveland

The sudden change in temperature yesterday brought in warning from Fire Chief Clark King of Cleveland against the use of kerosene oil lamps and the use of defective fireplaces as the chief fire hazards.

Pointing out that property in Sanford is only 10 percent insured against fire loss, Chief Cleveland urged that care be exercised in setting up heaters for the winter and that all fixtures should be inspected and repaired.

"Most of our fires occur during the winter months, and most of them are caused either by candles or by setting up heating stoves or defective pipes," Chief Cleveland said.

To date, firesmen have inspected approximately 300 buildings in Sanford, chiefly business houses. Chief Cleveland said, adding that while it is not the practice of the Fire Department to inspect all Sanford homes periodically as in the case of business buildings, a thorough inspection will be made at no time to the owner on request.

The Fire Chief reported that during his inspection he has found many hazardous arrangements for providing heat. He said he has found heater pipes run through the windows and in many instances very close to inflammable materials such as curtains.

Urging co-operation with the Fire Department, Chief Cleveland stated "It is best to stop the fire before they are started."

**84 Persons Lose Lives As Severe Storm Sweeps U.S.**

Clearing skies and slowly rising temperatures today speeded up the task of mopping up after the nation's worst November storm in years—a tempest of wind and snow that claimed at least 84 lives.

Frigid weather prevailed generally, however, from the east coast to the Rocky Mountains.

Snow-packed roads remained a menace to weekend travellers, particularly in rural areas. Traffic accidents on the segregated streets and deaths due to overexertion added to the toll of lives.

The storm caused 25 deaths in New York, 22 in New England, 12 in New Jersey, 7 in Pennsylvania, 6 in the South, 4 in Ohio, 5 in Maryland, 2 each in Michigan and Indiana and 1 each in Nebraska and Missouri.

We realize that this year it will perhaps be more difficult than ever for many Sanford person to make their usual contributions to this fund. But for that very reason the need will doubtless be all the greater. The more difficult it is for some to give, the more families there are likely to be who are in dire need and who must depend upon the Empty Stocking Fund for their Christmas dinner.

This used to be an expression during the World War which seems to fit our present day needs. "Give until it hurts". We heard that over and over again during the Liberty Loan drives of 20 years ago when we were trying to get the boys out of the trenches by Christmas. We should hear it more and more during the next few weeks as the Empty Stocking Fund seeks to meet the needs of local families that are destitute.

A few of our more well-to-do people have begun to believe during the past few years, as they have seen the Federal government assume more and more of the responsibility for local charity and relief, that perhaps it was no longer necessary for them to contribute to charity, and that, besides, they were doing their full share for the inner privileged through taxation.

This is, we believe, an rather short-sighted view to take of a very serious problem. In the first place, the federal government does not begin to answer the requirements of charity, and confines itself very largely to the needs of perfectly well and able-bodied men who would be more likely to earn their own living if they could find a job.

Whereas the most important part of all charity work is supposed to be for the benefit of families who because of sickness, death or desertion by the bread winner, or for some other reason, are made dependent upon others regardless of how many jobs may be available. It is this class of people for whom the Empty Stocking Fund seeks to provide.

And so we hope that everyone who is able to contribute to the Empty Stocking Fund will do so and in this way do something toward making someone, more unfortunate than himself, have a merry Christmas.

**Labor Strike**

Premier Daladier's government had no sooner launched his preparedness program in an effort to place France on an equal footing in a military sense with Germany than another wave of sit-down strikes spread over the country threatening to disrupt not only the rearmament drive but also industry in general.

The trouble seems to be that in trying to keep pace with German preparations for war, the necessity has finally become apparent to government leaders that the 40-hour week, fostered upon France by the Socialist regime, has got to go. It was manifestly impossible for French workmen to do in 40 hours of work what German workmen were laboring over under the whip and lash of Adolf Hitler for 70 hours a week.

But in refusing to work more than 40 hours a week under the trying circumstances which their country faces, the French workmen have placed themselves in exactly the same position as an army which fights courageously enough for four days a week, but on the remaining three days devotes itself to playing backgammon. Such a curtailed fighting week would afford just the opportunity which any enemy would wish.

Two of these ships—accurate reproductions of the fleet that sailed through the canal at its inauguration—were built from designs provided by Miss Frances Rich, head of the studio's technical department. And great artificial dredges of the type built on or near the canal were built and put in operation.

The greatest spectacle of all however, was filmed right on the home lot. This was the storm sequence in which a gale of seventy-five miles an hour intensity whipped across a twenty-acre desert, howling actors over, cutting them with flying sand, choking them and battering them for ten successive days. In addition to this the wind storm blew over there huge water towers and stampeded a herd of camels, horses and donkeys and scattered sand over an area three miles square.
