GENERAL HONJO'S MANCHURIA
NEW YORK HERALD TRIBUNE
Ambassador Davies, M. Brinley and his League Council colleagues
are now with justifiable consideration
contemplating from Paris a
much altered Manchurian situation.
Having invoked the League
covenanting the Kellogg pact to
protest against Japanese action
that was not strictly subject to
these agreements, they fostered a
Chinese defiance of Japanese in-
tervention which made an extension
of it inevitable. This enlargement
of the scope of military operations
has in turn created a situation
which General Honjo, in
command of the Japanese garrisons
in Manchuria, appears to have
taken advantage of to his own
hands, with the hearty infor-
mation of Japanese public opinion.
Alarming the defense of Japan
and the safety of the Japanese
Empire, Honjo's action is now
being taken as a positive step
toward the Far East area of North
Manchuria.
It is responsible now to escape
the fact that the civil govern-
ment of Japan has ceased to con-
duct operations and that the
military government is in charge
of the operations and ad-
justment of the situation. Japan's
policy of non-intervention in
international affairs is now being
called upon to do without in-
terference to international
conventions governing sea and
air traffic. The scope of these
operations is to be no longer
limited to the protection of the
Japanese Empire in the field, they
are to be police measures and take
the aspect of war measures for
which General Honjo is responsible
to the Emperor through the War
Minister. The disconcerting
nature of the situation at Paris,
therefore, appears to be that while
the Japanese Premier is ably re-
presented there General Honjo is
not.
What militates against an
adjustment of the present situa-
tion by negotiation in Paris is not
the tremendous popularity of mili-
tary action and equal resentment
against the League Council in
Japan. Public opinion is not so
concerned with diplomatic ap-
proaches. It is felt by all classes
that Chinese provocation over many
years justifies any action that the
military are to take. The mili-
tary know that, and believing that
public opinion will force their gov-
ernment to justify as best it can
any steps they find reason to take,
they are not going to make a
change to their China that Japan
is not to be "pinned on" with im-
punity. Their ambition are not,
therefore, limited by concern for
Russian susceptibilities, international
facts or the embarrassment of
a liberal Japanese government
abroad.
Japan's international credit
certainly depends now upon her ability
to put a firm check upon such
aspirations, and this cannot be too
quickly or clearly impressed upon
her representatives; but at the
same time the more than futile
results of the League's last un-
successful attempt to give Tokyo
peremptory orders in China's in-
terest argue to dictate an approach
that can be more accurately de-
scribed as diplomacy.

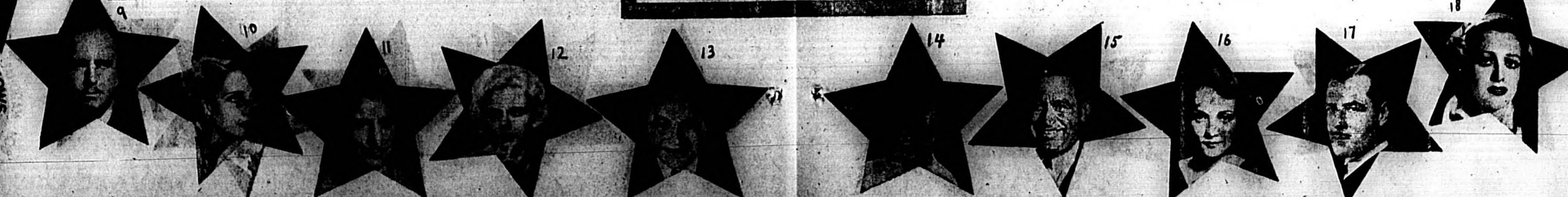

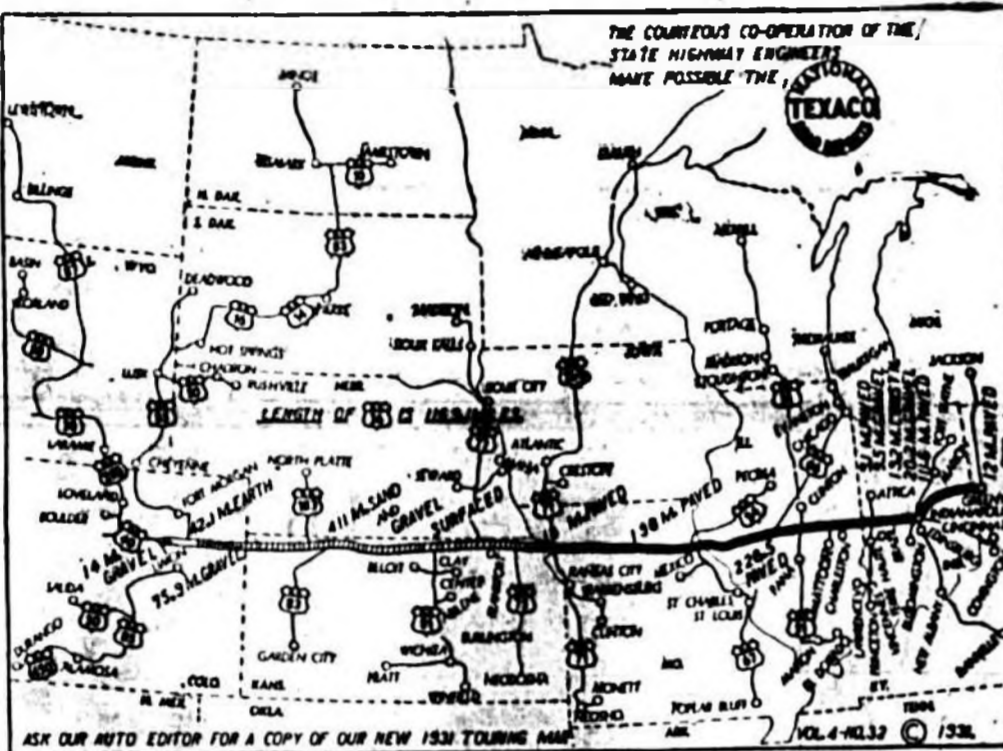
