**Reds Return** Bodies Of 3 U. S. Airmen

BEBLIN (UPD-The bodies of three U. S. airmen killed when Soviet jet fighters downed their unarmed trainer plane in East Germany Tuesday will be brought to West Berlin tonight, authoritative sources said.

The wreckage of their T39 twin-jet trainer also will be brought here, the sources said.

The U. S. military laison mission to the Soviet forces in East Germany went to the crash scene from Potsdam and is transporting the bodies and the wreckage back to the West.

The East German Communist regime denounced the American flight as "provocative" and demanded anew that Western troops leave West Berlin and West Germany.

U. S. Air Force officials took up the matter with their Soviet counterparts in Berlin and demanded swift action. They stressed that the T39 trainer had strayed across the border from West Germany accidentally and that two months before President the killing of the officers was

## Keep Them Constructive

A recent letter to the Greensboro, (N.C.) Daily News contained this paragraph about latters to the editor: "You could verify the accuracy of the "letters to the editor' you so freely publish and turn this column into an instrument of constructive criticism, rather than a public platform for malcontents and organized opposition groups."

This prompted the North Caro line daily to publish an editorial which we quote in part:

"Our correspondents may be interested to learn that no single feature of the editorial page gets more attention - or causes more concern - than letters. Some of our readers do, indeed, try to 'use' the Pulse (the paper's heading for its letters to the editor) for ulterior purposes. They send us letters signed with fictitious names: they try to sneak through personal vendettas against other individuals; they want us to publish letters without names or identification.

"So there is a constant game in progress. But such trouble comes only from a minority. Generally the letters are bona fide and worthy of publication. They serve as a medium of dialogue. They are part of the con-tinuing public debate and public af-fairs education of all our readers. And they are read.

"Do the editors try to guide and shape the opinion of the Public Pulse? Never as far as subject matter is concerned. We do measure each contribution against the libel law (for a newspaper is an responsible as the reader who signs the letter.) We do have standards of decency. All public officials and public issues are fair game. We gladly publish non-libelous letters which disagree with our editorial policy or attack any positions we take. But we do not allow readers to use the Pulse for personal purposes, if we can help it

"So while we would like for the Pulse to turn into an instrument of constructive criticism - and often it does - we do not shape it in that direction. Good letters, whether critical or otherwise, attract good letters. We put a limitation on letters by professionals (however note-worthy their contributions may be), and we try to discourage crackpots.

"But we do not shape the contents of the Public Pulse. Our readers know they have a medium of public expression - one which is widely read. We hope they have confidence in our "wide open" policy." The Herald concurs with the pol-

icles of the Daily News and attempts, as best we can, to follow the same procedures.

Our readers are not only invited but urged to use our columns to express their thoughts. It is our hope that they will continue to be as constructive as they have been in the past.
