## BIBLE VERSE FOR TODAY

WE CAN CHEAT OURSELVES, BUT NOT GOD: He that despiseth the gain of fraud, that shaketh his hands from holding bribes, He shall dwell on high. His bread shall be given him.—Isa. 33:16, 19.

Winston Churchill is reported in Germany. Couldn't be looking for Hitler, could he?

Part of Governor Caldwell's tax program has been enacted anyway. Henceforth, beer drinkers will pay three cents a bottle to the support of state government, and like it. To a man with a thirst three cents will not put him on the wagon, and not many beer industries in this state will be ruined, despite their bowls of profit, but the six million dollars produced will help put state institutions in better condition.

When German Field Marshal von Rundstedt surrendered the other day, he gave up his sword, if he had one, to a Florida boy, Lieut. Joseph H. Burke, who made the greatest capture so far in this war. Burke, born in Jacksonville, educated in Tampa schools and the University of Florida, and was employed in St. Petersburg before the war. There are, of course, men from other states participating in this war, but it remained for Florida boys to win.

The House has passed a bill requiring any publisher to put his name or any newspaper or handbill which tends to expose to hatred, contempt, ridicule or obloquy any individual or religious group. It should become a law. But it should be amended to include any publication of any anonymous letter or communication or any subject. It is by this means—chiefly as a result of individuals who furnish purposed information to newspapers, but "don't use my name"—that most of the misinformation these days gets into the newspapers. Anything that a man is not willing to support with his own name is not worth printing, and should not be printed.

The world moves fast. So much is happening these days that it is virtually impossible for one man to keep up with all of it. Time was when such a conference as is now taking place at San Francisco would occupy practically all of one's reading time, but now we merely skim at the headlines, go on to read of Hitler's death, the German surrender in Italy, the fall of Berlin, something which does not happen twice in a thousand years. And then, if that were not enough to keep a person busy, the OPA slams a ceiling on San Francisco rents and one is expected to listen to all the complaints, understand all the why's and wherefore's, give satisfactory explanations of what,

Senators Claude Pepper, with whom we find ourselves in continual agreement on most matters pertaining to foreign affairs, advocates an amendment to the Constitution of the United States to provide that treaties can be ratified by a majority vote of the Senate instead of the two-thirds vote which kept us out of the League of Nations. It may seem fair enough to say that a bare majority should rule in such matters, that is, a majority of one vote, but we say that if the treaty is approved by even a narrow margin, it will not last long and will not be worth having such a vote would have brought us into the League in 1919.







# GERMANY QUILTS UNCONDITIONALLY

## Stalin Delays Official Announcement Of Victory As British And Americans Celebrate Peace In Europe

America Greets Announcement With Solemn Prayer And Hilarious Gayety

**NEW YORK, May 7. (AP)—**A CBS correspondent Edward R. Murrow reported from London today that President Truman, Prime Minister Churchill were preparing to broadcast official news of the surrender at noon today but were delayed because Marshal Stalin was not yet ready.

**LONDON, May 7. (AP)—**The British Ministry of Information announced today that tomorrow will be treated as V-E Day. The Ministry said officially that "In accordance with arrangements between the three great powers, the Prime Minister will make an official announcement at 3 P.M., British Double Summer Time, (9 A.M. Eastern War Time), tomorrow, the 8th of May."

The announcement said that the Prime Minister "will broadcast to the people of British Empire and the Commonwealth tomorrow at 9 A.M. British Double Summer Time (3 P.M. E.W.T.)"

"In view of this fact," the announcement said, "tomorrow will be a double holiday and the day after, Wednesday, will also be regarded as a holiday."

"Parliament will meet at the usual time tomorrow."

**WASHINGTON, May 7. (AP)—**President Truman said today he had agreed with the London and Moscow governments that he would make no announcement on the surrender of enemy forces "until a simultaneous announcement could be made by the three governments."

Until a simultaneous statement can be made, he declared, "there is nothing I can or will say to you."

The President's statement, released by Press Secretary Jonathan Daniels, was addressed to the press and radio.

When Daniels was asked about British announcements that tomorrow will be observed as V-E Day, he said that he had nothing to add to the usual nothing.

Gen. Eisenhower Gets Surrender To Allied Armies

Capitulation Signed By General Jodl, Nazi Chief Of Staff

**LONDON, May 7. (AP)—**General Eisenhower announced the German unconditional surrender to the western Allies and Russia in his headquarters at Reims, France today. The surrenders was made by Col. Gen. Gustav Jodl, chief of staff for the German army.

This was announced officially after German broadcasts told the German people that Grand Admiral Karl Doenitz had ordered the capitulation of all fighting forces and called off the U-boat war. The surrender papers were signed by the Supreme Allied Command by Lieut. Gen. Walter Bedell Smith, chief of staff for General Eisenhower.

The end of European war came after five years eight months and six days of strife that overruled the globe. Hitler's armies invaded Poland on Sept. 1, 1939, beginning the agony that convulsed the world for 2,819 days.
