The Democratic program proposed as a means of reviving the economy and conserving energy marked the first time in memory that a congressional party had devised its own longrange legislative blueprint to compete with one from the White House.

WASHINGTON (AP) - The Justice Department has dismantled a computerized intelligence-gathering unit and locked up the files the unit collected on thousands of individuals in response to civil disorders in the late 1960s. Atty, Gen. Edward H. Levi has promised to give Congress advance notice if he ever considers it necessary to revive the operation, a prospect he called unlikely.

National Airline Plans **Test Of Bargain Fare**

MIAMI (AP) - If you don't mind carrying your lunch or paying 25 cents for a cup of coffee, you soon may be able to fly cross-country for less than it would cost by train or bus.

National Airlines proposed a bargain-price plan Thursday that would segregate participating passengers in the rear section of the airline's jumbo jets and save them 35 per cent of the day-coach fare. The proposal, which National will implement for all of

its jumbo jets on an experimental basis on April 14, has to be approved by the Civil Aeronautics Board. But tickets will go on sale Monday - with full refunds to passengers if the board rejects the idea.





NATO Relations Strained Again

The scheduling of an election in April as the first step toward constitutional government keeps alive the hope that Portugal can avoid falling under Communist domination. The strength of the wellorganized Communist Party in that country has raised the possibility that the North Atlantic Treaty Organization could see one of its members in a highly strategic location "defect" to the Warsaw Pact.



Too Late To Delay Shortage?

What is there about oil that has given rise to almost universal agreement among Americans that this country must eventually become totally independent of foreign sources for its energy

The United States is now, and for years has been, importing most of the raw materials required by modern industry and technology Yet no one says we must become bauxite - independent or chromium - independent or this - or - that - independent.

A little-noted report by the U.S. Geological Survey last year predicted that the nation may face future crises in the supply of some of its important minerals unless massive research efforts are begun soon to develop domestic resources

But while there is a substantial undeveloped potential for some of these minerals, the report also warned that others are seriously depleted or nonexistent. A couple of examples:

Zinc. In 1972, the United States imported about 52 per cent of its zinc consumption, chiefly from Canada, Mexico, Peru and Australia. U.S. reserves are put at about 30 million short tons. Identified resources of zinc are estimated at more than 80 million tons but are mostly in sub economic low-grade or deep-lying deposits. Chromium. The United States imported 100 per

cent of its consumption of this essential mineral in 1972, mainly from the Soviet Union, the Republic of South Africa and Turkey. The U.S. has no reserves of chromium.

Identified domestic resources of chromium amount to only about 1.67 million short tons and again they would be difficult to mine and expensive to use

Survey scientists noted that while the nature and implications of the energy problem virtually exploded into public consciousness, concern about our mineral supply remained, for the most part, within the professional and technical

"Whatever the reasons for this - perhaps one is the fact that energy problems are more immediate and affect people in more direct manner - the supply problem for minerals may become ust as serious as it is for energy," they said.

Those nasty oil companies are at it again. Now the complaint is that they are pushing a program of doing away with the traditional fullservice service station, which provides tune-ups, wheel alignments and all kinds of automotive work as well as gasoline.

Taking its place are a growing number / "gas-and-go" facilities where you get gas and oil and maybe your windshield cleaned if the attendant likes you, but nothing else.

That may be only the beginning. Judging from a report in Electronics magazine, the haman gas pump jockey may be headed for obsolescence.

WORLD IN BRIEF Subway Train Crash

Kills 18 In London

LONDON (AP) - A packed subway train crashed through the protective buffers of a station in London's financial district at the height of the morning rush hour today and slammed into a tunnel wall, killing at least 13 persons and injuring 68, officials and witnesses said. It was London's worst subway wreck.

Firemen used acetylene torches to cut through one of the twisted coaches to reach trapped victims. Some rescue workers had to crawl on their hands and knees. About 50 persons were trapped in three coaches that were badly smashed, a spokesman for the London Fire Brigade said. "Two of the coaches are concentrated in an area where one coach would normally go," said Police Commander Erpest Bright.

The police took possession of the picture and a letter that accompanied it. It was the first word of Lorenz since

he was kidnaped some 24 hours before. The Second of June Movement is a band of anarchists who named their group for the day in 1967 when a student Benno Ohnesorg was shot to death during a leftist

demonstration in West Berlin. Police said the group is alleged to have executed an anarchist last year after he gave information to the police.
