Two killed in drive-by shooting Operation Cease-Fire teams respond to

three men involved in Wednesday's fatal shooting outside the Cowan Moughton

shooting outside the Cowan Moughton Terrace apartment complex. Two men were killed, and two others injured just before 5 p.m. Wednesday when a trio of men pulled up in a late-model Dodge Intrepid and fired a barrage of bullets from at least two weapons into a car parked from at least two weapons into a car parked

The dead include Kavi Williford, 17, and Cedric Williams, 22. Williford was standing outside the parked car by the front door of community's concern over gun violence

According to witnesses, Roger Williford, brother of Kavi Williford, parked his white Oldsmobile in the front yard of 22 Cowan Moughton Terrace. Williams and Cory Smith 22 were in the back and and Smith, 22, were in the back seat, and Antonio Chandler was sitting next to Roger

ting in the back seat. Police believe the shooting is the result of a feud that began last weekend and escalat-ed over time. Macording to witnesses, Roger Williford, mother of Kavi Williford, parked his white sped away after the shootings. Shell casings recovered on the scene indicate that a 9-mm pistol and an assault rifle were used in the attack. Kavi Williford tried to run but collapsed

and died from a gunshot wound to the chest. Williams never made it out of the

Superintendent of Seminole schools announces retirement By Dan Ping Editor

SANFORD — Paul Hagerty, superintendent of Seminole County Schools, announced Tuesday he will retire after more than four decades of service as an

Hagerty informed School Board members Monday he will retire July 31, and sent an e-mail to school district employees Tuesday

"The eleven years I have worked in Seminole County are the highlight of my 42 year career working in public education," Hagerty told faculty and staff

Hagerty began his tenuns in Seminole County in June 1992, and of all active superintendents in Florida, he ranks second only to Pinellas County's Howard Hinesley, in years served in the same position. Hinesley has been in Pinellas County for 13 years.

During Hagerty's time as superintendent, Seminole County Schools have earned the title as one of Florida's best school systems. Rising test scores, the con-struction of 14 new schools, and the implementation of several magnet school programs through-out the county all occurred on Hagerty's watch.

In addition, Hagerty helped broker an agreement with city and county leaders that led to voters assing a 1-cent sales tax increase. Under the agreement, part of the money generated from the tax will fund building renovations and new school construction.

Hagerty said there are many factors which allowed the school system to excel and praised his school board members; central office staff; school administrators, teachers and support staff; active-ly involved parents; and a sup-sortive community;

"All of us, working together have made Seminole County the place to be for quality schools and quality of life," Hagerty said. "I thank all of you for making my final superintendency especially

Rachman, you'll recall, is the founder of **Cyber High School**, a supposedly innovative learning center that would boost the test scores and motivation of at-risk students through the use of the latest technology.

The only thing innovative about Cyber High was how much taxpayer funding it could suck up. Cyber High earned Charter School status in Orange and Seminole counties, making it eligible for state classroom dollars. In less than three years, both county school systems yanked Cyber's charter status because of financial troubles and rock-bottom FCAT scores.


Granted, most students at Cyber High were "atrisk," meaning no one should have expected the school's test scores to equal those at Lake Mary High.

Rachman prides herself on being a sharp education entrepreneur, but like those long-gone dotcoms, she forgot the basics. At-risk students are at risk of failing because they don't have a strong foundation of the basics. Technology absolutely has a role in building that foundation. But, if Johnny can't read a book, he's not going to be able to read the Internet, now matter how many laptops you give him. Put Johnny in a school with uncertified teachers who are wondering if Cyber High will have the money for paychecks and you've got a recipe for failure.

Like a true '90s entrepreneur, however, Rachman still praching the virtues of her cyber snake oil. She asked Mayor Brian Library Library, a write Commissioner Velma Williams, to write a letter of support for the new Cyber High School, which is operating as a private school with 35 students. 




