

# WHY. Do Stores Start Christmas Before Thanksgiving?

### That's the question often asked and it deserves a sincere answer!

Scarcely a store in the nation could cope with the store traffic that would be generated if Christmas shopping were post. poned until after Thanksgiving. Even under present circumstances most stores are strained to capacity during the peak of the season, to maintain the kind of store service all shoppers have learned to expect.

When you recall the extremely crowded conditions of stores the final two or three weeks before Christmas, the problems become evident.

If no early Christmas shopping were done, this condition would be multiplied many fold. (Actually there would not

be enough room behind store counters for enough sales people to serve shoppers during this period between Thanksgiving and Christmas.)

Those in the store business know that an extremely large percentage of the Christmas gifts that are selected are items that are in plentiful supply the entire year.

If you were to ask the thousands of retail employees . . . (and as a group they represent one of the largest employee groups in the Seminole County area) . . . they would tell you that much of the stress and strain of their Christmas would be relieved if the shopping public would anticipate Christmas shopping throughout the year. (Then, you would seldom hear your friends in retailing remark, "I'm simply worn down to my knees by Christmas Eve.")

Granted that the problem is not a one-sided one, it should be recognized that stores are faced with the problems of convenient service to customers, of maintaining helpful employee relations, of providing a place where those of the public who can not, or do not, plan ahead may select the traditional gifts for their loved ones and friends.

We are sure that if all of our storekeepers could chat with you, personally and informally, that you would be convinced of their sincerity, and that in the true spirit of Christmas they would not be criticized for their effort to perform a helpful service to their shopping public.



### An Unbalance

One of the durable myths of this country in that the only good education is the education m capped off by at least four years of college and an A. B. degree. With it, nearly everything is F possible in social and economic advancement. Without it, the prospect is bleak.

The myth is supported by the educators themselves. Most of them acquired a higher education and with it a built-in bias in favor of higher education. It is understandable, but it is also a kind of blindness - blindness to the fact that millions of Americans don't and probably shouldn't go to college.

American education has not been wholly indifferent to this fact. Manual training and home economics have been fixtures in the curriculum for many years. But the extent of the prejudice as measured in dollars is shown in some figures from the current U. S. News and World keport:

- Since 1964, federal outlays in support colleges has climbed steadily - from \$1.7 biltion to \$4.6 billion in 1968 to \$5 billion in 1969 (est.). Meanwhile, federal outlays for vocational education (in the main for those who don't re to college) have risen from a mere \$41 miltion in 1969 to \$266 million in 1970 (est.).

- Graphically, this presentation is startling. It says, in effect, billions for the college-bound, peanuts for everyone else. Some of the implications, as spelled out by the Department of Health, Education and Welfare's Advisory Council on Vocational Education are even worse. Every year it observes, the nation's schools fail to educate to the level of employability 25 per cent of the young men and women who turn 18. Thereafter, it supports for them a "galaxy of remedial programs, some of which have cost as much as \$12,000 for every man and woman Crane's Worry Clinic: placed on the job." And for those who linger in unemployment, it bears the cost of \$4,000 or more a year in welfare payments.

Their target, the command ship Yankee Clipper, with Richard F. Gordon Jr. at the controls, was 65 miles overhead and about 90 miles ahead at the

By the time the lunar ferry Intrepid achieved orbit seven minutes later. Gordon was more than 300 miles ahead and the Intrepid was in a near-perfect

orbit ranging from 10 to 5 miles above the surface.

On the way up, the astronauts reported a master alarm flashed on briefly, but they could detect nothing wrong.

Conrad said he "got to watching that problem" and allowed a light overburn of 11/2 seconds, which he was able to trim out. Conard and Bean had to catch Gordon in a 31/2-hour chase to get back to earth. The lunar craft was not designed to take them home.

After executing a complex series of maneuvers, they were to hook up with the command ship at 1:05 p.m. (Continued on Page 2A. Col. 1)
